### **NOTICE OF DRAFT VARIATION OF THE KELLS DEVELOPMENT PLAN 2013-2019**

Notice is hereby given pursuant to Section 13 of the Planning and Development Acts, 2000-2015 that Meath County Council, being the Planning Authority for County Meath has prepared a draft Variation of the Kells Development Plan 2013-2019.

The draft Variation will incorporate the key tenets of the Economic Development Strategy for County Meath 2014 – 2022, as they relate to land-use planning, into the Kells Development Plan.

The draft Variation will be referred to as Variation No. 1 and will amend Volume 1 of the Kells Development Plan 2013 – 2019.
