## **5.1** Corporate Services

5.1.3 To receive presentation on Information Security and GDPR (General Data Protection Regulations).

Valerie Lyons (BH Consulting) made a presentation which included information on:

- cyber crime in Ireland, the root causes and the challenges
- EU General Data Protection Regulation and its impact on organisations
- information security
- how Meath County Council protects its data

Following the presentation, a lengthy discussion took place and Councillors raised a number of issues on the matter. Responses were provided by Valerie Lyons and by Fergus O' Rourke, Head of Information Systems.

#### 5.2 Finance

5.2.1 To note the Audit Committee Report in relation to the Annual Financial Statement and Local Government (LG) Auditors Report for the year ended 31 December 2016.

Noted by the Councillors. Councillors raised a number of issues in regard to the comments made by the Local Government auditor, and responses were provided by the Chief Executive and the Head of Finance.

#### 5.3 Transportation

5.3.1 To receive a presentation on the Roadworks Programme for 2017.

Des Foley, Director of Services, introduced the item, and Senior Engineers John McGrath and Nicholas Whyatt, made a presentation on a summary of the works undertaken under the Roadworks Programme, 2017 to include:

- the Schedule of Municipal District Works (SMDW)
- routine maintenance, housing estates/minor works and bridge repairs
- Community Involvement Schemes (CIS) and Local Improvement Schemes (LIS)





- resurfacing and PSCI Ratings
- health and safety
- National & Non-National Road Schemes
- Sustainable Transport Schemes (1 & 2) and Low Cost Safety Scheme
- proposed works 2018

Following the presentation, a lengthy discussion took place in regard to various aspects of the roadworks programme, the CIS schemes, funding and resource issues and the requirements at specific locations in the county.

Responses were provided on the matters raised.

#### 6 Reports

### 6.1 Chief Executive's Report

Councillors sought clarification on a number of matters in the Chief Executive's report. The main issues raised and discussed included:

#### Housing:

- an emergency task force should be established to address the housing needs in the county
- sites should be facilitated for people who are not on the housing list
- new housing projects in Ashbourne welcomed and update requested re lands under Rebuilding Ireland Programme
- information requested re any proposals to purchase additional land for housing
- figures welcomed re approved housing bodies
- information requested re applications for mortgages
- update requested on progress re vacant homes scheme
- emergency accommodation placement figures: is it planned to have meetings in 2018 with the probation service and social inclusion services.

**Community**: imminent commencement of works on Lobinstown playground welcomed. **Environment**: Air monitoring station should be considered for Duleek as part of the National Ambient Air Quality Monitoring Programme 2017-2022.

#### 6.2 Report from the Corporate Policy Group

The Meetings Administrator advised that the Corporate Policy Group reviewed the agenda for the full Council meeting and received information on the particulars of some items. The report from the Environmental SPC meeting held on the 15th December was noted.

## 6.3 Report from the Protocol Committee





The Meetings Administrator advised the meeting of the recommendations arising as follows:

• The Protocol Committee considered a motion submitted by Councillor Wayne Forde calling on the Council to hold a Civic / Public Reception in Buvinda house for the emergency services following a recent search of the river Boyne. It was agreed to recommend that, as the emergency services received a civic reception in 2016, the Council would not be in a position to hold another event at this time.

Councillor Forde then requested that a letter of appreciation would be sent to the emergency services, and this was agreed by the Councillors.

 reports on conferences submitted by Councillors were noted, and a list of conferences relevant to the business of the Council was approved.
