INTRODUCTION

Meath County Council has continued to foster greater efficiencies and embrace the changes and reforms as set out in the Local Government Act 2014. The renewed focus on customer service, engaging with communities and supporting the business sector has achieved positive results across the county. While 2017 has brought many challenges, it has been a very active, productive and successful year for the Council. During the year, we continued to work across all Council Directorates to realise our vision to 'lead economic, social and community development, deliver efficient and good value services and represent the people and communities of County Meath, as effectively and accountably as possible.'

CUSTOMER SERVICE

The final stage in the unification of Meath County Council took place in 2017 with the relocation of 420 staff to Buvinda House, Meath County Council's new corporate headquarters. The new headquarters enables a structured workplace that we can be proud of, and that will serve both the staff and the people of County Meath for future generations. As an organisation, we are now well positioned to deliver a more efficient service to the public, community groups and businesses in the county.

The design of the building provides an improved customer experience through the large public foyer with all of Meath County Council's public counters accessible in one location, together with state of the art meeting rooms. In addition to this, the single location for most of the functional roles of Meath County Council will result in improved efficiencies in service provision, due to the accessibility of the various departments to each other.

The new customer service model introduced in 2014 has resulted in many benefits, including faster response time and the reporting of valuable information to inform strategic management and the allocation of resources in a more efficient and timely manner.

The model was developed and implemented based on one point of contact for the Council, a well trained and knowledgeable customer service team, supported by a system to facilitate case management, time-framed responses to customers, tracking, follow up and report generation.

In 2018, it is planned to implement an updated version of the SUGAR system, mobile access, phone system integration, customer surveys and an online self-service interface.



ECONOMIC DEVELOPMENT

With the implementation of our Economic Development Strategy 2014-2022 now in its third year, we are already seeing very positive results and success stories across the county. Job announcements were welcomed during 2017 at a number of companies, including MTM Engineering, based at Grangegeeth, eComm Merchant Solutions and Pre-paid Financial Services at their Navan office, the opening of Slane Distillery with the creation of 25 full time jobs and Facebook, Clonee becoming operational in Q1 2018.

Our 'Make It Meath' campaign continues to encourage local and overseas companies to locate in Meath by showing them that the county is the best location for business across the EU. This is being done through a range of marketing initiatives including active social media accounts aimed at engaging local, national and international audiences. Meath is undoubtedly Europe's most business-friendly region and we want to capitalise on that in the next couple of years and hope to have many more exciting company announcements in 2018.

Implementation of the Boyne Valley Tourism Strategy 2016-2020 is well underway. The strategy called for incorporation of Ireland's Ancient East branding into Boyne Valley digital and print materials, which was implemented during 2017 as well as promoting the Boyne Valley as the birthplace of Ireland's Ancient East. A comprehensive Boyne Valley Food Strategy was commissioned and developed with a dedicated Food Development Officer recruited to drive the implementation of the strategy.

Housing

The single and most important challenge facing Meath County Council is the delivery of housing services and helping families and individuals to meet their housing needs.

In 2017, over 1,000 households will have their housing accommodation needs met through the various housing supports, including casual vacancies, Housing Assistance Payment and units provided by the Approved Housing Body sector.

The Housing direct construction programme now comprises 13 sites across the county, equating to 227 units, and are at various stages of development. Sixteen units were delivered during 2017, with the completion of the Bettystown Phase 1 construction project, which were tenanted in July of this year. Work will continue in 2018 to bring forward further direct construction projects so as to ensure a continued pipeline of delivery post 2020, in parallel to our ongoing acquisition programme and Part V delivery.

The Local Infrastructure Housing Activation Fund (LIHAF) approved sites in 2017 will be advanced in 2018, in line with Development and Grant Agreements that are now in place regarding the Navan and Ratoath sites respectively.



Homelessness remains an ongoing challenge, with significant numbers receiving various supports from our Homeless Service, with over 130 households successfully exiting emergency accommodation during the course of the year. It is intended to replicate the development of supported shared accommodation model units in the county that occurred during 2017 with Approved Housing Bodies, in order to ensure an increased supply of supported emergency accommodation for the various cohorts of homeless clients.

The priority for 2018 is to focus on the policy framework set out in Rebuilding Ireland: Action Plan on Homelessness and Housing, and maintain ongoing contact with the Department to advance the various delivery mechanisms in Co. Meath, that will assist, in both the short and medium term, in increasing housing supply in the county.

PLANNING

The review of the County Development Plan will continue into 2018. The recently published draft National Development Plan (NDP) and the Regional Spatial & Economic Strategies (RSES) to be prepared by the Regional Assemblies will have a major influence on the development plan, in particular on the projected future population of the county. It was planned to put a draft of the new plan on display in Q1 next year. However, this may now be delayed pending publication of the RSES, and we await clarification from the Department on that issue.

The Council made comprehensive submissions to the NDP both at issues stage and on the published draft. The overall focus of the submissions is to ensure that Meath retains its ability to grow and develop in a sustainable way and, in particular, to attract new investment to the county. The need for high quality infrastructure such as water services, rail and motorway to support these objectives was also highlighted as being of critical importance to the county, as was the future shape of any revised Dublin Metropolitan Area.

The new S.247 planning process for strategic housing developments (any development of 100 houses or more) came into effect in mid. 2017. The legislation requires these planning applications to be submitted directly to An Bord Pleanála. The Council retains a major role in pre-planning, assessing and reporting on the applications, suggesting conditions and advising An Bord Pleanála on relevant local Development Plan policies. To date, we have formally engaged in two consultations under the new legislation, with a number of other schemes at informal/advisory consultation stage.

TRANSPORTATION

The new structures implemented pursuant to the Local Government Reform Act 2014 have achieved notable efficiencies, allowing for more roads to be improved, relative to the funding received. Funding for available restoration improvement works increased by 15% from 2016 to 2017 with an



increase in the area of road pavement being surfaced increasing by 26%. 16 Community Involvement Schemes were successfully completed. It is estimated Transportation has also achieved a 44%

increase in length of road rated coring in the 9-10 category (very good condition – excellent condition) since the survey for the Pavement Survey Condition Index was carried out in 2015. There is a noticeable rise in development activity throughout the county, which places additional challenges on all transportation services for the year ahead and into the future. As a result, strategic planning for the county's Infrastructure Network and supporting Sustainable Transport Initiatives will be vital. As yet, departmental funding for 2018 has not been confirmed.

Francis Ledwidge Centenary

The centenary of the death of the Meath poet Francis Ledwidge was commemorated during 2017 through a significant programme of events led by Meath County Council Cultural Services, in partnership with the Francis Ledwidge Museum Committee and the wider community. The collaboration delivered a rich and diverse programme of activities which culminated with the unveiling of a bronze statue of the poet, sculpted by the Slane artist, Liam O Broin, in the centre of the village. The statue was commissioned by Meath County Council and it will provide a fitting legacy to the commemorative celebrations.

Among the highlights of the activities, both at home and abroad, was the very moving state commemoration of the poet which took place in his homestead at Janeville, which was attended by over two hundred and fifty invited guests. It is acknowledged that that the most significant aspect of the centenary programme has been the leadership displayed by the local authority in helping to ensure that the county as a whole re-examined key events and Ledwidge connections in their own areas, brought them to life and ensured a widespread sharing of participation.

The newly commissioned artistic and theatrical works by both Solstice Arts Centre and the Arts Office will travel to the Irish Cultural Centre in Paris in 2018. The accessible and scholarly publication *A Bittern Cry,* published to co-incide with the anniversary of the death of the poet, will provide a key reference point into the future as new generations seek to revisit the legacy of the poet in years to come.

ANNUAL BUDGET 2018

The various aspects of the budget process include the involvement of the Corporate Policy Group, the Councillors and the general public as follows:

- A series of meetings with the Corporate Policy Group to consider Budget Strategy and Local Property Tax variation
- A public consultation process from the 11th July 2017 to the 19th August 2017 in relation to the variation of the Local Property Tax rate
- A special meeting of the Council on the 11th September 2017 to consider and decide on the variation of the Local Property Tax rate



- Submission of preliminary estimate of current and capital income and expenditure to the Department of the Environment, Community and Local Government by the 23rd September 2017
- Notification to the Revenue Commissioners and Department of the Environment, Community and Local Government by the 30th September 2017 of the decision of the Council in relation to the Local Property Tax rate.

The early submission of preliminary budget figures on the Council's current and capital accounts to the Department of the Housing, Planning, Community and Local Government was aligned to the National Budget and EU reporting requirements. Similarly, the necessity to make a decision on the variation of the Local Property Tax rate by the 30th September 2017, and ahead of Meath County Council's Budget Meeting, was aligned to the administration of Local Property Tax by the Revenue Commissioners taking into account that the "liability date" in respect to Local Property Tax by the Revenue Commissioners was the 1st November 2017.

LOCAL PROPERTY TAX VARIATION

The Councillors resolved at a special meeting of the Council on 11th September 2017 not to vary the basic rate of the Local Property Tax. This followed consideration of a statutory report covering:

- The Local Authority's estimate of the income it will receive and the expenditure it will incur in the period for which the varied rate is to have effect
- The financial position of Meath County Council
- The financial effect of a varied rate
- Feedback from the public consultation held.

This decision has had a very beneficial impact on the preparation of the 2018 Budget which I will highlight below.

2018 BUDGET CONTEXT

The Budget for 2018 provides for expenditure of €110,833,406, which is an increase of €6.2m. on the 2017 budget. The general annual rate on valuation for 2018 is 69.624.

It has been determined that the prescribed period for Local Authorities to hold budget meetings is between the 1st November to 30th November 2017. The Statutory Budget Meeting for Meath County Council is being held on Monday 27th November 2017 and the Budget must be adopted within a period of 14 days commencing on that date.

The Local Property Tax allocation was a very significant issue in framing the 2018 Budget and, as Meath County Council has not varied the basic rate of Local Property Tax for 2017, the budget has been prepared on the allocation of €13,954,243, as notified.



The benefits of the Council's decision to continue to retain the Local Property Tax at its current rate have enabled the Council to continue the financial provision in following areas:

- Economic Development and implementation of the actions agreed in the Council's Economic Strategy - €300,000
- €350k has been provided for the continuation and expansion of the Small Business Support Scheme
- Planned programme of road and footpath improvements in Housing Estates €300,000
- Municipal District Allocation €480,000

The main objective in preparing the 2018 Budget has been to maintain the existing level of services and to make some increased provisions, which has only been possible by the available capital provisions made in previous years by the prudent management and efficient budgetary controls. Financial provision has continued in the following areas:

- Maintenance and Improvement of LA Housing Units has again increased by a further €370k.
- Homeless Services has also increased by a further €127k.
- Mobility Aids Housing Grants has increased by a further €100k to a total budget in 2018 of €1.6m.
- A provision of €600k. has been made for risk mitigation projects on footpaths/roads
- Additional staffing in Housing, Environment, Transportation (capital projects) and outdoor areas
- Increased provision for Library book purchase, parks/open spaces and Meath Local Sports Partnership
- Provision has also been made for increases in Representational Payments and Expenses incurred by Councillors as per Circular LG 01/2017
- Provision has also been made for essential works and upgrades to comply with health and safety audits
- The increased expenditure of €2m. in the Housing sub-programme A07 RAS and Social Leasing, demonstrates the significant work programme undertaken, over the past 18 months, by the Council to ensure an increase in the delivery of housing units under the leasing mechanism between the local authorities and the affordable housing agencies.



Since 2014, the Council's focus has been on increased service delivery across all areas.

In preparing the budget each year, the Council identifies particular areas where increased investment is required, and puts in place a targeted programme to address these needs. This has resulted in an incremental increase in budgetary expenditure as outlined in the graph below.

RATES ON VACANT PREMISES

Section 29 of the Local Government Reform Act 2014 also provides for a change to rating law in relation to the refund of rates on vacant properties. It gives the power to the Councillors to vary the level of rates refunds.

The new reserved function commenced with effect from 1 June 2014 and provides that the decision to alter the rate of refund should be taken at the Budget meeting and that the rate of refund decided shall apply to eligible persons for the year to which the Budget relates only.



The absence of a decision to vary the refund means that the existing legislative provisions regarding the rate of refund applies i.e. the existing rate of refund at 100% continues to apply.

Following detailed discussions at the Municipal District budgetary meetings, it has been decided that there will be no change in the current 100% rate rebate policy in 2018. However, an examination of the vacant rateable properties will be undertaken during the year with a view to encouraging property owners to engage with the various schemes available at national level to bring properties back into use.

BUSINESS SUPPORT SCHEME

The Business Support Scheme first introduced in 2015 has proven to be very successful. It has now evolved into a measure to encourage and assist businesses throughout Meath with a particular emphasis on small business. In order to qualify, businesses are required to fully discharge their rates by a prescribed date in the due year. The grant ranges from €50 - €235 depending on the level of the Annual Commercial Rate liability. In excess of 2,100 businesses will have availed of the scheme by the end of 2017 at a cost of approximately €360,000. Given the numbers qualifying for the scheme and the very positive feedback from customers, it is proposed to continue the scheme in 2018.

CONCLUSION

The provision for expenditure of €110,833,406 in the Budget of 2018, an increase of €6.2m is very positive.

This has been possible through a continued focus on greater efficiencies, available capital provisions through strong budgetary management, and increased income in limited service areas.

It will enable the maintenance of current levels of service, while providing additional resources in critical and emerging areas, as highlighted.

I wish to take this opportunity to thank the Management Team and staff for their co-operation in preparing this Budget and delivering on the various programmes over the past year.

I would particularly like to thank the Finance Team headed by Ms. Fiona Lawless, Head of Finance, for their tremendous work in relation to the preparation of this Budget.

In conclusion, I wish to thank the Cathaoirligh, Cllr. Gerry O' Connor and Cllr. Maria Murphy and the Councillors of Meath County Council for their contribution and support over the past financial year. Finally, I formally recommend the Budget as presented to the Council for adoption.

SERVICE DIVISION A

Housing & Building

Achievements 2017:

Housing Capital

- Funding was secured under the Local Infrastructure Housing Activation Fund (LIHAF) for sites in Navan (Farganstown) and Ratoath, to a combined value of €8.18m. Development agreements were finalised between Meath County Council and the developers concerned regarding the LIHAF sites, and grant agreements are now in place between Meath County Council and the Department of Housing, Planning & Local Government.
- The Energy Efficiency Programme (Phase 1) continued to be implemented during 2017, with works completed on over 150 housing units. Works have centred on wall and attic insulation. Phase 1 works are due to be completed on all Meath County Council stock by early 2018. In addition to the above programme, external insulation and retro-fit works were completed under the Better Energies Scheme (SEAI) on 13 units in Navan.
- Refurbishment works were carried out on over 80 casual vacancies to date in 2017.
- Works on 42 units under the Local Authority Adaptation Works Scheme will be completed by vear end.
- Bettystown direct construction project was completed during 2017, with 16 units tenanted in July. The construction of 32 units in Athboy and 19 Units in Summerhill are currently underway, and it is expected that a contractor will be appointed in relation to the Ratoath (17 units) site before year end.
- In addition to the existing approved projects, a further 7 direct construction projects received Stage 1 Approval from the Department of Housing, Planning & Local Government during 2017, equating to 103 units, of which three sites were selected for rapid build delivery.
- Under the 2017 Acquisition Programme, 44 units are at sale agreed/closed stage to date, located throughout the County, with a further 17 units acquired by the Housing Agency.
- Budget approval was received in the sum of €3,458,329 in relation to the submission regarding the refurbishment of Alverno Court. Discussions are ongoing with Department officials regarding the shortfall between funding sought and that approved.

Housing Allocations

- In excess of 1,000 households will have their accommodation needs met by Meath County Council in 2017, through various housing supports, including Housing Assistance Payment, the Rental Accommodation Scheme, Approved Housing Bodies, as well as through casual vacancies.
- Collaborative work with Approved Housing Bodies has yielded approval for 100 units under the Social Housing Current Expenditure Code in 2017, with a further 24 units becoming operational in 2017 by the voluntary housing sector.
- The 2017 Summary of Social Housing Assessment recorded a net housing need of 2,467 as at 28th June 2017 for Co. Meath (Gross housing need inclusive of HAP recipients 3,447).

Housing Grants

■ Grant funding of €1,887,816 was allocated in 2017. Approval has been granted to 283 housing grant applications to date under the following schemes: Housing Adaptation Grant for People with a Disability and Housing Aid for Older People and Mobility Aid Grants.

Homeless Service

One hundred and sixty nine households have required an emergency accommodation placement, to date, in 2017 with over 124 households exiting emergency accommodation for the same period. A number of Service Level Agreements were entered into between Meath County Council and Approved Housing Bodies in respect to the establishment of supported emergency accommodation models in the County.

Traveller Accommodation

- The accommodation targets for 2017 under the Traveller Accommodation Programme 2014
 2018 have been achieved.
- Work continues to bring forward the proposed refurbishment of St Francis' Park halting site, which has Departmental approval in the sum of €2,856,336 granted.

Tenant Liaison

 In excess of 135 tenants completed pre tenancy training during 2017, obtaining a variety of information concerning their tenancy with Meath County Council.

Initiatives and Challenges, 2018:

Provision has been made in the 2018 Housing Budget for the following:

- Funding of grants under the Housing Grant Scheme to a value of €1.6m.
- Response and Preventative Maintenance programmes.
- Estate Management Initiatives.

The need for social housing continues to increase, with over 750 new applications for Social Housing received during 2017. A key challenge for 2018 will be to address the growing demand for housing support in the context of Rebuilding Ireland: Action Plan for Housing and Homelessness. Engagement with the Approved Housing Bodies will be vital and necessary to ensure a co-ordinated approach at local level in meeting the demand for social housing in the county.

Further demand on our Homeless Service will require increased funding at both local and national level in order to sustain the service provided, primarily through the provision of emergency accommodation. Strategic work with other relevant stakeholders will continue in 2018, with a view to tackling cyclical homelessness and build on the models of supported emergency accommodation units established during 2017. The draft Homeless Action Plan of the Mid East Region (2018-2020), which is currently be finalised by each of the three Local Authorities, will provide the strategic framework for the development of our homeless services for the period concerned.

Meath County Council's 'Strategy for Housing People with a Disability' will be further advanced in 2018, in particular with regard to the analysis completed in 2017 regarding applicants on our social

housing waiting list that fall within the four categories of disability. Progression of all our current major capital projects will be a key priority for the Housing Department in 2018, including the development of further pipeline projects and advancing opportunities contained within Rebuilding Ireland: Action Plan for Housing and Homelessness, for implementation in Co. Meath.

SERVICE DIVISION B

Transportation

Introduction

Meath County Council manages and maintains over 3,500 km. of road network. This is achieved with the co-operation and assistance of the NTA, TII, and DTTAS through 4 main elements, namely:

- Road upkeep, including routine and winter maintenance, surface dressing and public lighting
- Road improvements, which includes discretionary Improvement, restoration improvement, specific improvement schemes and other improvement schemes
- Road traffic, which includes traffic management and safety
- Sustainable transport Initiatives

Achievements 2017

In 2017, Road Improvement achievements included the delivery of the circa €26m road works programme and the completion of 16 Community Involvement Schemes. The scheme showcases how partnership between the Council and communities can deliver meaningful improvements on roads, which otherwise would not receive maintenance/improvement funding. Applications were also processed for participation in the CIS Scheme for 2018 and 2019 and the various successful communities were contacted.

The following National Primary and Secondary Road Schemes were advanced in 2017:

- N2 Slane Bypass Constraints and Route Selection Studies are ongoing
- N51 Dunmoe Phase 2 Part 8 Process complete, CPO prepared
- N52 Grange to Clontail Road scheme consultants appointed
- N2 Balrath to Cushinstown, N2 Coolaliss and Clontail Pavement schemes
- N51 Pavement overlay scheme complete (NIIR Round O to Abbey Rd).

The following lengths of the non-national road network were maintained in 2017: Road Restoration:

Regional Roads - 10.75 kms. and Local Roads - 56.7 kms. (incl 7.7 kms for CIS).

Surface Dressing:

- Regional 29.6 kms. (including road restoration lengths)
- Local 146.5 kms. (including road restoration lengths) (incl 7.7 kms for CIS).

Additional Non-National Schemes which were progressed in 2017:

- R150 Laytown to Bettystown Spine Road Consultants appointed to prepare a CPO
- LDR4 Abbeyland Navan Consultants appointed to prepare application for statutory approval
- LDR6 Navan R153 to Ferganstown & Ballymacon LIHAF Agreement with developer signed Consulting Engineers appointed
- Ratoath Outer Relief Road LIHAF Agreement with developer signed. Tender negotiation underway with consultant.

Bridge Remedial Works:

Remedial Works were carried out on the following bridges: Beggstown Bridge, Beggstown; Headfort Bridge, Kells, Causetown Bridge, Stackallen; Bellinter Bridge, Navan; Doghtog Bridge, Doghtog; Johnstown Bridge, Rathcore; Clondoogan Bridge, Summerhill.

Low Cost Safety Improvement Schemes

Low Cost Safety Improvement Schemes have been carried out at the R108 Clinstown Cross, Fennor Cross R195/L6814-16 Junction Oldcastle, L5619 Legganhall Cross, R161 Connells Cross, Robinstown and the R147/R149 Junction, Clonee.

Sustainable Transport Schemes

Work on the following schemes progressed in 2017:

- Commenced process to prepare a Part 8 for the Boyneside Trail
- Continuation with the design of The Boyne Greenway Phase 2 (ongoing)
- Part 8 completed for Navan 2030 to improve public transport infrastructure and associated traffic management for the town centre in Navan
- Continuation of a Cycle Network Design for Navan and progressed design of Ashbourne Cycle Network
- Continuation of a Cycle Network Design for Ratoath including construction of cycling and pedestrian facilities on the Meadowbankhill Road
- Part 8 completed for the Cantilever Bridge on the Kentstown Road
- Completion of Pedestrian Toucan Crossing in Dunboyne
- Completion of M3 Transportation Study at Dunboyne and Environs
- Laytown Park & Ride.

Other schemes designed/constructed by the Sustainable Transport Unit for Transportation/ MDs:

- Road Safety Study on the R157 Dunboyne Maynooth Road
- Circular Road Roundabout Improvement Works
- Construction of 19kms of the Dublin Galway Greenway along the Royal Canal
- Gormanstown Stamullen Footpath Link constructed.

Speed Limit Review

The review of speed limits within the county is substantially complete. The bye-law for housing estates was adopted and will come into effect in November 2017. Draft County Special Speed Limit Bye-Law for countywide speed limits was on public display up until 30th August. This reflected the review of the countywide speed limits that had been undertaken on the road network in 2016/2017. The bye-law is ready to adopt pending final confirmation of proposals for the National Roads from TII.

Work continued on the delivery of other services:

- Ordinary Maintenance, Winter Maintenance Service and Maintenance of Plant & Machinery
- Public Lighting Services and Energy Efficiency Schemes
- Development Control / Transport Planning Advice
- Road Safety Improvement Schemes, Promotion and Education
- Road Opening Licences, Abnormal Load Applications, Roads and Services in Charge queries.

Initiatives and Challenges in 2018:

The continuing challenge for the Council in 2018 will be to deploy the resources available to it in the most effective way to maintain the network and provide the best level of service possible to road users. The roadworks programme 2018 will be informed by the data collected from the extensive condition surveys carried out on the non-national road network. There is a noticeable rise in development activity and this will place additional challenges on the transportation services listed above.

SERVICE DIVISION C

Water Services

In 2018, Meath County Council will enter the 5th year of the Service Level Agreement with Irish Water, which ensures the continued provision of day to day water and wastewater operation and maintenance and capital delivery services.

Under this Service Level Agreement, Meath County Council continues to operate and maintain all water services facilities and networks within County Meath and to project manage capital programmes on behalf of Irish Water. In this capacity, the Council continues to play a key role in the provision of Water and Wastewater services.

The Council's 2018 Budget accounts for Water Services staff payroll, directly incurred costs and a representative proportion of the Central Management Charge, which will be recouped on a monthly basis from Irish Water during 2018. Irish Water has budgeted directly for the provision of the goods and services associated with the provision of Water Services.

Irish Water does not have responsibility for storm water, storm flooding, group schemes, well grants or lead piping replacement grants and, hence, the Council will continue to have direct responsibility for these matters.

During 2018, a number of Water Services capital projects will commence on site and this, coupled with the Council's ongoing commitment to water conservation and continued close engagement with Irish Water to secure further capital investment in critical Water Services infrastructure, will serve to facilitate the planned development and growth of Meath into 2018 and beyond.

SERVICE DIVISION D

Development Management

Achievements, 2017:

Forward Planning

Variation 1 of the Kells Development Plan and Variation 2 of the Navan Development Plan were adopted by the full Council at a Special Meeting in July, 2017. Both Variations align the Development Plans with the key tenets of the Economic Development Strategy for County Meath, 2014-2022.

Variation 4 of the Meath County Development Plan 2013-2019 was placed on public display in October, 2017 for a period of four weeks. This Variation provides for the inclusion of objectives for the regeneration and renewal of land, and the active land management of vacant sites within the Settlement/Core Strategy of the County Development Plan.

The review of the Meath County Development Plan 2019-2025 continued in 2017 with the Councillors giving direction on the preparation of the Draft Plan, following receipt of the Chief Executive's Report on the submissions made on the Strategic Issues Paper. The Draft Plan will be placed on public display in Q1 2018.

Development Contributions

Receipts from development contributions continue to rise, with a projected outturn in the region of €6.5m. for 2017. The increase in receipts can be attributed to both the increase in development activity and the active engagement between debtors and the Financial Compliance Team.

Compliance Activities

Complaints regarding planning compliance have risen, with 233 warning letters issued together with 150 enforcement notices and 16 cases referred for legal action on a range of non-compliance and unauthorised development issues. These figures include action taken for non compliance with the financial provisions of extant planning permissions. The Council continues to carry out its function in regard to the taking-in-charge of estates. The Planning Department is currently liaising with the Council's Water Services Department and Irish Water in relation to progressing the taking-in-charge of 79 residential developments.

Development Management

The number of applications received to date remains steady showing a definite increase on previous years. Pre-planning clinics are now fully subscribed and the Planning Department continues to note an improvement in the scope and complexity of development proposals being considered.

Meath County Council prepared a report under the Strategic Infrastructure Act for An Bord Pleanála in relation to an application from Irish Cement.

The Planning Department attended the Oral Hearing held with respect to an application by Tara Mines.

The Planning Department also assisted in its first Section 247 (pre-planning) meeting relating to a Strategic Housing Development, which was introduced in July 2017 under the Planning and Development (Housing) and Residential Tenancies Act 2016.

Quarry Regulation

The Planning Authority continues to monitor and assess quarrying operations in Meath.

Building Control

The Council's Building Control function is performed by the Building Control Officer who also leads the Planning Enforcement Team. The Building Control function plays a critical role in informing the Council's Financial Compliance Team.

Initiatives and challenges for 2018

The Planning Department will continue with the review of the Meath County Development Plan 2019-2025 with public consultation on the Draft Plan commencing on 19 February, 2018 with a proposed adoption date in early December, 2018.

On the adoption of Variation 4 of the Meath County Development Plan 2013-2019, the Planning Department will advise landowners of its intention to place them on the Vacant Sites Register. The Planning Department will continue to ensure that a quality service is provided across all areas of the Planning function and continue to work closely and engage with all stakeholders.

ECONOMIC DEVELOPMENT AND ENTERPRISE

The implementation of our Economic Development Strategy 2014-2022 is now in its third year and already there are very positive results and success stories across the county. Meath is now undoubtedly perceived both on the national and international stage as a prime business location.

Achievements 2017:

Jobs:

Jobs and investment announcements during the year included:

 Facebook confirmed that they will immediately commence the 2nd phase of their data centre project at Clonee and will construct an additional 28,000 square meters bringing the total development to 86,000 square meters. The 1st phase of this development supported over 1,500 construction jobs

- Shire Pharmaceuticals has obtained planning permission for a redesign of their building and construction started on this project. It is estimated that 400 jobs will be supported during the construction phase
- MTM Engineering, based at Grangegeeth, has added in excess of 100 jobs during 2017
- eComm Merchant Solutions and Pre-paid Financial Services added over 60 new positions at their Navan office during this year
- Gyproc (North Meath near Kingscourt) recently announced a move to a 4 shift system and will add 14 jobs bringing their workforce to over 150
- Slane Distillery has now opened and 25 full time jobs have been created.

These welcome announcements have been complimented by job increases in smaller companies. For example, Gripfix (Dunshaughlin) added 8 new employees this year while animal health company Fenu Health (Summerhill) now employ 8 staff and are exporting to 12 countries.

Business Supports

- Meath Enterprise Week leads the way locally and nationally with a range of initiatives to encourage, train, mentor and support new and existing businesses in Meath
- Commissioned and developed a comprehensive Boyne Valley Food Strategy in conjunction with Louth County Council
- Dedicated Food Development Officer recruited to drive the implementation of the strategy
- Meath LEO is the 'first-stop-shop' for all Government supports for those in Meath who
 want to start or expand their business and create jobs in the county and provided
 funding of c. €500,000 to support businesses in 2017
- LEO Meath presented awards to Ireland's Best Young Entrepreneurs and Student Enterprises and a range of training programmes, mentoring and business information seminars for SMEs was provided during 2017
- The LEO has agreed formal co-operation agreements with LEADER, Solas, Udaras na Gaeltachta, INTREO and SkillNets.

Marketing

- The 'Make IT Meath' campaign has begun with a new website (www.makeitmeath.ie). The website is designed to attract Irish and International companies to locate in Meath. Make it Meath social media accounts are active and engaging local, national and international audiences
- WhiteLight Consulting were appointed to develop a suite of new marketing initiatives as part of a three year marketing and communication plan for the Economic Development Strategy.

TOURISM

Achievements, 2017:

Implementation of the Boyne Valley Tourism Strategy 2016-2020 is well underway. The strategy called for incorporation of Ireland's Ancient East branding into Boyne Valley digital and print materials, which was implemented during 2017 as well as promoting the Boyne Valley as the birthplace of Ireland's Ancient East. A digital marketing campaign was carried out by Boyne Valley Tourism during 2017 targeting key markets UK, US, France and Germany to attract international visitors using google advertising. New sections were created on discoverboynevalley.ie including a new blog and new Ireland's Ancient East stories section; additionally, ezines were sent to potential visitors throughout the year.

A highlight of 2017 was the press visit organised by Boyne Valley Tourism whereby the Rough Guide, Lonely Planet, The Guardian, Scotsman and Scotland on Sunday in addition to Cara Magazine were invited to visit the Boyne Valley over three days. They published articles and videos about the Boyne Valley which included live periscope from Lonely Planet and articles written in Cara Magazine, the Rough Guide and Scotland on Sunday.

Networking opportunities were created for the tourism trade with two familiarisation trips organised to attractions across the Boyne Valley. Training on experience development was delivered to the tourism trade in the Boyne Valley, which produced a number of new tourism packages and experiences incorporating food and activities. 16 promotional shows were attended by Boyne Valley Tourism, supported by the tourism trade during 2017. The ninth Spirits of Meath Halloween Festival featured on national radio, TV and newspapers. Boyne Valley Tourism worked with the Boyne Valley Food Series to support its development. Funding was secured from Fáilte Ireland for a new permanent exhibition at the Kells Heritage Centre to create an orientation point for visitors to the area.

Initiatives and Challenges, 2018:

The Kells Heritage Centre project will be launched in 2018. Collaboration with the hotel and attractions sectors will continue to develop new tourism experiences in order to attract business tourism. During 2018, the development of the Spirits of Meath Halloween festival will be a key part of the work programme in order to gain greater recognition for the story of the origins of Halloween in Meath. Efforts will continue to firmly place the Boyne Valley foremost in the public's mind as the Birthplace of Ireland's Ancient East by working closely with Fáilte Ireland.

SERVICE DIVISION E

Environment, Fire & Emergency Services

Introduction

The protection of the environment and the enhancement of the county's natural and built environment are of significant importance for the residents of, and visitors to, County Meath. Clean air and water, a litter free countryside, pristine beaches and sustainable waste management systems are fundamental to a sustainable and high quality environment and improving the quality of life of our citizens.

Achievements 2017:

Environmental Enforcement Priorities

The Council continued to actively enforce the provisions of all environmental legislation as required by statute. Compliance includes inspections and/or audits to determine compliance with all environmental legislation which includes air, noise, nitrates, water and waste legislation. The main priorities for 2017 were:

- Illegal dumping including construction and demolition waste
- Household waste management compliance including Brown Bin
- End of life vehicles including abandoned cars
- Tyres
- Farm inspections and cross reporting to DAFM
- Domestic waste water inspections in accordance with the National Inspection Plan
- Licensing of Section 4 Discharges
- Solid Fuel Regulations –smokey coal enforcement.

Environmental Education and Awareness Activities

In 2017, the Council engaged in a wide range of environmental education and awareness activities and supports including:

- Green Schools Initiatives including workshops on litter and waste, energy, water, biodiversity, global citizenship
- Secondary Schools The Really Rubbish Film Company, ECO UNESCO Young Environmentalist, Clean-Up Navan Campaign
- Community Groups Anti Litter League, Clean-Up Navan, Climate Change Community Action event, 2 Minute Beach Clean Up, Up-cycle Furniture Workshops for Reuse Month
- 'Stop Food Waste Campaign' including cinema, outdoor advertising on buses and at shopping centres, demonstrations, promotional materials, website
- Anti Dumping Initiative Projects at Bridge of Boyne Navan, Broadmeadow River Ashbourne, Girley Bog – Kells and Bohermeen Bog
- Dog fouling awareness campaign Radio campaign in conjunction with Louth County Council

Household hazardous waste collection and collection day for old toys.

Abandoned Car Policy

An abandoned vehicles policy was introduced in 2017 following a rapid increase in the number of vehicles being reported as abandoned.

The new policy is proving quite successful in having vehicles removed. However, failure by the registered owner to respond to a number of notifications has resulted in some vehicles being removed, destroyed and certificates of destruction submitted. The Council seeks to recoup any costs arising from the last registered owner.

Climate Change

Consultants have been engaged to prepare a Climate Action Strategy and to ensure this subject matter is strongly integrated into the review process of the Meath County Development Plan 2019-2025. Information gathered on baseline emissions inventories and climate risk & vulnerability assessments will feed into a 'Sustainable Energies and Climate Action Plan', which is a requirement for signatories 'to the Covenant of Mayors' the European movement whereby local and regional authorities voluntarily commit to contribute to reaching EU targets for reducing greenhouse gases and resilience to the impacts of climate change'

River Basin Management Planning

The Water Framework Directive provides the legal framework to protect and restore clean water and to ensure its long term sustainable use and this is achieved through the River Basin Management Plans. A draft river basin management plan covering the period 2018-2021 was published in March 2017 and subject to public consultation until the end of August 2017.

The draft plan provides an assessment of the pressures on the water environment in Ireland, and the proposed programme of measures to be implemented in the period to 2021. As part of extensive consultations in respect of the draft plan, a series of 6 public meetings were held in Kells, Navan, Trim, Dunshaughlin, Ashbourne and Bettystown when community groups and other interested parties were afforded the opportunity to outline any particular concerns they had in respect of local water bodies. Following a series of Catchment Assessment workshops, eight water bodies in County Meath were identified for priority action during the lifetime of the plan.

Provision of Slipways –River Boyne and Blackwater

The Council, in association with other statutory agencies with responsibilities for the River Boyne and Blackwater, appointed specialist environmental consultants to carry out an appraisal of the locations of the temporary boat slipways currently in place along the River Boyne and to propose the most appropriate locations for additional boat slipways on the Boyne and the Blackwater, both of which are designated Special Areas of Conservation (SAC).

In light of such designations a screening for appropriate assessment was carried out and arising from which a full Natura Impact Statement (NIS) has been prepared and submitted to An Bord Pleanála for approval.

Beach Management Plan

A draft Beach Management Plan for a section of the coast of Co. Meath from mouth of the River Nanny to the sea wall at Mornington was placed on public display until July 2017 and elicited a significant number of submissions and covering a wide and varied number of issues.

The coastline, being home to a variety of natural habitats, is subject to SAC, NHA, and SPA designations and, in accordance with the EU Habitats Directive, a screening for appropriate assessment was carried out and arising from which a Natura Impact Statement is currently being prepared and will be subject to further public consultation.

A Beach Management Committee comprising representatives from various community and voluntary groups as well as elected Councillors from Laytown/ Bettystown Municipal District was set up in March 2017. The committee will provide a forum for communication and discussion in respect of enhancements relating to the beach.

Tyres - Waste Management (Tyres and Waste Tyres) Regulations 2017

In September 2017, new Regulations were signed into law and providing for all tyre producer and retailers being members of REPAK an approved body for Tyres and for all producers to register with Producer Register Limited (PRL) an approved Registration body.

Changes to Household Waste Collection Charging Arrangement

In June 2017, The Minister for Communications, Climate Action and Environment, confirmed that a more flexible framework for waste collection charges had been approved by Government, including a provision whereby 'all-in flat rate' charging for household waste will be phased out as customers renew or enter new service contracts, and replaced with an incentivised pricing structure for household waste collection.

The new provisions will allow for a range of charging options, which most consumers are already familiar with, and which will encourage householders to reduce and separate their waste while choosing the service-price offering that best suits their circumstances and allows them manage their costs.

Under the new arrangement, waste collectors will be given the flexibility to continue to offer, or to introduce, a range of incentivised pricing options to their customers. These options include elements or combinations of standing charges, and per-lift, per-kilogramme, weight-bands, and weight allowance charges.

All waste collectors will be required to start rolling-out food/organic "brown" bins to all localities nationwide with a population greater than 500 people.

FIRE SERVICE

Meath Fire & Rescue Service covers a broad range of functions ranging from operational response to fire prevention, including:

- Fire fighting and rescue services
- Community fire safety
- Technical fire prevention
- Major emergency planning and pre incident planning

Meath Fire & Rescue Service is ready to respond to a range of incidents and emergencies as requested by the Eastern Regional Control Centre through the 999/112 system. To ensure a continued efficient and effective response, staff are continuously trained and supported to maintain competency in the wide range of skills required. Specialised equipment and fleet are essential to service provision and ongoing procurement and maintenance form an important element of the annual budget provision.

Achievements 2017

Health and Safety

Meath Fire and Rescue Service has worked to provide and maintain an effective Health and Safety Management System and currently holds OHSAS 18001 accreditation, an international standard which provides a framework to identify, control and decrease the risks associated with health and safety within the workplace. The fire service will continue to monitor and implement improvements to meet statutory health and safety obligations and staff training will continue in accordance with the agreed Training Plan for 2018 to ensure high standards of service delivery.

Equipment

Meath Fire & Rescue service utilises a broad range of specialist equipment in the delivery of its operational rescue service and there was significant investment during 2017 in equipment including cutting and extrication gear for use at road based incidents.

Initiatives and Challenges 2018

Fleet & Station Maintenance

Meath Fire & Rescue Service maintains fire appliances in seven stations throughout County Meath, and a variety of different types of appliances are in operation. Investment in fleet is a priority to ensure that we continue to have a modern, safe and efficient fleet to respond to incidents and emergencies across the county. Improvement works are scheduled during 2018 to continue to enhance the facilities in the fire station building stock.

Fire Prevention and Community Fire Safety

Fire Prevention Officers deal with a wide range of Fire Safety Certificate applications for new and existing developments and carry out a range of inspections to deal with the fire safety of the existing building stock and proposed developments, through strong links to the Planning and Building Control Section. Educating the community in fire safety is a key role for the fire service and targeted campaigns will be continued during 2018 at various times throughout the year, especially during National Fire Safety Week and Halloween. Meath Fire and Rescue Service will endeavour to increase the level of activity in the area of community fire safety paying particular attention to fire safety in the home.

CIVIL DEFENCE

There are currently two hundred active volunteer members in Civil Defence throughout the county. In addition to regular training activities in the nine training centres, 2017 was a busy year, with over one hundred and eighty duty days at events throughout the county, providing assistance to the emergency services and local communities.

Part 8 planning has been secured for the proposed new training and operational facility for the organisation on the Mullaghboy Industrial Estate. A detailed building design is in progress and site work has commenced to make the site ready for when a building contractor is appointed which is expected to go to tender early in the new year.

SERVICE DIVISION F

Recreation & Amenity

Introduction

"Putting People First" significantly strengthens and expands the role of local authorities in local and community development with particular focus on promoting the well-being and quality of life of citizens and communities. It sets out reforms to improve the delivery of services for the citizen, deliver greater efficiency and effectiveness and give local government a more central role in local and community development.

Local Community Development Committee (LCDC)

The function of the LCDC is to implement the 2016-2021 Local Economic Community Plan, to co-ordinate, manage and oversee the implementation of local and community programmes on behalf of the government department's e.g SICAP and LEADER programmes.

Local Economic & Community Plan (LECP) 2016-2021

The LECP for Meath was launched in January 2017. The LCDC prepared the 6 year Statutory Local Economic Community Plan in conjunction with the Council. This Plan serves as the primary strategy guiding development in Meath and the targeting of resources under the direct management of the LCDC. Any funding applications for proposed projects must also be consistent with the objectives of the plan. A review of the plan will take place in 2018.

Social Inclusion Community Activation Programme (SICAP) 2015-2017

This is the 3rd year of this 3 year programme which is funded by the Department of Rural and Community Development. SICAP's aim is to reduce poverty, promote social inclusion and equality through local engagement and collaboration. The tender to deliver the 3-year programme was awarded to Meath Partnership) with a budget of €371,072 allocated for 2017. A new 5-year programme will commence in January 2018. The indicative budget for 2018 is €393,336, this to be confirmed by the department.

LEADER Programme 2014-2020

The LCDC (LAG) and Local Authority is responsible for monitoring/overseeing the delivery of the LEADER programme 2014-2020. Meath's allocation under the programme is €6,903,123.57. The LCDC agreed to a joint approach to LEADER with the LCDC as the LAG and Meath Partnership as the implementing partner (IP). During 2017, the LAG approved funding towards 5 festival events namely, Guth Gafa film festival, Hinterland festival, Royal Meath Show, Francis Ledwidge 2017 Centenary festival, Sandyachting European championships 2017. Funding has also been approved for 2 community facility developments in Duleek and Donore.

Public Participation Network (PPN)

The PPN has a current membership of 515 groups. A county plenary meeting took place in May 2017 and was very well attended by all groups.

The PPN website, <u>www.meathppn.ie</u> and Facebook page is being updated regularly with a dedicated PPN support worker working with the secretariat of the PPN to progress their plans.

Meath Age Friendly Initiative

The 2nd Age Friendly strategy 2017-2020 was launched in 2017. This strategy gives solution focussed commitments to improving key areas of infrastructure, transportation, services and information across the county. Meath County Council is currently hosting the National Age Friendly Ireland programme on an interim basis until such a time that a national shared service is established.

Comhairle na nÓg

Meath Comhairle na nÓg, the Youth Council for County Meath, held their AGM in October with over 110 young people in attendance. Their topic for 2017/2018 is Health and Fitness with 5 workshops incorporating this topic held at the AGM. The group undertook other initiatives throughout the year under this topic.

Joint Policing Committee (JPC)

The committee met quarterly and also held their public meeting in Trim Castle Hotel in October 2017 with good attendance on the night.

The 3 sub- groups - Community Safety and Crime Prevention, Public Order and Anti-social Behaviour, Road Safety and Improved Driver Behaviour also meet on a regular basis.

Ashbourne Linear Park

A Part 8 for the Ashbourne linear park was agreed by the Ashbourne Municipal District Councillors at their March meeting. Work is continuing on the detailed design for the scheme with an Archaeological Assessment Report forwarded to the National Monument Service (NMS). The procurement process for the project will commence following a response from NMS.

Lobinstown Playground

Funding of €15k was allocated by the Department of Children & Youth Affairs (DCYA) towards the development of a playground in Lobinstown. The closing date for receipt of tenders was 25th October 2017 with a review currently taking place. Under the Town & Village renewal scheme €32,000 has been approved towards works in association with the playground.

Community Initiatives - Pride of Place

Pride of Place continued with competitions at Municipal District level and category winners from each MD going forward to compete at county level. Two new categories – Best New Group and Volunteer of the Year were introduced this year. A total of 203 groups and businesses participated with 70 schools taking part. Four groups are entered in the National awards on December 2nd namely, Slane Tidy Towns, Trim Tidy Towns, Kells Local Heroes and the Blackfriary Community Heritage and Archaeology group.

Grant Schemes

The following grant schemes were processed in 2017

- Community Grant Scheme 2017 A total of 375 applications approved under the various categories
- Carranstown Grant Scheme 28 applications were approved
- Knockharley Grant Scheme 11 applications were approved

Unity Centre, Windtown, Navan

The Unity Centre provides a space for community activities as well as training and leisure activities. A weekly Parent and Toddler Group and Youth Club are run by members of the Windtown community, and the building is regularly used by LMETB, HSE, Rehab care, Prosper Meath, Navan Schools Completion Service, Springboard Family Support and Orchard Children's Services.

Community Facilities Scheme

The scheme is being administered by the LCDC under the remit of the Local Authorities with an allocation of €64,500 available to Meath. 63 groups were approved for the scheme with works to be completed by year end.

Healthy Ireland Fund Scheme

This fund will be administered by the LCDC under the remit of the Local Authorities. An allocation of €100,000 is available to the LCDC to support the implementation of Healthy Ireland projects and programmes. 3 proposals were submitted with decisions due in November.

Outdoor Recreation Infrastructure Scheme

11 applications were submitted by the Council. The Department has approved funding for six projects submitted under Measure 1; Balrath Wood, Kentstown; Clarins Bridge, Kells; Ramparts, Navan; Girley Bog Loop Walk; Harvest Walk, Kells and River Walk Ratoath. These works have commenced and must be completed by year end.

Town & Village Renewal Scheme

This scheme supports the revitalisation of towns and villages. 15 projects were submitted and approved by the department to the amount of €905,000. Contact is currently being made with the groups to discuss progressing the projects and arranging for works to be carried out.

Clár Initiative

This is a targeted investment programme for an identified Clár area. Grants totalling €104k were received from the Department for 4 projects namely footpath construction in Kilskyre, upgrading of footpath in Killallen and installation of warning speed signage at Ballinlough and Ughtyneill schools. These works are ongoing.

Eirgrid Community Fund

This was a once off funding of €30k for the south west corner of Trim MD under the Eirgrid project. Community projects were identified in the area and were awarded funding towards their projects. These included Castlejordan Community Playschool, St Ciaran's National School, Ballinabrackey GAA underage and Jordan Junior Youth Club.

Broadband

A full time Broadband Officer was appointed in June 2017 with the objective of facilitating the implementation of the National Broadband Plan and related initiatives in County Meath. This will include the development of a digital strategy for Co. Meath and work is ongoing in this regard.

LIBRARY SERVICES

Achievements 2017:

- Delivered the Francis Ledwidge Centenary programme in partnership with national, local and community stakeholders
- Delivered the 2017 activation plan for the 2016 legacy initiative Creative Ireland
- Completed the migration of acquisition services to the new national library procurement system
- Reconfigured work practices to adapt to the new national library distribution service *Newspread*. The national launch took place in Navan in May
- Introduced RFID self-service at Trim branch as part of the preparation for the *My Open Library* initiative and secured funding of c.€200,000 for the extension and further implementation of RFID across the branch network
- Reconfigured service at Trim and completed the move to new staff accommodation
- Extended the new national Business Information service Work Matters to Kells library
- Secured funding of €8,100 for the implementation of the Healthy Ireland library initiative
- Branch upgrades at Dunshaughlin and Oldcastle as part of the countywide Energy works
- Broadband upgrades at Duleek, Nobber, Oldcastle and Slane
- Developed a junior library at Mosney accommodation centre
- Paul Gamble headlined the annual Children's Book Festival in October. In excess of one hundred events were
 organised with almost 6,000 children from over fifty different schools attending events making this Meath's
 leading cultural event for children
- Over 4,000 children attended the Summer Programme of events organised by the library service during July and August
- 2,000 children participated in the annual Summer Reading Challenge.

Initiatives and Challenges 2018:

- Develop service in accordance with priorities set out in national library strategy *Libraries Ireland 2018 2022* which will be published in March 2018
- Develop Open Libraries in accordance with emerging national guidelines
- Re-configure and extend Navan branch library
- Progress the design of the Trim Library and Cultural Centre
- Develop a 5 year strategy for the county under the Creative Ireland initiative in partnership with national, local and community stakeholders
- Develop and deliver appropriate programme of events to commemorate events as part of the Decade of Centenaries in partnership with national, local and community stakeholders
- Deliver appropriate programme of activities for *Bliain na Gaeilge* in partnership with national, local and community stakeholders

- Progress Bettystown branch development as part of an overall plan to deliver a library and community facility for East Meath in Bettystown town centre
- Provide minor upgrades to Athboy, Dunshaughlin and Kells libraries to comply with accessibility guidelines
- Provide major upgrade to Nobber library to comply with energy efficiency guidelines
- Initiate Right to Read initiative as per national template.

ARTS OFFICE

The Meath County Council Arts policy and mission is 'to increase access to the arts for all sectors of the community, encourage and increase awareness and interest in the arts, increase participation in the arts, whilst recognising the importance of the arts in areas of personal development, community development, employment and tourism'. The Arts Office continues to implement key aims and objectives as per the Council's strategic Arts Policy.

Achievements 2017:

- Implementation of the FÉACH professional artist mentoring and training programme in partnership with Visual Artists Ireland, the Irish Writers' Centre and the Arts Council
- Exhibitions held at Toradh Gallery, Ashbourne Cultural Centre
- Artists talk, workshops and schools events held at Toradh Gallery
- Managed and funded Bealtaine Festival at venues across the county
- Programmed, managed and delivered Pucas and Potions Children's Halloween Arts Festival events
- Administered, assessed and processed 94 application under six Arts grant schemes
- Continued with the delivery of 'Training Notes' professional training programme for musicians wishing to work in a health care system in partnership with Kids Classics, Navan Hospital and Beaufort House
- Born/Beirthe: children's play exploring the events of 1916 by Deirdre Kinahan (schools workshops programme) shortlisted for Chambers Ireland Excellence in Local Government Awards, 2017
- Worked in collaboration with Cultural Services Team and Francis Ledwidge Committee to commemorate the centenary of the death of Meath poet Francis Ledwidge.
- Worked in collaboration with Cultural Services Team to develop and implement Creative Ireland Activation Plan for 2017.

- Manage and implement Private Developer Public Art Project programme
- Explore and plan for arts/cultural infrastructural projects
- Continue Urban Art Trails Development, design and print Sculpture Trail maps

- Youth Arts devise, implement and manage youth arts programmes in the areas of Visual Arts, Theatre and Film
- Expand working relationships with key stakeholders & partners in delivery of high quality events across the county

- Develop Creative Ireland 5 year plan in partnership with Cultural Services Team
- Implement new 'Writers Readings' series
- Deliver County Arts Development Plan & implement year one actions.

SERVICE DIVISION J

FINANCE

During 2017, the Finance Department focused its efforts on effective expenditure controls and enhanced debt collection measures, with the overall objective of ensuring that the Council operates within its allocated Budget.

Obtaining value for money, efficient delivery of services and optimising revenue streams continue to be the main focus of the Finance Department.

Achievements 2017:

Procurement

The Procurement section continues to support all sections by continuous review and reporting on matters related to policy and procedures, approval limits, implementation of national frameworks, administration of low value purchase cards and tendering initiatives.

Since the implementation of the new MS4 Financial system, procurement has become an integral part of the purchase to pay cycle which has enabled Management to focus on developing improvements to the tendering and procurement process throughout the organisation.

Commercial Rates

The Council continues to work closely with ratepayers to facilitate payments and maximise collection rates. The Business Support Scheme will assist approximately 2,100 businesses. Collection levels for 2017 are on course to slightly exceed 2016 levels.

Rents

Quarterly statements are issued to all tenants. This enables tenants to monitor and confirm their payments. Escalation protocols have also been strengthened to facilitate early intervention in cases of difficulty. House calls in certain circumstances are undertaken. Collection levels may increase on 2016 levels. Rents are now assessed through iHouse (Housing System), which will enable more effective assessments and an improved reporting facility.

Loans

The Mortgage Arrears Resolution Process (MARP) has been implemented and progress is being made on viable agreements. It should be noted that MARP is a time consuming process. Loan approvals are in line with 2016 levels. These are first evaluated by the Housing Agency (HA) before a final decision is made by the Credit Committee.

NPPR

The service of providing NPPR compliance and exemption certificates is a sizeable task as these are being sought for all residential property sales, regardless of whether the property was liable or not. Agreements and payment plans are continually being put in place and monitored. It should be noted that the amount of liable properties is diminishing and the income from the NPPR will decrease in time.

Initiatives and Challenges 2018:

During 2018 budgetary control will continue to be the main focus for Finance as we strive to effectively manage the County's resources, and achieve further efficiencies and value for money.

The Finance Department will continue to review actual spend against budget on a regular basis and seek to provide explanations for any variances.

A full review of the operations of the LVPC (Low Value Purchase Cards) is also planned for 2018.

HUMAN RESOURCES

Achievements 2017:

In 2017, as part of ongoing workforce planning, the HR Department continuously reviewed staffing levels and requirements. Following a number of years of change throughout the local government sector the HR Department has worked with senior management and the various service areas of the organisation in order to identify current and emerging requirements so to be in a position to plan and respond to same in terms of staffing.

The implementation of the ongoing workforce planning process throughout 2017 gave consideration to the following:

- Continued increase in activity both locally and throughout the local government sector in terms of recruitment and selection
- Continued increase in opportunities throughout the public sector in general and consequent employment and skills mobility
- Planning for the filling of vacancies and a renewed focus on attracting and recruiting people with the appropriate knowledge and skills
- Continued work towards being an employer of choice which would assist with the retention of staff
- Renewed focus on learning and development opportunities for staff with a particular focus on structured induction for new staff as well as fostering a fair and healthy working environment
- Continued change management processes including the move of staff to new civic offices
- Working with line managers and supervisors in terms of managing effectively.

To date in 2017, the Recruitment & Selection Unit has facilitated 40 recruitment competitions, an increase, once again, on previous years.

The new version of the Core (Version 19) was successfully implemented.

The Training Unit has continued to review learning and development requirements throughout the organisation, which includes mandatory training as well as new initiatives in terms of the staff welfare and health.

The Superannuation Unit is now close to completing work on the transition of the Superannuation function to MyPay. The transition for Meath County Council will be completed before the end of 2017.

The HR Department has worked very closely with staff and unions particularly in terms of the move to new civic offices in order to assist with either group or individual concerns.

Initiatives and Challenges 2018:

The priorities for the Human Resources Department in 2018 will be:

- ongoing workforce planning including identifying emerging requirements and continued focus on recruitment & selection
- continued focus on training and staff learning & development opportunities.

INFORMATION SYSTEMS

Achievements 2017:

During 2017, the Information Systems department continued to deliver business improvement projects across the entire organisation while maintaining its focus on operational stability and information security.

- IT Operations Successful migration of staff and services to the new Headquarters has been a focus for the year. Careful planning and testing of network links, WiFi, Audio-Visual facilities for meeting rooms, etc. ensured a seamless move to an environment that encourages teamwork and innovation. Other key initiatives included the replacement of our entire server and storage environment, including backups and disaster recovery. Various security initiatives included awareness training for all staff
- **Business Solutions** The complete redesign of the www.meath.ie website is nearing completion. This will include many new facilities as well as an enhanced user interface, and will form the basis for ongoing new developments as we focus on providing a digital channel for customers. A major upgrade of the SugarCRM system has been developed and training is currently underway. This will include a mobile app to allow for speedy resolution of calls onsite. A new facility for online consultation has been implemented, in readiness for use in the next stage of the County Development Plan.
- Information Management Pilot projects were undertaken to uild our capability in the area of analytics, to support timely decision making across the council. Work has commenced in preparing the IT environment for the implications of the General Data Protection Regulations (GDPR). Also, a new mapping solution has been implemented to support the new www.meath.ie website.

Initiatives and Challenges 2018:

During 2018 we will upgrade our entire Microsoft environment at server and desktop level. Related to this will be a major focus on document and records management, to ensure readiness for the General Data Protection Regulations. Both of these initiatives will also create a new environment for productivity through collaboration and secure mobile working. Mobility will be a major focus, where we will be seeking opportunities to improve customer service and efficiency through use of the SugarCRM app and other apps.
