4. To receive a presentation on the Social Inclusion and Community Activation Programme (SICAP) from the Programme Implementer (PI)

J. Land, Meath Partnership gave a presentation on the Social Inclusion and Community Activation Programme (SICAP) as Meath Partnership is the Programme Implementer with the LCDC overseeing the programme. The budget for Meath is €235,799 for 2015. The Operational period for the Programme is from 14th May, 2015 to 31st December, 2017. SICAP has three programme goals which contain objectives, outcomes and indicators.

The Programme of Activities for 2015 namely:

A discussion took place with the members following the presentation. D Jones suggested that a Sub Group be set up to review actions and to sign off on payments. G O'Brien requested that financial and monitoring reports be circulated in advance of meetings. Cllr Sinead Burke and John V Farrelly agreed to sit on the Sub Group along with Áine Bird, David Jones, Michael Ludlow and Jennifer Land.

5. To receive a presentation on the Leader Programme

J. Land, Meath Partnership also gave a presentation on the Leader Programme. The Leader Programme has 7 key aspects and 3 Themes. It is a capital investment programme with a budget of €6,903,123.57. Consultation process will commence in

September with the aim of presenting a draft to the LCDC in November and the Programme commencing in Spring 2016.

D Jones stated that the LCDC is the Local Action Group for Leader and suggested that a Sub Group be set up to feed into the Strategy. It was agreed to have further discussions at the next meeting.

6. Update on the Local Economic & Community Plan (LECP)

A copy of the public consultations timetable for the LECP was circulated to all present.

7. Update on Public Participation Network (PPN)

D Jones updated the Members as follows:

Most pillars / Municipal District PPN's did not meet during the summer months. The Secretariat continued to meet monthly throughout the summer. They have set up a referral register to record all issues raised at PPN meetings in order to identify common themes and issues raised so they can decide which ones to progress. They intend to work on this once the LCDC nominatios process is completed. The next Secretariat meeting will be held on 28th September, 2015.

The Secretariat has written to the Chair of the LCDC, the Chief Executive, Meath Co. Council seeking a number of measures which they feel will improve communication between the PPN, LCDC and Council Departments.

Following a resignation from the Secretariat, another rep from the Social Inclusion College for the Secretariat will now be sought.

S Smith stated that the PPN needs to be independent of the Local Authority and feels that it is struggling in particular the Social Inclusion college.

G O'Brien also brought up the matter of travel and subsistence for the Secretariat.

S Smith suggested that D Jones meet with the Secretariat.
