# 1. To receive and ratify the recommendation from the Evaluation Sub-committee on the SICAP tender.

D Jones advised that a letter was issued from the Department of Environment, Community & Local Government to the Chief Officer, Chair of the LCDC, Chief Executive and Chair of Meath Partnership. It stated that the issues between the Department and Meath Partnership are now resolved and that the LCDC can now proceed to make a decision to award the SICAP tender.

D. Jones gave a presentation on the overview of the public procurement tender process for SICAP. He advised that the Department wanted the entire allocation of

€278,000 for 2015to be delivered in Meath. This would be under the LCDP framework from January to May 13<sup>th</sup> and then SICAP from 14<sup>th</sup> May to December 2015.

The members agreed to the SICAP allocation to commence from 13<sup>th</sup> May to December 2015 which would increase the targets being delivered over a shorter timeframe with a budget of €235,000 being allocated for this period. This would mean that the full funding for Co Meath for 2015 would be delivered under the LCDP and SICAP frameworks.

On the proposal of John Farrelly and seconded by Tadhg Ó Conghaile, the members ratified and approved the SICAP tender from Meath Partnership.

It was agreed that Meath Partnership would present the plan at the September meeting scheduled for Friday 11<sup>th</sup> September 2015 at 10.30am.
