1 Confirmation of Minutes

1.1 Confirmation of minutes of Ordinary Meeting held on 26th March, 2018.

The minutes of the Ordinary Meeting held on the 26th March, 2018 were adopted on the proposal of **Councillor Bryan Reilly** and seconded by **Councillor Michael Gallagher**.

4 Statutory Business

4.1 Transportation

4.1.1 To receive a Progress Report on works undertaken/planned for Kells Municipal District.

The report had been circulated in advance and matters raised by Councillors included:

- The use of extra road crews it was confirmed that two extra contractors had been taken on and had undertaken works in the Oldcastle and Nobber areas with further works to be undertaken in Oldcastle and Kells areas.
- Pothole repairs on lanes it was confirmed that main roads were being prioritised but that an application for additional funding was being made for damage resulting from the bad weather and that if this funding was secured, another contractor would be taken on for pothole repair.
- Poor road conditions in locations such as between Drumconrath and Kingscourt the works planned, subject to funding, were outlined.
- Potholes from the Railway Bar out the Rockfield Road and the need to ensure that damage to roads within the town were also included it was pointed out that the watermain rehabilitation works would be carried out on this road but that potholes would be filled as required.

4.2 Community

4.2.1 To receive details of the proposed Part VIII Planning process for the installation





of lighting along the walkway in the threshing field in Moynalty, and, if thought fit, to resolve to commence the Part VIII Planning Process for the proposed works.

Fiona Fallon, Senior Executive Officer, Community Section outlined the project, which was due to be undertaken in September/October. The public consultation is due to commence on 1st May until 30th May, following which submissions can be made by 5th June. It is expected that the Chief Executive's report, with submissions and recommendations, would be brought to the July municipal district meeting.

The information was noted.

4.2.2 To receive a presentation on the current LEADER programme & updates to the scheme.

Michael Ludlow, CEO and Colin Ludlow, Senior Project Officer, Meath Partnership delivered a presentation on the LEADER 2020 programme, including an overview of the programme, the thematic framework 2014-2020, eligible project areas, ineligible activities, available grant rates, benefits of changes to programme delivery, progress 2017 – 2018 including progression of applications in 2018 and applications approved 2017 – 2018.

Matters raised by Councillors included:

- The capacity of the programme to accept more applications it was confirmed that the programme was not over-subscribed and applications should still be made.
- The amount allocated to date it was highlighted that 62% of the amount available had been awarded and would be paid out as projects progress.
- Funding available for disadvantaged groups the available funding was outlined.
- The deadline for the receipt of applications it was pointed out that the programme was fully open to applications on a rolling basis.





- Advice available on the eligibility of applications prior to their submission – it was confirmed that a proposition can be assessed for eligibility and a project assessed to see if an element of it would be eligible.
- The co-funding of projects it was conceded that, whilst these can be more complex, they can be managed and would be suitable for larger community projects. It was pointed out also that the Town & Village Renewal Scheme, e.g., can also be used to fund a project once the schemes are not funding the same element.
- Additional funding allocation it was agreed that this may happen but only if the programme is being delivered.
- The capacity of groups to fulfil procurement requirements it was pointed out a case was being made for greater flexibility, e.g. with regard to festivals, and that whilst Meath Partnership cannot provide such expertise any longer, there were companies available that could assist at nominal cost.

The Cathaoirleach and Councillors thanked Michael and Colin for their presentation and for the information provided.

4.3 Corporate Services

4.3.1 To note Municipal District Allocations submitted by Councillors on behalf of Kells Municipal District.

9 Any Other Business

- 9.1 Councillor David Gilroy raised the following issues:
 - 9.1.1 Requested an update on the unauthorised halting site at Kilkeela, Athboy it was agreed to refer this to the Planning Department.
 - 9.1.2 Requested an update on the derelict property on Main Street, Athboy opposite the hotel.
 - 9.1.3 Suggested that the twinning connection with Iona be formally re-established before the summer and confirmed that an allocation of €2,500 was available, possibly for a trip to Iona for 2 or 3 nights. It was agreed that local links be pursued and contact made with representatives in Iona to ascertain their interest.





- 9.2 Councillor Sarah Reilly raised the following issues:
 - 9.2.1 Requested an update on the plans for the Community House, Carrick Street, for which an allocation had been made in the capital programme and the need to make it available for community groups.
 - 9.2.2 Requested an update on the review of the car park and safety issues at the Chipper Lane, Kells.
 - 9.2.3 Requested an update on the capital works in the three cemeteries.
 - 9.2.4 Requested that a reminder letter issue to the OPW regarding the Round Tower and St. Colmcille's House.
 - 9.2.5 Requested that potholes be repaired on the route of the 'Darkness into Light' walk in the Moynalty area and taking place on 12th May.
- 9.3 Councillor Michael Gallagher raised the following issues:
 - 9.3.1 Requested an update on the provision of the taxi ranks.
 - 9.3.2 Concerns raised by Blackwater Anglers regarding possible pollution from the drainage from the business park and requesting that tests be carried out at this location.
- 9.4 Councillor Johnny Guirke raised the following issues:
 - 9.4.1 The possibility of replacing the flag pole on The Square in Oldcaste.
 - 9.4.2 Additional or updated signage on the Kells Road, Oldcastle to deter speeding traffic towards Gibson school.
 - 9.4.3 Welcomed the motion proposed by Councillor Eugene Cassidy at the full Council meeting to reduce the community contribution under the CIS to 5%.
