NOTICE OF DRAFT VARIATION OF THE NAVAN DEVELOPMENT PLAN 2009-2015

Notice is hereby given that the Members of Meath County Council, having considered Proposed Variation No. 2 of the Navan Development Plan 2009-2015 and the Chief Executive's Report therein in accordance with Section 13 of the Planning and Development Acts, 2000-2016, have resolved that the Proposed Variation of the Navan Development Plan be altered. The proposed modifications constitute a material alteration of the draft Variation of the Navan Development Plan 2009-2015.

The likely significant effects on the environment of implementing the proposed material alterations have been assessed. The Planning Authority has determined that neither a Strategic Environmental Assessment nor Appropriate Assessment is required to be carried out with respect to the proposed material alterations.

The purpose of this variation is to incorporate the key tenets of the Economic Development Strategy for County Meath 2014 – 2022, as they relate to land-use planning, into the Navan Development Plan.
