6.1 Orientation for Councillors

- 6.2 Councillor Nick Killian raised the following issues:
 - 6.2.1 The needs to replace the traffic lights at the cemetery cross at Ratoath it was confirmed that works at this junction, including surfacing, were being costed.
 - 6.2.2 The need to advertise the position of school warden in Ratoath.
- 6.3 Councillor Brian Fitzgerald raised the following issue:
 - 6.3.1 The number of dangerous junctions due to overgrown weeds and hedges and the responsibility of landowners to deal with same it was confirmed that works would commence on this in 2/3 weeks.
- 6.4 Councillor Maria Murphy raised the following issue:
 - 6.4.1 The need to advertise the position of school warden in Dunboyne it was pointed out that a policy had been adopted by both the SPC and full council in relation to situations where a school warden vacancy arises, whereby all options would be considered, including any suitable engineering solutions.
- 6.5 Councillor Damien O'Reilly raised the following issue:
 - 6.5.1 Expressed his dissatisfaction at the delay in progressing the provision of a new or extended cemetery for Dunboyne it was agreed that an update would be circulated in advance of the July meeting.
- 6.6 Councillor Gerry O'Connor raised the following issues:
 - 6.6.1 The need for an alternative safe crossing, e.g. pedestrian traffic lights, at St. Seachnall's N.S.
 - 6.6.2 The possibility of council staff cutting the grass at the front of the health centre in Dunshaughlin during the Tidy Towns/Pride of Place judging.





- 6.7 Philip Traynor raised the following issue:
 - 6.7.1 Circulated the draft proposal for works on the Drumree Road it was agreed on the proposal of **Councillor Damien O'Reilly** and seconded by **Councillor Gerry O'Connor** that these should proceed to public display.
- 6.8 Councillor Deirdre Geraghty-Smith raised the following issue:
 - 6.8.1 The issues relating to traffic exiting at the junction of Glascarn Lane to Fairyhouse Road it was pointed out that there were interim measures in place with negotiations ongoing to provide a more permanent solution.
