- To consider the report of the Chief Executive prepared in accordance with the provisions of the Local Property Tax (Local Adjustment Factor) Regulations 2014, for the purpose of resolving as follows:
 - a) Vary the basic rate and set a local adjustment factor that will apply for a period of one year from the next Local Property Tax liability date, or
 - b) Not vary the basic rate.





The Cathaoirleach opened the meeting and the Chief Executive provided an overview of the purpose of the meeting and the decisions required. The Head of Finance made a presentation that comprised of two parts:

- 1. An overview of the 2015 budget process, including the legislation, regulations, circulars, timelines and the decisions required as part of that process. These include the harmonisation of commercial rates, the vacancy refund rate and the General Municipal Allocation. The Budget Meeting is to take place on 24th November 2014.
- 2. The issues related to the Local Property Tax Adjustment Factor. The presentation outlined the regulations, the approach to and outcomes of the public consultation, the estimation of income and expenditure for 2015, a statement of the Council's current financial position and the financial effect of the varied rate. These are all matters that Councillors must have regard to in making their decision.

Three proposals were made as follows:

- A reduction of 5% in the Local Property Tax was proposed by **Councillor Shane Cassells** and seconded by **Councillor Wayne Harding**.
- A reduction of 15% in the Local Property Tax was proposed by **Councillor Darren O'Rourke** and seconded by **Councillor Sinéad Burke**.
- **Councillor Gerry O'Connor** proposed an amendment to retain the Local Property Tax at its current rate and this was seconded by **Councillor Eugene Cassidy**.
- A reduction of 2% was proposed by Councillor Joe Bonner and seconded by Councillor Michael Gallagher.

The proposal to reduce the basic rate of the Local Property Tax by 5% was defeated following a roll call vote:
