5.0 Statutory Business

5.1 **Planning**

5.1.1 To agree a date for the holding of a Special Planning Meeting in order to receive the Manager's report on submissions to the public display of the Draft Meath County Development Plan 2013-2019.

- A map of the line should be made available.

5.2 Transportation

5.2.1 To enter into an agreement pursuant to Section 85 of the Local Government Act 2001 with Navan Town Council whereby Meath County Council will exercise the powers, functions and duties of both Councils in relation to the carrying out of sustainable transport projects funded by the National Transport Authority including, design, procurement and construction of works within the administrative area of Navan Town Council.

Approved on the proposal of **Councillors Tommy Reilly** and seconded by **Councillor John V. Farrelly**.

5.2.2 To enter into an Agreement pursuant to Section 85 of the Local Government Act 2001 with Drogheda Borough Council whereby Drogheda Borough Council will exercise the powers, functions and duties of both Councils in relation to the carrying out of the R152 Platin Road Safety Scheme, funded by the NTA including design, procurement and construction of works within the administrative area of Meath County Council (text of the agreement to follow).

Nicholas Whyatt, Senior Engineer, outlined the current position in relation to the Slane By-pass and the Traffic Management System.

5.4.1 Briefing on revised Local Government Fund Allocation.

Fiona Lawless, Head of Finance, outlined the implications of the recent Government circular in relation to the Household Charge. The meeting was informed of the 56% collection rate to date in Meath. Ger Soady, Administrative Officer, Finance Section, outlined the work to date regarding the collection of the charge and that third reminder letters are now being prepared. The limited data available was noted.

A lengthy discussion followed on the financial implications for the Council in terms of the non-payment of the household charge.

It was noted that inspections by the Council are carried out in relation to the landfill levy. It was agreed that the Council would write to the EPA in relation to environmental concerns.
