4 (a) Presentation by Mr. Stephen Kent, Chief Executive Officer, Bus Éireann on the provision of bus services in County Meath

Mr. Stephen Kent, Chief Executive Officer, Bus Éireann made a presentation to the meeting outlining the context within which the company provides services in the county. The presentation set out the challenges that the companies faces and its plans for improvements in the coming years. Mr. Kent was joined by his colleagues: Mr. Alan Parker, Chief Customer Officer; Mr. Adrian O'Loughlin, Operations Officer and Mr. John Sheridan, Media and Communications Officer.

The Bus Éireann representatives provided feedback and clarification and informed members about the company's representation email, which is set up to provide responses on issues raised by elected members.

- 6 Reports
- 6.1 Chief Executive's Report





Clarification was sought by Councillors Nick Killian; Mike Bray; Annie Hoey; Alan Tobin; Tom Behan; Sharon Keogan; and Paddy Meade on a number of matters in the Report. The main issues focused on:

6.2 Report from the Corporate Policy Group

The CPG received an up-date on the preparation of Budget 2020 and confirmed the next steps, which included the series of meetings with Municipal Districts. It also received an up-date on the preparation of the Corporate Plan 2019-2024. It reviewed the minutes of the first meetings of the Transportation and the Climate Action and Environment SPCs. The Meetings Administrator also advised that the Chief Executive has provided the Chief Executive with a prescribed notification under Section 147 of the Local Government Act 2001 regarding her tenure in office.

The **Cathaoirleach** confirmed receipt of the prescribed notification and informed the meeting that he would be informing the Minister and the Local Appointments Commissioners, as required under the Act.

8 Notice of Question

8.1 Submitted by Councillor Edward Fennessy

'Subsequent to a motion passed during the November 2018 meeting of Meath County Council, I ask the Chief Executive for an update regarding the commencement of a pilot part-time work placement scheme across council offices, for people with disabilities.'

Response:

As outlined in the supporting information to the motion passed in November 2018 Meath County Council is an equal opportunities employer which accommodates applications for jobs and work placements from candidates from a range of backgrounds including candidates with a disability. Since November 2018 the HR Department has continued with the main area of priority ensuring that the Council has the appropriate staff resources available so we may deliver on our current and planned service/business requirements.

Staff recruitment and facilitation of work placements from a range of candidates continues and while it has not been possible, due to HR Department service demands, to implement a specific programme as prescribed in the motion of November 2018 it may be possible to do so at a future point. In the meantime the HR Department will continue to seek to accommodate candidates with a disability who are seeking work placements wherever feasible. It must be noted that the work in relation to Prosper Meath continues and that this partnership process is proving successful in addressing disability related issues.

8.2 Submitted by Councillor Darren O'Rourke

'To ask the Chief Executive for a report on the Meath County Council local authority energy consumption rates for the last two years and whether it is believed that Meath County Council is in line to meet its 2020 target.'

Response:

Meath County Council's energy consumption in 2018 was 38,615,414 KWh, which was a 1.3% reduction on energy consumption in 2017 of 39,106,003 kWh.

The Council's energy consumption has reduced by 15% from a baseline of 2009. The target is 33% by 2020. While other local authorities have a better rate of reduction, they are using an earlier baseline, when energy consumption was higher and thus their relative rate of reduction is greater. The roll-out of the LED public lighting programme on over 18,500 lights in the county will be a significant advance in reducing the Council's energy consumption. Public Lighting currently accounts for 49% of





energy consumption and the LED programme, when complete, should bring a reduction of between 30-50%.

8.3 Submitted by Councillor Mike Bray

"To provide the number of fines issued and the number of fines paid for dog fouling in each municipal district in 2018 and to date in 2019."

Response:

A total of 9 dog fouling fines were issued in 2018 and of which 3 were paid - fines issued were as follows - Navan MD 4, Laytown/Bettystown MD 3 & Trim MD 2. Four dog fouling fines have issued to date in 2019 two of which have been paid to date. Fines are also issued in respect of dogs that are not under control - 11 in 2018 and 7 to date in 2019.

It is pointed out that sufficient evidence of littering is required in order to obtain a prosecution in the Courts and in many cases, while fines are issued based on information received from members of the public, getting the witness to subsequently attend Court to give evidence often proves very problematic. This is particularly so in the case of reported dog fouling incidences.

It is also pointed out that the Community Wardens do target areas which are subject to regular complaints over dog fouling and advise dog owners of their responsibilities in terms of cleaning up and in the vast majority of cases such advices are taken on board without the need for any further action including the issuing of fines. The erection of signage at popular dog walking areas also serves to remind dog owners of such responsibilities.

In all cases, consideration has to be given as to whether it is in the public interest to proceed to the courts based on the significant legal costs involved and the difficulties in securing payment of such costs, even where a conviction is obtained based on the circumstances of the offender.

8.4 Submitted by Councillor Deirdre Geraghty-Smith

"To ask the Chief Executive to describe the specific actions currently being undertaken by the Housing department to ensure that the vacant sites register is fully up to date in the County."

Response:

Following the adoption of Variation 4 of the Meath County Development Plan 2013-2019 in December 2017 Meath County Council has placed 23 sites on the Vacant Sites Register. Sites are





identified in accordance with the criteria set out in the legislation and a Proposed Notice of Entry on the Vacant Site Register is sent to the landowner(s). This gives the landowner the opportunity to set out why the site does not meet the criteria for the Vacant Sites Register. If the appeal is unsuccessful, the site is placed on the Vacant Sites Register with a further appeal mechanism to An Bord Pleanála.

The Planning Authority continues to implement this policy on sites that meet the relevant criteria, i.e. zoned appropriately, have not applied for and/or activated a permission and are serviced with transport links and water supply.

Cllr. Geraghty-Smith sought a clarification, which would be provided to her directly. Noted by the Elected Members.

9 Notice of Motion

9.1 Submitted by the following Laytown-Bettystown District Councillors (Councillors: Sharon Keogan; Wayne Harding; Paddy Meade; Stephen McKee; Annie Hoey)

"The elected members of Laytown-Bettystown Municipal District call on Meath County Council to cease all progression of the proposed council house development at Staleen, Donore (including not placing the proposed development on e-tenders or seeking tender by any other method), until such time as a majority of the Laytown-Bettystown County Councillors vote in favour of a proposed plan."

Supporting Information subject to the motion being proposed, seconded and considered.

Housing Need for the Scheme: Meath County Council as part of its statutory remit as a Housing Authority is required to assess the housing need throughout the County, including Donore. The housing need in Donore alone stands at 38 households (with a total of 83 applicants from all areas expressing a preference for Donore). Housing need has existed in the area for the past number of years and is expected to continue even with the implementation of this scheme.

Initiation of the Scheme: In order to meet housing needs in the County, a strategic review of the Council's land bank was carried out to identify suitable sites for the provision of social housing. On foot of this review approval was sought from the Department of Housing, Planning and Local Government in mid-2017 to progress schemes at seven different locations including Donore. Stage 1 approval to proceed with the Donore scheme was received in June 2017. A design team was appointed in October 2017.

Planning Process: After the initial designs were received, Departmental approval was obtained in May 2018 to go to a Part VIII process for 21 Houses. Prior to the formal commencement of this process a variation of the County Development Plan was required. The variation went on public display in November 2018 and was approved by the full Council (including the Laytown/Bettystown





members) at its meeting on 4th February 2019, following consideration of the Chief Executive's Report and the submissions received.

Once the variation was approved, a Part VIII application went on public display on 21st February, 2019 and the Chief Executive's Report was presented to the meeting of Laytown-Bettystown Municipal District on 16th May 2019. The officials from the Planning and Housing Departments were in attendance and outlined the process for the members i.e. that they would have to bring forward a motion to either reject or amend the Part VIII within six weeks of receiving the Chief Executive's Report. If no such motion was brought forward within that period, permission was effectively granted for the development. No motions were brought forward within the six week period.

Departmental Approval: As the planning process has been completed, Departmental approval has now been obtained to go to tender on the scheme within an overall scheme budget of €4,521,902. The Donore Scheme, as with all direct construction projects, is subject to the Department's four stage approval process, including Capital Appraisal and Project Review, Pre-Planning Statutory Approval, Pre-Tender Approval and Tender Approval. For each of these four stages, a project cannot proceed without the Department's formal sanction, which includes approval in respect of scheme design, technical aspects and costs. The Donore scheme is now in the third stage of the approval process.

Conclusion: Meath County Council, as the statutory Housing Authority, has an obligation to assess the housing need and to meet that need as effectively as possible. The housing need in Donore has been established and is growing. The proposed development will be a significance response to this need.

Given the stage at which the project is at, the motion would negate the exchequer funds already expended in the planning and design of the project and cast doubt on Meath County Council's commitment to implementing its programme under Rebuilding Ireland, potentially putting in jeopardy the €4.5m approved, thus undermining its ability to attract future funding for housing in the county.

Following the approval of the variation to the County Development Plan and the completion of the Part VIII process by the Councillors, the provision of this housing scheme is now an executive function and it is intended to proceed with the next stages of the development, in accordance with the approvals granted by the Department to date.

The motion was proposed by Councillor Paddy Meade and seconded by Councillor Stephen McKee. There was an extensive debate on the motion with contributions from Councillors Paddy Meade; Stephen McKee; Sharon Keogan; Alan Lawes; Nick Killian; Gerry O'Connor; Sharon Tolan; Sarah Reilly; Darren O'Rourke; Eugene Cassidy; Joe Fox, Maria Murphy; and the Cathaoirleach. A response was provided by the Chief Executive and clarifications given by Directors of Services: Kevin Stewart and Barry Lynch. The Cathaoirleach decided to put the motion to a roll call vote.

9.2 Submitted by the Laytown-Bettystown Municipal District Councillors

"To call on the Minister for Transport, Tourism and Sport, Shane Ross, to designate the R132 as a national road."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The R132 Dublin — Dundalk, County Louth (Part Old National Route 1) extends from its junction with R803 at Parnell Street in the city of Dublin to its junction with R174 at Feede in the county of Louth. It passes through the administrative areas of four local authorities namely Dublin City, Fingal, Meath and Louth.

The proposition to make the R132 a national road was raised at the meeting of the Joint Oireachtas Committee on Transport, Tourism and Sport on September 25, 2019. The response given by the Department was that even if the Minister made an order designating the R132 as a national road, TII would still have to go through the same process of undertaking the analysis and justification of the project in conjunction with the local authority. Funding would also have to be found for the project. While there may be a perception that TII might be in a better position to deliver the project more quickly, the actuality is that the same timelines would apply to delivering the scheme regardless of whether it was a national road or a regional road project.

A reclassification of the R132 to a national road would have other implications. Meath County Council would remain as the Road Authority, however, the TII would have overall responsibility for the planning and supervision of works for the construction and maintenance of the road.

TII is required, as far as possible, to arrange that these functions shall be performed on its behalf by the relevant road authority. However, where TII considers that it would be more convenient, more expeditious, more effective or more economical that the function concerned should be performed by it, it may decide accordingly. Under section 20 of the Roads Act 1993, TII would also have the power to direct Meath County Council to do certain things in relation to the road and the Council would be obliged to take all such measures as would be necessary to comply with such a direction.

It should also be noted that should the road be re-classified as a national road the provisions of the Spatial Planning and National Roads Guidelines 2012 would apply, which would cause potential restriction to/from the road in the context of development control.

The current status regarding Julianstown is that a draft business case to address the traffic volumes in Julianstown was submitted to the Department of Transport, Tourism and Sport in December 2018, with the by-pass emerging as the preferred option. Following the meeting of the Joint Oireachtas Committee on Transport, Tourism and Sport on the 25th September 2019 a final business case was





submitted in October 2019 and the Council await the Department's comments on same. In the meantime, the Council has made provision for €800,000 in its Capital Plan 2019-2021 for traffic management measures in Julianstown. The Transportation Department is currently preparing a submission to An Bord Pleanala for approval of these proposed traffic management works. This is due to be submitted in November 2019.

The motion was proposed by **Councillor Annie Hoey** and seconded by **Councillor Stephen McKee.** There were contributions from the following members: **Councillors Annie Hoey; Sharon Tolan; Alan Tobin; Maria Murphy;** and **Mike Bray**. It was agreed that this motion be referred to the Transportation Strategic Policy Committee for consideration.

9.3 Submitted by Councillor Ronan Moore

"That Meath County Council undertakes to ensure that all new public buildings when designed – with particular attention paid to sanitary facilities – incorporate a Universal Design approach so that it can be accessed, understood and used to the greatest extent possible by all people regardless of their age, size, ability or disability. Furthermore, that Meath County Council encourages all entities that receive funding from Meath County Council for the construction and/or refurbishment of facilities open to the public, consider a Universal Design approach."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

During the design of any new building, Meath County Council considers statutory requirements, available space, end use of the building and best design principles. The Universal Design approach has been previously utilised during the design phase and this is something that will continue going forward. In addition to considering Universal Design in Meath County Council projects, this approach can also be considered through the various Community grant schemes that have an element of building design.

The supporting information and the motion, proposed by **Councillor Ronan Moore** and seconded by **Councillor Darren O'Rourke**, was noted.

9.4 Submitted by Councillor Sarah Reilly

"That Meath County Council investigate the feasibility of recycling stair lifts in appropriate circumstances."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The Housing Department will investigate the feasibility of the reuse of stair lifts, in particular in instances that arise through our own housing stock, and had been subject to Local Authority Adaptation Works Scheme funding. Matters of compatibility of equipment, installers' willingness to





utilise pre used stair lifts and storage will need to be examined in this context, while schemes operated by other Local Authorities will be ascertained.

The supporting information and the motion, proposed by **Councillor Sarah Reilly** and seconded by **Councillor Gerry O'Connor**, was noted.

9.5 Submitted by Councillor Alan Tobin

"Following the unanimous passing of my motion in 2015, I call on Meath County Council to follow through as soon as practicably possible to introduce "bye laws on the prohibition of consumption of intoxicating liquor on roads and public places."

Supporting Information subject to the motion being proposed, seconded and considered.

This matter was the subject of a Motion considered at the September 2015 Council Meeting and a response issued as follows:

The motion has since been the subject of discussion with the Gardaí and particularly at Joint Policing Committee meetings and while further discussions are proposed it has been suggested that sufficient authority is already available to the Gardaí to deal with public order offences often associated with consumption of alcohol in public places through the Criminal Justice Acts as well as the Councils own Meath Parks and Playgrounds Bye Laws 2014.

The matter has been raised at subsequent Joint Policing Committee level meetings however, the Gardaí in whom responsibility for enforcing the bye-laws would inevitably fall, have not called for such bye-laws to be introduced and suggest they have sufficient enforcement powers as vested in Public Order legislation.

It was agreed that the motion, proposed by **Councillor Alan Tobin** and seconded by **Councillor Sharon Tolan**, would be referred to the Joint Policing Committee for consideration.

9.6 Submitted by Councillor Alan Tobin

"That Meath County Council use opportunities available to it to encourage the public to take the flu jab as well as other recommended vaccines for the overall health of our older people, those that are pregnant, young children, teenagers and those with compromised immune systems."

There was an intervention from Councillor Ronan Moore. The motion, proposed by **Councillor Alan Tobin** and seconded by **Councillor Gerry O'Connor**, was noted.





9.7 Submitted by Councillor Deirdre Geraghty-Smith

"That this Council would write to the Garda Commissioner expressing its dissatisfaction at the announcement that the new Garda Divisional Headquarters is not to be located in County Meath, following the recently announced merger of the Meath and Westmeath Garda divisions; in spite of the larger population in this County. That this Council would also seek a full, written description of the proposed resourcing plan and organisational structure on a district by district basis for County Meath. That the Council would further impress upon the Commissioner the need for increased visibility and resourcing on the ground in County Meath in line with population growth; such as in South County Meath, and the need to invest significantly in the physical resources available to an Garda Síochána across the County."

Supporting Information subject to the motion being proposed, seconded and considered.

The Chairperson of the Joint Policing Committee (JPC) has already written to the An Garda Commissioner inviting him to attend a meeting of the JPC on December 9, 2019. This invitation has been accepted and all Councillors will be invited to attend and participate in the meeting. Should this motion be passed, it will be forwarded to the Commissioner in advance of the December meeting.

There were interventions from Councillors Gerry O'Connor and Alan Tobin. The motion, proposed by Councillor Deirdre Geraghty-Smith and seconded by Councillor Ashling Dempsey, was agreed.

9.8 Submitted by Councillor Deirdre Geraghty-Smith

"That this Council would write to the NTA inviting them to attend a meeting of the Council to discuss a range of issues relating to transport in the County, including the bus network and the Navan Rail Link."

Supporting Information subject to the motion being proposed, seconded and considered.

Following the passing of a motion by this Council at its meeting in October, the NTA has been invited to attend a meeting of the Council and has accepted this invitation. It is planned that executives from the NTA will make a presentation and discuss transportation issues with elected members at the December Council meeting.

This motion was considered as part of Item 7.1

9.9 Submitted by Councillor Darren O'Rourke

'In order to better inform the ongoing review of the Meath County Development Plan, and recognising 1) the implications of the provisions of national and regional strategies on rural one-off housing, 2) the related restrictions to be provided on those seeking planning permission in rural





areas, and 3) the potential impact that this will have on rural areas, including Gaeltacht areas, in Meath; that this Council will write to the Minister for Housing, Planning and Local Government for an urgent update on the local planning implications of the 'Flemish Decree' judgement by the European Court of Justice."

There was an intervention from Councillor Damien O'Reilly and the motion, proposed by **Councillor Darren O'Rourke** and seconded by **Councillor Alan Lawes**, was agreed.
