#### 5.1 Transportation

5.1.1 To receive a Progress Report on works undertaken/planned for Kells Municipal District.

5.1.2 To consider a request to permit HGVs to access the new services station on the R147 on the northern edge of Kells (currently under construction adjacent to the Aldi supermarket) in contravention of the current HGV ban and if appropriate to agree a mechanism for public consultation on the matter.

Kevin Stewart confirmed that a formal request had been received with regard to the access by HGVs to the new service station and that the recommended means of dealing with this is by way of revised signage under the road traffic legislation, which does not require statutory public consultation. It is therefore proposed to undertaken non-statutory public consultation, which, if agreed, could allow for a report, with recommendations, be presented at the March meeting.

  - 9.2.1 The need to clear blocked drains in Wilkinstown village.
  - 9.3 Councillor Paul McCabe raised the following issue:
    - 9.3.1 Referred to the L2805 Moynalty to Baileboro road, which is not on the gritting route, and requested the erection of signage on either end of the road warning road users that the stretch is not gritted, particularly as the regional roads on either side are gritted It was agreed that signage would be ordered as this section of road did merit signage.
  - 9.4 Councillor Seán Drew raised the following issues:
    - 9.4.1 The dumping of household refuse in bins around the town It was agreed to temporarily remove the bins on Castle Street and monitor this location.
    - 9.4.2 Welcomed the plans and proposals for the People's Park to make it more attractive as an amenity.
