5 Presentation from the National Transportation Authority by Ms. Anne Graham CEO and Mr. Hugh Creegan, Deputy CEO

Ms. Anne Graham, Chief Executive Officer, National Transportation Authority (NTA), accompanied by Mr. Hugh Creegan, Deputy Chief Executive Officer, made a presentation to the meeting outlining: the role and range of functions of the NTA; the Greater Dublin Area Transportation Strategy; the spatial planning framework; the future of the Navan rail line; future public transport provision; park and ride facilities; low emissions vehicles; walking and cycling infrastructure - investments in Meath; the DART Extension; accessibility of public transport; the bus fleet and bus stops; rural services; and future transportation challenges.

There was an extensive debate with the following members making contributions: Councillors: Tommy Reilly; Alan Tobin; Mike Bray; Noel French; Nick Killian; Gillian Toole; Sharon Tolan; Gerry O'Connor; Tom Behan; Darren O'Rourke; Maria Murphy; Joe Fox; Paul McCabe; Alan Lawes; Joe Bonner; Ronan Moore; Johnny Guirke; Damien O'Reilly; Yemi Adenuga; Sarah Reilly; Conor Tormey; and Emer Tóibín. Comments and questions focused on the proposed review of the rail line to Navan; the operation of bus services and certain routes in the county, including reliability and connectivity issues; the public transport fare structures; the need to revise the map of the Greater Dublin Area for transportation planning purposes; the need to have a joined-up approach to all public transport modes, including a joint marketing plan; the capacity and suitability of the bus fleet; the location and provision of bus stops; park and ride facilities in the county; and the provision of cycling infrastructure and facilities. The NTA representatives provided responses and clarifications and noted some of the issues raised for future response.

7 Reports

Chief Executive's Report 7.1

Clarification was sought by Councillors Nick Killian; Sharon Keogan; Gillian Toole and Paul McCabe on a number of matters in the Report. The main issues focused on:

Housing – Delivery in 2019; availability of land for future own-build housing; reasons for emergency accommodation provision; update on housing development in Athboy;

Planning – public display of draft County Development Plan;

Community – Roll out of Walkability Audits in Ratoath and Dunshaughlin;

Environment – Illegal Dumping; Quarrying; Dog Breeding.

Responses and clarifications were provided on the issues raised by the Management Team.





7.2 Report from the Corporate Policy Group

The Meetings Administrator advised that the Corporate Policy Group reviewed the agenda for the full Council meeting and received information on the particulars of some items. The CPG received a report from the Housing SPC, which had considered a motion referred to it by the Council in September 2019. The SPC recommended an amended motion which the CPG agreed be put to the Council for approval as follows:

"That the council writes to the Minister for Justice and Equality Charlie Flanagan T.D. and the Minister of State for Justice at the Department of Justice and Equality with special responsibility for Equality, Immigration and Integration David Staunton T.D., calling for the full implementation of the recommendations of the Working Group to Report to Government on the Protection Process on Improvements to the Protection Process, including Direct Provision and Supports to Asylum Seekers i.e. the McMahon Report 2015."

This was approved by the Elected Members.

7.3 Report from the Protocol Committee

The Meetings Administrator gave a summary of items discussed by the Protocol Committee, including: agreement on presentations by SIPTU and National Broadband Ireland, in advance of scheduled Council meetings in 2020. The Committee also agreed in principle to hold a civic event for retired Bishop Michael Smith and approved the list of attendance at conferences and training events under Section 142(5) of the Local Government Act 2001.

9 **Notice of Question**

9.1 Submitted by Councillor Deirdre Geraghty-Smith

"To ask the Chief Executive to confirm whether Meath County Council is implementing the All Ireland Pollinator Plan and the National Biodiversity Action Plan; and to provide a description of the specific current and planned actions, to implement these plans across the County; recognising the significant role of pollinators in promoting biodiversity and protecting the local eco-system."

Response:

Meath County Council has not as yet signed up as a partner of the All Ireland Pollinator Plan 2015-2020 however arrangements are being made to do so as the Council recognises the important service that pollinators provide, is developing and supporting pollinator friendly actions in towns and villages throughout the County, and particularly with regard to measures which serve to reverse the decline in the amount of food such as wildlife flowers, and safe nesting sites in our landscapes.

Pending this however it is pointed out that the Council is involved in various actions associated with pollination and Biodiversity Action Plans including:

- Pollinator training for staff of Meath County Council was provided in April 2018 by Biodiversity Ireland, arising from which a pollinator friendly area was developed at Buvinda House. A further pollinator area is proposed at the rear of the building, including a herb garden
- A biodiversity workshop for Community Groups was held in Buvinda House in 2018 and a separate bumble bee monitoring workshop was also held
- Community Biodiversity Action plans have been developed for seven Town /Villages in the County and they contain many actions which support pollinators
- Meath recently hosted the All Ireland Tidy Town Forum and a specific presentation was made on the National Pollinator Plan
- An area within the recently developed Derrockstown Burial Garden near Dunshaughlin is to be reserved as a pollinator friendly area
- The Council's draft Climate Action Strategy also strongly supports biodiversity including • pollinator friendly actions in public recreational spaces





- The Council gave away 1,000 native saplings to community groups and individuals as part of National Tree Week in April. This initiative promotes the growth of trees and encourages pollinating insects in private gardens throughout County.
- The Council, in 2018, in association with the National Tree Council of Ireland, distributed Mountain Ash and native woodland trees to 65 Schools in the county and created a video on tree planting techniques, which was distributed to each school.
- The CEAF (formerly Local Agenda 21) Fund for 2019 specifically targets projects which promote Biodiversity and Climate Action.
- A community biodiversity workshop on pollinators and citizen science was held in Buvinda House on November 23rd 2019.

Mr. Kevin Stewart, Director of Services, informed the meeting that the Council had recently signed the Pollinator Plan. Noted by the Elected Members.

"What are the Housing Rent collection percentages for Meath County Council for 2017 and 2018?"





Response:

The rental income collection percentage in Meath for 2017 and 2018 is 89%, which is above the national average of 86%. Arrears have reduced year on year from €1.6m in 2014 to €1.2m in 2018, a reduction of €0.4m. During 2019, the Rents Section of the Council continued to place a greater emphasis on problem cases and early intervention. A considerable body of work continues to be carried out through the Mortgage Arrears Resolution Process (MARP) with regards to shared ownership rent arrears, and it is anticipated that this work will continue to bring further improvements in collection yields.

9.4 Submitted by Councillor Darren O'Rourke

"To ask the Chief Executive to provide a report on the financial cost to the Council to remove illegal dumping for each year since 2014; and if she will make a statement on the matter?"

Response:

Illegal dumping is a problem for many areas across the country including parts of County Meath, varying in volume from a single black bag of domestic rubbish to truck loads of rubbish. The depositing of large amounts of rubbish is often associated with isolated rural areas and in some of the most scenic and frequented areas. Locations that are prone to illegal dumping are affected both on a visual and environmental level.

As shown in the following table the costs associated with the removal of illegally dumped waste and litter control by Meath County Council is very significant:

The disposal of rubbish in any area of land without approval, permission, or which does not have a waste license is illegal and a criminal offence, punishable by fines from €150 up to €10 million upon conviction and 10 years imprisonment, or both. Where Meath County Council finds material that is illegally dumped and establishes the identity of those responsible, such persons will be subject to enforcement proceedings and with the main objective of having the illegally dumped material removed to an authorised facility and the environmental risk eliminated.





One of the major problems in relation to illegal dumping/fly-tipping is householders and businesses handing over their waste to unauthorised door-to-door waste collectors. In this regard, Meath County Council initiated a major campaign last year to encourage households not to give their waste to these 'man in the van' type operators – this campaign has proved to be quite successful in that the number of such operators advertising on social media has significantly reduced.

There are many other initiatives being undertaken at local and national level in an effort to address the problem that is illegal dumping. These include:

- Co-ordination of national waste enforcement priorities between the local authorities, the • Waste Enforcement Office etc in tackling (1) significant illegal waste activity, (2) the unauthorised disposal of construction and demolition waste, (3) end of life vehicles, (4) compliance with waste collection permits and (5) multi-agency responses to sites operating without authorisation.
- Participation in an anti-dumping initiative was introduced by the Government where local authorities and community organisations identify problem areas, develop enforcement responses and carry out clean-up operations.
- The adoption of Household Waste Presentation Bye Laws which are primarily intended to give additional powers to Local Authorities to target persistent offenders who do not have appropriate arrangements in place for waste disposal
- An increase in the use of Technology such as CCTV, Drones and wildlife cameras in detecting and preventing illegal dumping
- An ongoing Education and Awareness programme which includes extensive social media postings, billboards, local newspaper press releases, etc.
- The holding of free bulky waste days across different waste streams which otherwise might end • up being illegally dumped for collection by the Council.
- Utilising preventative measures installation of signage and fencing.

Notwithstanding the challenges highlighted above in tackling a problem that has existed for generations and affecting every local authority area, it is considered that the mixture of enforcement, education and awareness and collaboration with community and voluntary groups is proving effective in the fight against illegal dumping, while acknowledging such efforts alone may not deter the small minority who choose to continue to illegally dump.

"Could Meath County Council confirm the number of properties in Meath that are currently available to rent under Airbnb; how many of these properties are being rented for less than 90 days and have registered for exemption with us, their local authority; how many of these are properties that are being rented more than 90 days and have applied for planning permission for a change of use; and if there are currently any properties in Meath that are year-long short-term lets and therefore prohibited in Meath due to our Rent-Pressure Zone status?"

Response:

Meath County Council does not have a record of the number of properties available to rent in Meath on Airbnb or any similar websites. Since the introduction of the Short Term Letting legislation, 12 properties in total have registered with the Council. 7 notifications referred to home-sharing and the remaining 5 referred to short-term letting. Meath County Council currently has no enforcement cases in relation to the practice of unauthorised short-term letting.

Notice of Motion 10

10.1 Submitted by Councillor Mike Bray

"That Meath County Council supports the introduction of reverse vending recycling machines in towns and villages across the county such was launched in Carrickmacross, Co. Monaghan recently; and engages with local communities and Tidy Towns groups to optimise the introduction of these machines."

Supporting Information subject to the motion being proposed, seconded and considered.

The reverse vending machine, which allows people to recycle plastic bottles in return for vouchers, was recently launched in Carrickmacross and being the first location in Ireland where such a machine has been introduced.

The Department of Communications, Climate Action and the Environment while noting, the details of this particular initiative in testing the viability of a deposit return scheme in a very localised basis, point out that they have commissioned a review to establish the best way to reach a 90% collection target for beverage bottles, including examination of a deposit and return scheme and will consider the outcome of this review and any necessary actions from it, once completed.

The Council will monitor the outcomes of the Carrickmacross initiative which is a litter prevention model for plastic bottle litter, and while we are willing to work with Tidy Towns or other such groups in any initiatives to prevent littering and promote recycling, we will await the outcome of the Departmental review which it is understood will take into account current Repak Initiatives, the





kerbside collections and operations as well as, the wide network of Civic Amenity Sites and Bring Banks throughout the Country.

There were interventions from Councillors Ronan Moore; Joe Bonner; Paul McCabe; and Alan Tobin and clarifications from Mr. Larry Whelan, Senior Executive Officer. The supporting information and the motion, proposed by Councillor Mike Bray and seconded by Councillor Paul McCabe was agreed.

10.2 Submitted by the Fianna Fáil Group

"That Meath County Council takes the lead in harnessing the potential of our county's hedgerows by encouraging and supporting the planting of native Irish trees, as these are the best placed to thrive and survive in Irish conditions and help offset some of the greenhouse gas emissions that are produced through our day to day activities. Further, that Meath County Council should make a concerted effort to only plant native Irish trees and plants."

Supporting Information subject to the motion being proposed, seconded and considered.

Hedgerows, along with the trees within them, are a characteristic feature of the landscape of Meath. The County Meath Tree, Woodland and Hedgerow Survey (2011) estimated that there are over 22,000 kms of hedgerow in the county; which equates to an average of 9.5km of hedgerow per square kilometre of land. Hedgerows provide food and shelter to a wealth of wildlife including small mammals, numerous birds and invertebrates. As linear features, hedges provide corridors for wildlife to move across the landscape. Trees produce oxygen, clean the soil and air, control noise pollution, act as carbon sinks thus reducing greenhouse gases, regulate temperature, help to control erosion and flooding and are important for their amenity and aesthetic value. Meath hedgerows are old – over 80% are shown as field boundaries on maps from the 1840s, and many are likely to be much older than that. At least 36 species of trees and shrubs can be found in County Meath hedgerows.

The protection and conservation of plants, animals and wildlife habitats is enshrined in European and national legislation, this extends to trees and hedgerows. It is also government policy as set out in the third National Biodiversity Plan 2017-2021 and is an objective of the County Meath Biodiversity Plan 2015-2020. Natura 2000 sites (i.e. Special Areas of Conservation (SACs) and Special Protection Areas (SPAs)) form part of a network of ecologically important sites to protect and conserve species of importance in a European Union context.

Meath County Council recognises the values of our native tree, hedgerow and woodland resource:

• The County Meath Development Plan 2013-2019 contains a number of policies and objectives to support the sustainable management of Meath's hedgerow resource and to support the





retention of existing trees and hedgerows, and planting of native hedgerows (where required) through the Development Management Process

- Through the implementation of the County Heritage Plan and County Biodiversity Plan, the • Council has organised a number of community biodiversity workshops and provides resource material to the public to encourage the planting of native trees
- Meath County Council participates each year in National Tree Week and encourages Tidy ٠ Towns, community groups and individuals to plant native trees and distributes large numbers of trees
- Training courses on biodiversity have been delivered to Local Authority staff and further • workshops are planned for December 2019 and early 2020
- Meath County Council through its partnership in the implementation of the All Ireland • Pollinator Plan will take a number of positive actions to enhance the local landscape for pollinators
- As part of the Council's commitment to climate action, next year the council will look to identify small land parcels of Council owned property which would be suitable for planting native trees and creating biodiversity areas. We will also explore options for partnerships in this area where we might benefit from funding.

There were interventions from Councillors Alan Tobin; Gillian Toole; Paul McCabe and Mike Bray. The supporting information and motion, proposed by Councillor Damien O'Reilly and seconded by Councillor Tom Behan, was agreed.

"Meath County Council recognises the huge contribution low paid workers make to the Irish economy and calls for the implementation of a Living Wage to end in-work poverty and reduce the financial pressure on many households and also calls on this Council to become a Living Wage employer, by ensuring every worker employed by the Council earns at least the Living Wage of €12.30 per hour."

Supporting Information subject to the motion being proposed, seconded and considered.

Local authority staff pay-scales are set by Department of Housing, Planning & Local Government circular. The HR Department can confirm however that Meath County Council posts currently have pay-scales where earnings are no less than €12.30 per hour.





The supporting information and motion, proposed by Councillor Johnny Guirke and seconded by Councillor Edward Fennessy, were noted.

10.4 Submitted by Councillor Ronan Moore

"That Meath County Council undertakes a gender pay review and implement any recommendations from such a review, in as timely a manner as is possible."

Supporting Information subject to the motion being proposed, seconded and considered.

The 'Gender Pay Gap' is the aggregate difference between what women are paid compared to men. In March 2019 the government announced cabinet approval for a number of measures to promote greater gender equality including the 'Gender Pay Gap Information Bill' which, when enacted, will require companies or organisations to publish information in relation to the difference between the mean and median hourly pay of male and female employees. The Local Authority Sector, including Meath County Council, will comply with the relevant requirements as in year one the regulations will apply to organisations of 250 or more employees. The sector, including Meath County Council, awaits clarification as to the requirements of the forthcoming regulations.

The supporting information and motion proposed by **Councillor Ronan Moore** and seconded by Councillor Alan Lawes, were noted.

"That Meath County Council does all in its power to ensure that the Doctor on Call service remains located in Navan."
