- St Francis Park Departmental approval of €2,856,336 had been received for the refurbishment of St Francis Park Halting site. Documentation for Part 8 Design process has been prepared. Further clarifications are required prior to Departmental Stage 2 approval to proceed to Part 8.
- <u>Alverno Court</u> Part 8 Planning Permission is in place. Project scope has been revised and the total estimate of the all in cost currently stands at €4,807,972. Budget approval from the Department has been increased from €3,458,329 to €4,150,329, with self funding also to be provided in order to advance the scheme to the next stage. Planning

Planning Applications

The number of applications received in the period 01.01.2019 to 19.11.19 was 1544 in comparison to 1372 received in the same period last year.

Development Contributions

Development Contribution receipts up to the end of October 2019 were €9,082,902 compared to €12,168,307 in the same period last year. (Figure is inclusive of Irish Water receipts)

Draft Meath County Development Plan 2020-2026

The Draft Meath County Development Plan 2020-2026 will go on public display for a period of 10 weeks from 18th December 2019 to 6th March, 2020. This period includes additional days for Christmas.

Community

Local Community Development Committee (LCDC)

Next meeting of the LCDC will take place on Friday 29th November 2019.

LEADER Programme 2014-2020

The next meeting of the LAG is scheduled for Friday 29th November, 2019.

Local Economic Community Plan (LECP)

Continue to liaise with agencies and partners to progress actions within the LECP with quarterly reports presented to the LCDC meetings.

Age Friendly County Initiative (AF)

- Two Walkability audits were held in Enfield and Summerhill with the Community involved. Details from the walks are being collated and discussed with the area engineer for next steps.
- The Age Friendly Alliance launched an awareness of the "Message in a Bottle" for older persons at the Flexibus annual Celebration Day with up to 600 older persons present.
- The Age Friendly Recognition awards were held in Croke Park in November with 2 projects shortlisted. The Acorn Tablet pilot won its category with Prosper Kells walkability receiving a shortlisted award in its category.
- Two Age Friendly projects Athboy Walkability and Age Friendly Shared Service are shortlisted under the "Innovation in Politics" awards being held in Berlin on December 4th.

Joint Policing Committee

The next JPC Meeting is scheduled to take place on Monday 9th December 2019. Commissioner Drew Harris is scheduled to attend this JPC Meeting. All Elected Members are invited to attend.

Public Participation Network

The re-registration process has improved the quality of contact information and effectiveness of communication. The Community Well Being Vision process is continuing with new workshops planned for January 2020. The Resource Officer is working on strengthening links with community groups and networks. A national review of the PPN structures is planned for early 2020.

Pride of Place

The County awards took place in the Solstice Arts Centre, Navan on Thursday 7th November, 2019. Gluais who performed from Scoil Mhuire, Trim were a big hit on the night.

The Co-operation All-Ireland Pride of Place awards are being held in Kilkenny on November 30th with 3 groups entered for Meath.

The Community Grant Scheme

The Community Grant Scheme claims are being processed as they are received and a final call for the submission of grant claims issued to the applicants of outstanding claims.

The Community Amenity Project Scheme

Details were presented to the Full Council at the November meeting and all applicants have been notified if they were successful or not.

Regional Festivals & Participative Events

A Fund of €11,000 provided by Fáilte Ireland and administered by Meath County Council to 9 qualifying applicants. Funding is being paid following receipt of claims from the applicants.

CLÁR

Funding was approved by the Department of Rural & Community Development for two projects. Works will commence shortly on these.

Carranstown Grant Scheme

A meeting of the Liaison Committee took place on 6th November, launching the next funding round for the Indaver Community Grant Scheme. Indaver's 10 Year Commemorative plaques were awarded to 6 groups at a photo-call which was held prior to the committee's meeting.

Knockharley Grant Scheme

Works are currently ongoing on the Kentstown Village Project which involves the creation of green space, football pitches, parking area and changing rooms. Next meeting scheduled for 16th December.

Town and Village Renewal Scheme

Works on-going by the groups under the 2018 scheme and must be completed by April 2020. The following six projects were approved under the 2019 scheme by the Department of Rural & Community Development, totalling €585,792- Ballivor, Kilbeg, Summerhill, Wilkinstown, Nobber and Kilmainhamwood.

Healthy Ireland Fund (HIF) scheme

New HIF Round 3 announced and will run from 1st July 2019 to 30th June 2021, 4 projects have been selected by the LCDC and have been submitted to Pobal for approval. Additional funding was awarded by the Department of Health for a Mental Health theme, 3 projects under this theme have also been submitted to Pobal for consideration. Assessments are currently being undertaken and approval is due shortly.

Outdoor Recreation Infrastructure Scheme

Seven applications were submitted to the Department for consideration. Three projects under Measure 1, three projects under Measure 2 and one project under Measure 3. An announcement of successful projects for the 2019 scheme is awaited.

Community Enhancement Programme

Meath's allocation under this programme is €163,835.00. The LCDC approved 52 grant allocations and 18 Men's Shed's applications. All works must be completed and claimed by year end. Claims are being paid out once received.

National Broadband Plan

The contract between the Government and National Broadband Ireland (NBI) was signed on the 19th November 2019. The majority will be connected using a fixed Fibre to the Home network running over open eir and ESB's existing pole and duct network. NBI will also have responsibility for maintaining and improving the network over at least the next 25 years. NBI have contracted a network design company 4Site to carry out surveying work on the existing networks. The Meath County Council Broadband Officer and MD Engineers will be informed when crews are working at locations in the county.

The first phase of the rollout will be the connection of over 300 Broadband Connection Points (BCP) nationally. 12 locations were identified in Co. Meath for a BCP. The Council has to confirm full agreement with the locations and is awaiting the revised Service Level Agreement from the Department of Rural & Community Development.

Six locations have expressed a strong commitment to be part of the BCP project these include: Culmullen Community Hall, Teach Raithneach Heritage & Cultural Centre, Meath Hill Community Centre, Cormeen Sports Complex, Rathkenny Hall and Castletown GAA Club. Discussions are ongoing with the other four locations and one or two will need to be replaced.

Telecommunications Action Group

Meath County Council hosted the Department of Rural & Community Development and Broadband Officers monthly meeting on the 15th November in Kells Tech Hub. The Broadband Officers were very impressed with the facilities that the county has developed to support new businesses and remote workers.

Presentations covered subjects including the proposed NBI website, COMREG's role on EMF testing, Meath Enterprise and NECEC Strategies, 254 Licencing and the Acorn Tablet Pilot.

Arts

Toradh Gallery Ashbourne

Solo Exhibition – *Places, Histories and Other Matters*: a solo exhibition by Helsinki based Meath artist Jane Hughes. Originally from Navan, Jane has worked internationally as a visual artist, curator and educator in Germany and Finland for over a decade. Jane's work relates to social history and is largely researched from old photographic sources. Featuring a series of 18 painted works, Places, Histories and Other Matters is on display at Toradh Gallery in Ashbourne Library and Cultural Centre from November 18 and will remain until January 10, 2020.

Toradh2 Gallery Kells

Kells Photography Club: *Meath Through the Lens*. An exhibition of work by 22 photography enthusiasts from the region. This exhibition presents a selection of images examining a common theme: *Meath through the Lens*. Each photographer approached this theme in a unique and special way. Runs until January 2020.

Festivals

Teenage Dreams Youth Film Festival Run in partnership with Guth Gafa International Documentary Film Festival and Maynooth University, the Teenage Dreams Youth Film Festival saw a number of documentary film screenings take place at the Courthouse, Kells. Six schools and 290+ secondary school children attended the screenings and took part in the Q&A and discussion sessions afterwards.

The Cultural Hub at the Courthouse Kells hosted the MCC Environment Section *Rubbish Film Festival Hinterland/Boyne Valley Flavors Samhain Festival* with ten events taking place over the weekend.

<u>Awards</u>

The Professional Artists Development Fund Phase 2 instigated with funding support from Creative Ireland. The Centre Cultural Irlandais Paris/Meath County Council International Residency Award has been agreed for 2020/21 as per the County Arts Development Plan. Scheme advertised, closing date January 8th 2020.

Kells Creative Placemaking Project:

Presentation made to Kells MD November meeting to update members on the Kells Creative Placemaking Project. The Kells Creative Placemaking RRDF Round 2 Category A Funding secured towards the development of Kells Printworks and Typography Centre and completion works on the Courthouse as a Cultural Hub. Consultant appointed to write the business and operational plans for the Kells Creative Placemaking Project.

Economic Development

Business Advice Sessions

23 Business Advice sessions were undertaken during November.

Mentoring

6 mentoring assignments commenced in October.

Training

55 participants took part in LEO training over November, with participants on various courses.

Online Trading Vouchers

3 Trading Online Vouchers (TOVs) were approved during November.

BREXIT Preparatory Programme: LEO Meath Outreach Programme - Oct 2019

BREXIT Customs Training Workshops – 5th November in City North with 11 businesses in attendance. These practical customs workshops provide an overview of the additional documentation and procedures needed, following Brexit. The practical course content also includes understanding of how to start the import/export journey; understanding customs basics; customs declarations; additional customs facilitations; Customs Duty Reliefs; AEO/Trusted Trader and Industry Specific Issues.

LEO Meath Client Engagement Offering – This project is on-going. 30 LEO Meath grant-aided clients are taking part in a programme of intensive mentoring to develop a strategy plan for their business. The deadline for submission of plans and final reports from the mentors is Friday, 13th December. Enterprise Ireland has provided a €50,000 budget to deliver this project to assist businesses to prepare for the impact of BREXIT.

LEO Meath 2020 Training Schedule:

The 2020 Training Schedule has now been agreed and dates set for all management training for the coming year. The brochure is currently being compiled and will go to print shortly. Details of all courses will be posted on the LEO Meath website before the end of the year.

EEN Meet The Buyer Event – 21st November

The Enterprise Europe Network, in conjunction with the Local Enterprise Offices and Invest NI, hosted a Food EirEEN, a food "Meet the Buyer" event which offered participants the opportunity to engage in face-to-face sales meetings with senior food buyers from throughout Ireland and the EU. The event which was held in the City North Hotel on Thursday, 21st November, was attended by many of our food producers from the Boyne Valley and staff of the Local Enterprise Office.

Innovate Accelerate Programme

The InnovateAccelerate Europe Programme aims to increase the innovativeness and thus the competitiveness of companies in the region by helping them to plan a pathway to the internationalisation of their businesses. The programme is a joint initiative between Meath, Louth and Newry & Mourne District Council. It is imperative that companies in this region build new business relationships in markets other than Northern Ireland, the Irish Republic and Britain in order to survive Brexit.

The focus of InnovateAccelerate Europe is on accessing current, real world business opportunities in European markets. Each participating business is receiving individually tailored support to help them identify new business collaboration opportunities. InnovateAccelerate Europe's combination of mentoring support, networking, greater access to information and resources, upskilling to take advantage of the opportunities afforded by IT and links to third level educational establishments and the technology sector as well as B2B linkages offers businesses in the east transfrontier region a significant opportunity to develop, diversify, innovate and compete more effectively in international markets.

We have recruited 21 SMEs from the Newry Mourne Down/Louth/Meath transfrontier region to participate on a business opportunity mission to Berlin where they will have the opportunity to engage with potential partners.

Public Libraries

Facebook - Donation

The library service has received a donation of €29,000 from Facebook to develop and introduce a new initiative in the area of Science, Technology, Engineering, Arts and Maths ("STEAM"). The funding will be used to purchase a pilot collection of STEAM backpacks for all 12 branch libraries in Meath. These backpacks will then be made available for loan to children aged 3-6 years.

Family Time

Branch libraries will be hosting a range of events this December as part of the initiative which aims to:

- support a family-focused approach to reading with children as part of the national Right to Read programme:
- increase awareness of the benefits of reading and promote reading as a fun, recreational activity for children;
- increase awareness among parents and families of services and resources for children in public libraries and support further engagement between users and library staff.

Decade of Centenaries

The Sack of Trim, September 1920

IRA activity, for much of 1919, involved capturing weaponry and freeing republican prisoners, while the Dáil set about building a state. In September, the British government outlawed the Dáil and Sinn Féin and the conflict intensified. The IRA began ambushing RIC and British Army patrols, attacking their barracks and forcing isolated barracks to be abandoned. As part of that campaign Trim RIC barracks was raided by local Republicans and arms were taken. The reprisal for this action came in late September 1920.

A publication to commemorate the centenary of the burning of the town of Trim by members of the Black & Tan force on 26 and 27 September 1920 will be published in 2020. The book will reproduce facsimiles of original courts martial and prison documents, contemporary newspaper accounts, stills of contemporary newsreel footage, and rare photographs of the town in the immediate aftermath of the burning.

Climate Action

The library service is exploring the possibility of lending home energy saving kits to the public in partnership with the Climate Action team. This follows on from the OWL Energy Saving Monitors which the library service has being lending to the public since 2011.

ENVIRONMENT, WATER SERVICES, FIRE AND EMERGENCY PLANNING

National Waste Enforcement Priorities 2020

The National Waste Enforcement Steering Committee has agreed the following as being the priorities for 2020:

- Tackling significant illegal waste activity including unauthorised operators, skip hire companies and man in the van activities.
- Construction and Demolition Activity unauthorised disposal of C & D waste
- End of Life Vehicles inspection of both authorised ELV sites and unauthorised operators.
- Waste collection Household & Commercial including roll out of brown bins.
- Multi Agency Sites of Interest where there are reasonable grounds to believe that there is ongoing
 illegal activity.

Climate Change

Further actions from the Climate Action Strategy launched in September were initiated in recent weeks following on from those highlighted in previous Chief Executive's reports.

- Further communication with the various stakeholders involved in the Sustainable Energies Community (SEC) project for Batterstown a number of other towns in the County have expressed an interest in developing similar plans for their area.
- Support for the National smart metering project as part of the National Climate Action Plan. ESB
 Networks has recently commenced a major meter replacement programme, which will result in the
 upgrade of 2.4 million electricity meters to modern smart ready digital technology.
- Officials from the Council attended the Youth Forum on Climate Change in the Dáil on the 15th November – children in the age group 10-17 presented their proposals to Minister Bruton.
- Officials attended Stamullen National School as part of the roll out of Climate Action awareness training
- Planning has commenced for a schools event at local level along the lines of the RTE Youth Assembly, where students will debate on climate action, develop robust actions, vote on these and establish a Climate Action Charter that they can bring back to their school.
- The Chair of the Environment SPC and three other elected members were invited to attend a Climate and Biodiversity Action Workshop for Councillors in Wood Quay on the 4th December 2019

National ambient Air Quality Monitoring Programme 2017 - 2022

The EPA in 2017 published the National Ambient Air Quality Monitoring Programme 2017 - 2022 to provide an expanded national monitoring network of enhanced real time information on air quality to the public. The programme provides for an additional 38 new monitoring stations in all urban areas, the siting of which will be based on the criteria of population size, vulnerability to air quality issues and spatial distribution. The network of sites will monitor a range of specified air quality parameters including particulates, heavy metals, inorganic and organic gases.

A new monitoring station for Navan in close proximity to the Fire Station has now been put in place and providing enhanced real time information on air quality for the area. New monitoring stations are also proposed for Drogheda and Balbriggan

Green Schools

A Green Schools Seminar for all schools in Meath took place in Buvinda House in November. The An Taisce Green Schools team were on hand to assist schools in rolling out their environmental programme across a range of themes – Litter and Waste, Energy, Water, Biodiversity, Travel, Global Citizenship.

Really Rubbish Film Festival and Guth Gafa

10 Meath Secondary Schools showed their movies at the Guth Gafa Documentary Festival in Kells in November, with themes such as climate action and biodiversity. The schools also took part in the Meath County Council Really Rubbish Film Festival in 2018/19, where Colaiste Na Hinse Bettystown and St Patricks Secondary School Navan were declared the winners.

National Food Waste Recycling Pilot - Trim

Meath County Council is supporting a collaborative Food Waste Recycling Pilot project with Cre (the Composting and Anaerobic Digestion Association of Ireland) and the Irish Waste Management Association, with the objective of addressing barriers to householders using their Food Waste bin effectively. Three pilot towns have been selected for the project including Trim with staff calling to households to explain the objectives and to distribute householder packs including kitchen kaddies and sacks to the households who agree to participate in the pilot project.

The project got underway in November and will run over a 6 month period.

ReLove Fashion

The aim of the initiative is to encourage young people to develop an understanding of the challenges which 'Fast Fashion' create in terms of damage to the environment, and to find new ways to upcycle existing fabrics and textiles.

The Regional Final took place in the Rediscovery Centre in November where four Meath Schools took part.

Community Environment Action Fund (previously Local Agenda 21)

The Local Agenda 21 Environmental Partnership Fund (LA21) which has operated since 1997, promotes sustainable development by assisting small-scale environmental projects at local level. The Scheme has been renamed the Community Environment Action Fund from 2019 onwards.

The projects involve partnership arrangements between local authorities and various local groups including community groups, schools and environmental NGOs and for this year's scheme there is a particular emphasis on projects which target Climate Action and Biodiversity A total of 50 applications were submitted, involving 75 projects, of which 36 were approved for funding.

River Basin Management Plan 2018 -2021

The River Basin Management Plan 2018-2021 was launched on the 17th April 2018 and outlines the measures the State and other sectors will take to improve water quality in Ireland's groundwater, rivers, lakes, estuarine and coastal waters over the next four years. The 726 water bodies including 9 in County Meath form part of a total of 190 Areas for Action which have been prioritised nationally for particular attention

A regional integrated Catchment Management Programme for the Midlands and Eastern region was published earlier in the year and setting out the areas pritorised for action and the schedule for commencing works by recently established Catchments assessment teams. Public consultation is a key feature of the programme in advance of any works being undertaken and to date public consultation evenings have been held in respect of proposed works for the Kilmainham Dee & Moynalty Rivers and the Boycetown River near Dunsany/Kiltale the River Inny /Lough Sheelin catchment, the Broadmeadow Cathhement in Ashbourne, and the River Tolka in south east Meath.

<u>Provision of Slipways – River Boyne and Blackwater</u>

An Bord Pleanála by order dated 26th November 2018 approved the planning application and the Natura Impact Statement (NIS) for the provision of the boat slipways and construction of access thereto on the River Boyne and River Blackwater. Construction work on the 5 slipways commenced in early August and is now substantially complete.

Draft Beach Management Plan

At the February Laytown Bettystown Municipal District meeting, members agreed to accept the findings of the draft plan and recommendations there from, and noting that the specific provisions from the Natura Impact Statement relating to dogs on leads and horses will require revisions to the 2010 Foreshore Bye Laws. The proposed revisions were placed on public display from 19th July 2019 to 30th August 2019.

A number of suggestions contained in the submissions will be the subject of discussion with the appropriate bodies and a report will be prepared and considered at MD level.

The Council is preparing the Part 8 planning application for the development of a Seafront Building and Civic Plaza at Seaview Terrace, Bettystown i.e. on the site of the terraced houses at the beach entrance. It is intended that the Building will house the Lifeguards, Beach warden and other services. A consultation with local stakeholders was held in Bettystown in mid August, when some very constructive ideas and suggestions were put forward for consideration. It is hoped to commence the statutory Planning/Part 8 process early in the new year.
