Councillors also welcomed the recent launch by Fáilte Ireland of 'Ireland's Ancient East', the new "touring region" that includes several Meath sites. Councillors pointed out that other counties are promoting their own counties whilst Meath is part of the Boyne Valley brand. It was agreed to raise this at the May Meath County Council meeting, when Meath Tourism was due to deliver a presentation.

4 To receive a presentation from Mary Murphy, Meath Local Sports Partnership - Overview of the LSP.

Mary Murphy, Meath Local Sports Partnership (MLSP) delivered a presentation to the meeting that provided an overview of MLSP, its structure, funding, activities and key events planned.

Matters raised by the Councillors included:

- The hugely positive progress made by MLSP and the physical and mental health benefits accruing to the citizens of Meath;
- The consideration of increased support by Meath County Council as part of the budgetary process;
- The possibility of developing further linkages with health service providers within the community;
- The use of school facilities during the summer months.
