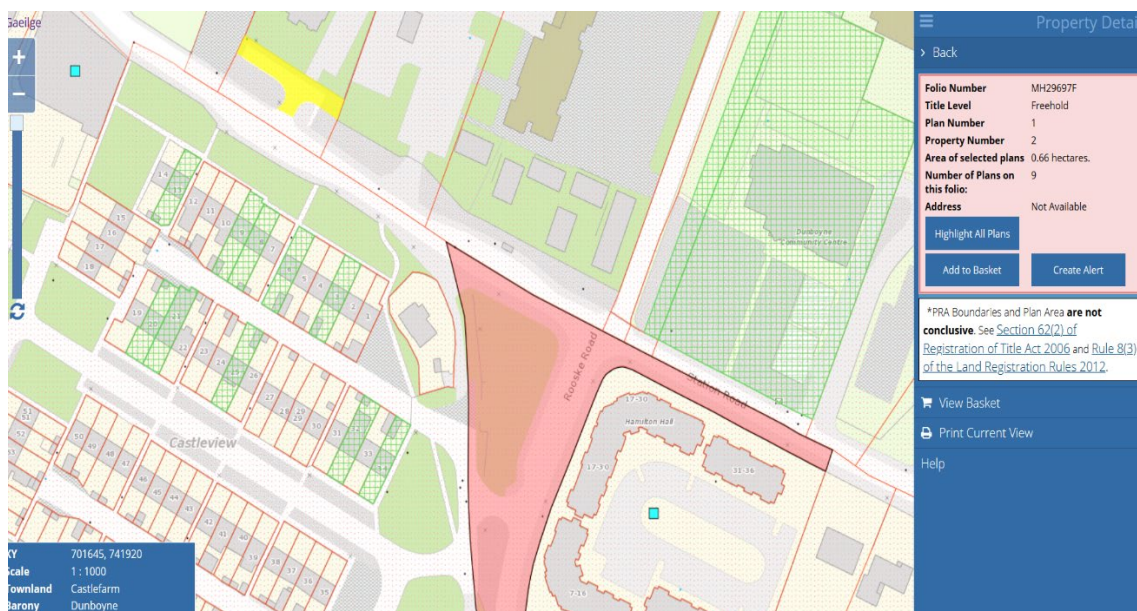

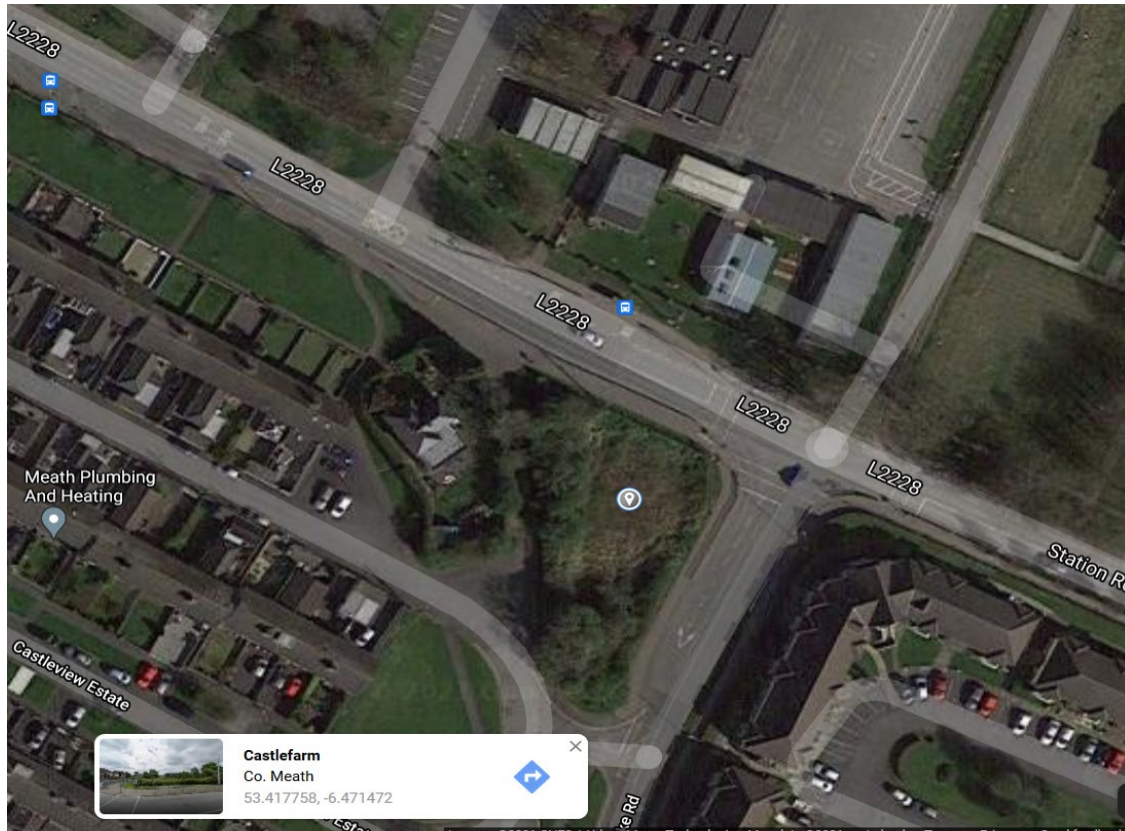
6.1 Submitted by Councillor Damien O'Reilly
