	March 2020 MCC Meeting – Cllr E Toíbín "That speed ramps and flashing lights are installed approaching the drop off and collection points of all country schools across Meath where levels of speeding endanger children trying to gain access to their school and where to date they have not been installed despite ongoing calls from overwrought parents and teachers." It was noted that this motion had been discussed at the July SPC meeting and it had been agreed to reflect on what was discussed and to discuss it again at the meeting today. It was noted that the Council is very active on works for school safety but that one solution does not fit all the issues at schools. A list of direct and indirect works carried out at 25 schools was presented to the meeting.
	The members raised the following - Safety issues at various schools. - Some schools not included on list incl. Lismullen, Dunsany and schools in Kells MD. - Why existing safety measures such as signage and flashing lights are not

- If raised tables are the most effective measure then it should be first method used.
- Can provision of Vehicle Activation Speed signs be managed centrally rather than at MD level.
- Children cannot walk to school.
- Provision of reflectors on ramps/why are there no reflectors on existing ramps.
- Lack of footpaths & set down zones are the biggest issues Why is planning permission granted for schools without footpaths /drop off areas. Pressure should be applied to Dept of Education at application stage to ensure these elements have been addressed
- Cars parking on both sides of road at schools.
- Department of Education should be providing funding towards any required measures

The following responses were made

- Noted that there was a planning permission for works at Lismullen School and that some parking would be made available on the southern side of the school. Road Markings at the school had been refreshed and hedging cut back The issue at Lismullen may be public lighting.
- Underlying problem at schools is no set down area provided.
- Noted that there was a lot of contact with the schools through the Road Safety Officer.
- The SPC has adopted a policy on Vehicle Activated Signage. Traffic signs manual outlines where signs can be located. The TII are carrying out a review of where signs can be located.
- The provision of Vehicle Activated Signage can be raised with the MD engineers to ensure a consistent approach.
- Triangular markings on ramps are used for surfaces facing drivers. Reflective materials used to help with visibility.
- Warning signs are erected for ramps. A certain level of lighting is required from a safety perspective
- Some off road parking is to be provided at Rathmore school.
- Temporary accommodation at Dunsany school off road parking at church next to school.
- Works on path to Educate Together Secondary School at Colpe Road have commenced.
- Agreement from TII required for works on a National Road.
- Noted the recommendation from the meeting that raised tables/ramps be prioritised. It is necessary to bring this recommendation to the full Council.
