Future Meeting and Civic Events

The decision by Government to ease the majority of the public health restrictions has prompted the Council to make new arrangements for the holding of Council and Municipal District meetings.

In early February, the elected members were surveyed as to their preferred options for future meetings. A total of 39 responses was received, with 50% of members indicating that hybrid meetings were their preferred option, 45% of members preferred in-person meetings and 5% of members favouring online only meetings. Future meeting arrangements will be considered, taking account of the feedback from this survey.

Launch of the Transport Strategy for Drogheda Town and Vicinity Survey

Louth County Council and Meath County Council are developing a Transport Strategy for Drogheda Town and Vicinity. The Transport Strategy will determine the transport interventions required to improve traffic and transport conditions in and around Drogheda.

Throughout February both Council's invited people who live, work, study or shop within the study area to have their say. Responses will assist in understanding current issues related to transport and obtain views on potential solutions.



The survey was open for submissions until Thursday, March 3rd across all social media platforms.

Toys, Technology and Training Initiative

Meath County Library launched their specialised Toys, Technology and Training initiative. The collection is designed to offer support to children and adults with learning difficulties, disabilities or more significant needs. The toys and other resources can be accessed free of charge in branches throughout the county with the TTT membership card.



As part of the initiative, the library service will host

an annual series of free lectures, recordings and workshops. These events offer further guidance, support and networking opportunities for parents, teachers and healthcare professionals.

Temperature Gauge Cards

During February, all Meath County Council staff received a temperature gauge card sharing some tips to save energy and to help reduce energy consumption in Meath County Council buildings. Additional cards were also printed for business owners and home owners, these cards were made available through local libraries, civic offices and in the Local Enterprise Office.



Drogheda Spring Clean Weekend



Louth County Council and Meath County Council launched an online campaign inviting all resident associations, community groups, schools, sporting organisations, an individual or a few neighbours working together, to get involved, in the Drogheda Spring Clean weekend (between Friday, March 4th and Sunday, March 6th 2022).

Members of the public were invited to tackle a Kilometre of roadway, park, street or lane in your local area and help make it litter and debris free.

Both Council's provided litter pickers, bags, gloves and hi viz vests. The bags of waste would be collected when clean ups finished. Those who registered could collect a free Clean Up pack from Drogheda Recycling Centre who supported the initiative.

Draft River Basin Management Plan (RBMP)

The Local Authority Waters Programme (LAWPRO) is hosting two online public meeting on the Draft River Basin Management. It will include both an overview of the national plan and information on local Rivers and Catchments.

There will be two brief presentations, followed by an opportunity for questions and discussion on any of the issues raised. There will also be guidance on how to make a submission on the Draft River Basin Management Plan for Ireland 2022 - 2027.

Green KM

The Green KM scheme has been launched for 2022 and there has been a very positive response from new and existing participants across the county.





Bulky Waste Collection

The following is a calendar of Free Bulky Waste Collections for 2022 at Trim, Navan, Kells and Dunboyne Recycling Centre including couches, beds, mattresses, toys, nursery equipment.

Drogheda Spring Clean

Meath and Louth County Councils have developed a joint initiative to encourage Clean Up activities in Drogheda. A Spring Clean Weekend is planned for March $4^{th}-6^{th}$, whereby groups, clubs, schools and individuals will be invited to avail of litter picking equipment and a waste collection service to tackle litter and waste in their area. The awareness campaign will include Radio advertising, Radio Interviews, Press, Social Media, PPN Network, Community Database. Subsequent to the Clean Up participants will be encouraged to continue to take regular clean ups as part of the Green Kilometre Scheme. Saplings will be provided to participating groups to mark Tree Week which takes place in March.

Prohibition of Waste Disposal by Burning

The Waste Management (Prohibition of Waste Disposal by Burning) Regulations 2009 allowed farmers, in accordance with the waste hierarchy and as a last resort, to dispose of green waste by burning i.e. untreated/uncontaminated wood, trees, tree trimmings, leaves and brush which were generated by agricultural practices. New amending Regulations have now been introduced extending the exemptions to burn waste generated by Agricultural practices until the 1st January 2023.

Climate Action

Air Quality Project Trim: The tender process for this contract is almost complete and the successful contractor is expected to be appointed in the coming weeks.

Energy Bureau: Meath County Council in collaboration with Kildare and Wicklow County Councils is progressing the establishment of a regional Energy Bureau which will be co-funded to 50% for a period of three years by the SEAI. The tender for same will be published by early February. The Energy Bureau will be initially inwards facing, progressing energy projects to increase energy efficiency and reduce emissions within councils.

Call for Expressions of Interest for Purchase of Lands and/or Turnkey Houses – Social & Affordable Housing

A call for Expressions of Interest was advertised on February 18th, for uncommenced residential developments and land for social and affordable housing. Proposals will be evaluated as they are received. Both calls for Expressions of Interest are open until the end of the year. Proposals received will be evaluated, and if deemed suitable, will then form the basis of an application for funding under the Affordable Housing Fund to achieve affordability. Refurbishment Projects

<u>St Francis Park (€3,771,374)</u> – Departmental approval is awaited to proceed to Tender Stage using the restricted procurement procedure. A total of 5 contractors have been shortlisted for the tender stage of the scheme. Estimated start date onsite is Q2 2022.

Alverno Court Refurbishment (€4,150,329) - Refurbishment works commenced on site on 3rd August 2021, and will be completed across five phases. Phase 1, which comprises of the refurbishment of 4 units, is due for completion on 4th March 2022. The tenants from Phase 1 will move back into their dwellings and the tenants from Phase 2 of the works will be decanted. The scheme also consists of the demolition of 2 additional units which are to be rebuilt over the duration of the 5 phases. Phase 2 is due to commence on 10th March 2022 and this consists of the refurbishment of 5 units. The estimated project programme for Phase 2 is 12 weeks.

Housing Adaptation Grant Schemes for Older People and People with a Disability

A total of 92 applications for Grant funding to the value of €681,791 was approved at the end of 2021 – carried forward into this year's budget as works will not be completed until 2022. A further 44 applications to the value of €324,802 has been approved to date in 2022. A total of 136 applications which equates to €1,006,593 of Grant Allocation for 2022 when announced.

Local Authority Adaptation Works Scheme

A total of 52 projects was completed in 2021 under this scheme with a total recoupment of €488,478.00 from the Department.

A submission for 2022 Local Authority Housing Adaptation Grants has been made to the Department requesting approval of €629,301 for 54 adaptation grants and 3 extensions.

Local Authority Vacant Units Currently Unavailable for Allocation

Outlined below is a summary per Municipal District of the number of vacant properties that currently require works before they can be re-tenanted, as of 16th February 2022. For the period from 14th January 2022 to 16th February 2022, works were completed on 2 vacant units, while 5 units became vacant during this period.

Of the households with children, 29 families are placed in short term private rented accommodation (house/apartment) through Settlement Team's intervention and 6 Families in PMVT Family Hubs.

Reasons for emergency accommodation placement in order of frequency: Primary reason is Notice to Quit & unable to a find property to rent; followed by family breakdown; addiction; mental health and young person leaving Tusla aftercare.

A total of 3 tenancies was secured through the support provided by the Homeless HAP Placefinder Service for the period January 1st to January 31st 2022.

Community Development

Local Community Development Committee (LCDC)

The LCDC scheduled for Friday 25th February did not go ahead due to a lack of a quorum. The next meeting is scheduled for 25th March and will receive updates, approve the Sicap end of year report 2021 and the LCDC annual report for 2021.

Joe O'Brien TD, Minister of State for Community Development & Charities visited Navan recently and met with some agencies involved in working on projects promoting social inclusion in disadvantaged areas. The Windtown bus initiative was one such project, a collaboration between a number of bodies including the council. It was set up 5 years ago to bring young people from the Windtown area of Navan to Beaufort College secondary school. The distance between Windtown and Beaufort was not sufficient for the students to qualify for the School Transport Service. The scheme has been a huge success with young people remaining in school with attendance at school >90% and minimal absenteeism. The initiative was set up to break the cycle of disadvantage by keeping young people in education.

LEADER Programme 2014-2022

The LAG meeting took place on Friday 25th February where the LAG received updates on EOI's received and considered projects recommended by the IEC.

Meath Age Friendly

The alliance met in person recently and discussed progress on the draft strategy and progress on the upcoming older persons convention in May. A presentation was given to Sgt Dean Kerins on his retirement from An Garda Síochána and his contribution to the Age Friendly programme in Meath over the last 10 years.

Comhairle na n'Óg

Dail na nÓg is taking place on Saturday the 26th of March in the Convention Centre Dublin. Meath Comhairle will have 7 members in attendance.

Joint Policing Committee

The next meeting is scheduled for Monday 21st February.

National Broadband Plan

Open eir commenced work in Laytown-Bettystown to carry out underground route proving and clearing of blockages for the NBP. NBI have also sent in details of new pole locations and the general area for underground works in the Dunboyne Area.

WIFI4EU

Ratoath, Oldcastle, Trim are now completed and the WIFI4EU network is live in the town centres. Connections are still required at one site each in Dunshaughlin and Dunboyne.

In Ashbourne can complete works for areas in Broadmeadow, Frederick St and the playground. The CAPEX funding for the WIFI4EU is due to expire in March 2022.

Broadband Connection Points

All BCPs have been upgraded with new furniture and digital audio-visual equipment to improve the range of activities that can take place at the sites. Access Control System installations commenced in February.

Funding Schemes

The Community Grant Scheme is now open for applications until 11th March 2022.

Carranstown Grant Scheme

This scheme is now open for applications until 25th February 2022.

Outdoor Recreation Infrastructure Scheme (ORIS)

Minister Humphreys launched ORIS on the 18th February and said that the 2022 Outdoor Recreation Infrastructure Scheme (ORIS) will see the development of natural amenities such as mountains, lakes, beaches, bogs, walkways, greenways and blueways. The Scheme, which saw its funding increased will place a focus on developing adventure tourism in Rural Ireland. It will support activities such as hiking, mountaineering, kayaking, swimming and cycling, which were especially popular among families throughout the Pandemic.

The projects that will be supported under ORIS are designed to benefit the health and wellbeing of the communities in which they are located.

The Scheme is funded by the Department of Rural and Community Development in partnership with Fáilte Ireland and project applications will be accepted from the Local Authority under the following Measures:

- Measure 1 for small scale projects requiring funding of up to €30,000,
- Measure 2 for medium scale projects with funding of up to €200,000,
- Measure 3 for large scale projects seeking funding of up to €500,000, and
- Project Development Measure funding of up to €50,000 for development costs for strategic large-scale projects.

CLÁR scheme

Minister Humphreys announced the launch of the CLÁR scheme on 24th February which provides funding for small scale infrastructural projects in CLÁR areas.

The programme is funded by the DRCD with Measure 1 delivered by the Local Authorities.

Measure 1 has been updated and will support capital interventions that contribute to the enhancement of facilities and amenities which will enhance the rural communities.

Measures 2 and 3 are administered directly by the department.

Town & Village Renewal Scheme 2021 (TVRS)

The Department announced today the successful projects under Town & Village scheme 2021.

Dunboyne €100,000

This proposal aims to redevelop Dunboyne Playground, which will provide more age specific play equipment for younger and older age groups and will also include repair of the existing skate park.

Enfield €250,000

Enfield Multi-purpose Hall: The proposal seeks to develop and refurbish St. Patrick's Parish Hall, on the main street in Enfield, into a usable space for the community providing a community facility for a young and diverse community as well as bringing back into use a vacant building.

Kilcloon €100,000

This proposal aims to develop the village square into a fully inclusive, accessible space which caters for all sections of the community and acts as a focal point in the village.

Kilmainhamwood €250,000

Kilmainhamwood Multipurpose Centre: This proposal seeks to refurbish a derelict building in the centre of Kilmainhamwood into a community centre with a multi-purpose space and a remote working space.

Libraries Services and Arts Office

Libraries - Overview:

- All libraries fully operational
- Full complement of study spaces available for use.
- Full complement of public access PCs available for use.
- Class visits can be arranged with your local library.
- Events and activities resumed

Library services returned to normal with effect from February 21st, but with continued use of sanitisers, screens, appropriate signage and mask wearing (while mandated).

Ireland Reads Day

Ireland Reads Day was on Friday 25th February with the aim of making that day the focus of the reopening by inviting in all adult book clubs, arts groups etc Branches also ran a welcome back story time for Parents and Toddler or young children on Ireland Reads Day.

In addition to programming a range of events staff also recruited high profile media ambassadors, to support the local campaign, and drive interest on social media channels. Fred Cooke, Killian Donnelly, and Gavan Reilly are contributing to the Meath campaign.

Decade of Centenaries

'Unsettled Territory – The 5th Battalion (Meath Brigade) in North Meath 1917-1921' – Meath County Council – New publication - March 2022

Having served Ireland as a diplomatic representative for over forty years in many places around the world and having seen the tricolour raised with dignity and respect, Frank Cogan returns to his roots in north Meath, to the summer of 1954. His memory of an Old IRA commemoration in Ballinlough cemetery, and the still-vivid shock of the discharge of weapons over a rural grave, lead him to explore his family connections with the struggle for statehood a hundred years ago.

His exploration begins with the founding of the 5th battalion in north Meath in 1917, the decisive 1918 General Election, the tragic deaths of Séamus Cogan and Patrick McDonnell, the Sylvan Park and Drumbaragh ambushes, to reorganisation of the battalion and to Truce and Civil War.

In approaching this complex period in our history, Cogan's work is in keeping with the principle of the *Decade of Centenaries 2012-2023* of remembering appropriately, proportionately, respectfully and with sensitivity. His search leads him to make contact with a grand nephew of 2nd Lieut. Albert Henry Ball who commanded the cyclist platoon of the Norfolk Regiment in Oldcastle on the fateful night Séamus Cogan was killed and who, quite probably, pulled the trigger.

"Major Albert Henry Ball was my great-uncle and ... it is an honour for me to act on behalf of him and his family in firmly and warmly grasping your extended hand in a reciprocal act of friendship, peace and reconciliation."

This important new work takes the reader on a century-long journey from tragedy to reconciliation.

Writer in Residence – Brian Gallagher

Brian Gallagher, an award-winning children's writer will work with two Meath schools to increase pupils understanding of the revolutionary period.

Brian Gallagher <u>www.briangallagherwriter.com</u> Brian Gallagher was born in Dublin. He is a full-time writer whose plays and short stories have been produced in Ireland, Britain, and Canada. He has worked extensively in radio and television, writing many dramas and documentaries.

In recent years he has concentrated on historical fiction for older children/young adults, and his novels cover the decade of centenaries period i.e: <u>Across the Divide</u>, <u>Taking Sides</u>, and <u>Friend or</u> Foe

Brian will work with schools in Navan and Slane over a two-month period, March to April, to help the children explore the history of the revolutionary period in their local areas. Boyerstown NS has been selected to participate, as it is located close to the scene of the 'Battle of Curraghtown', the major event in Meath during the Civil War.

Creative Ireland (Meath) - Patrick Reel Exhibition

Patrick Reel was born in 1935 and lives in Navan, Co. Meath. He opened the Oriel Gallery beside his home and studios in 1976 – it is one of the longest running private galleries in Ireland. Reel's paintings have been included in many notable solo and group shows over the sixty-five years of his artistic practice.

'A Life in Paint: Retrospective Exhibition of Works of Patrick Reel' opens on March 10th and will run, in Dublin Castle State Apartment Galleries, until the end of July.

The exhibition will be across four rooms: Portraits (including a large one of De Valera, and one of Mary Lavin), Realism, Abstract/Semi-Abstract (pre-2015) and Abstract/Semi-Abstract (post 2015). Patrick Reel reverted to chiefly abstract work after a gap of around thirty-five years from his Solo Exhibition in the Project Arts Centre in 1973, and arguably some of his best work has been produced in the last ten years or so. There is a strong influence of Celtic/monastic images and the Boyne Valley evident in his paintings, dating back to his work as a designer in Navan Carpets in the 1960s. There are countless examples of well-known artists around the world whose best work occurred or was only recognised in older age.

The event will be linked to Creative Brain Week, and Prof Ian Robertson, Co-Director Global Brain Health Institute, Trinity College Dublin, will be the guest speaker at the launch.

The Creative Ireland (Meath) programme supported Patrick Reel with contributions towards his time and material costs in preparing for this landmark exhibition.

The Local Enterprise Office Meath continues to provide excellent support to businesses throughout the county. End of year statistics released by Enterprise Ireland, MicroFinanceIreland and .ie domains show that in 2021:

- LEO Meath is number two in the country for job gains in the annual employment survey
- Meath is number two in the country for job creation associated with MicroFinance Ireland loans
- Meath is number three in the country for new on-line business registrations.

Some headline figures for the supports and services delivered to local businesses by the LEO Meath in 2021 show:

- Feasibility, Priming & Expansion Grants 33 companies approved for financial assistance, creating 421 new jobs
- Trading online Vouchers 165 companies were assisted to bring their businesses on-line

LEO Meath continues to roll-out the very successful Innovate/Accelerate Europe programme to support local businesses overcome some of the difficulties encountered because of Brexit. This programme was designed and delivered collaboratively by the LEOs in Meath and Louth and the Newry & Mourne Enterprise Agency, with funding from the three relevant councils. The third tranche of 21 companies is coming to the end of its programme. Minister English, when he visited LEO Meath recently, commented on the unique and innovative use of technology evident in the programme. Recruitment for the next phase will begin in Q2, 2022.

Commercial Rates Waiver

The Government extended the targeted commercial rates waiver to include the period Q1 2022, the process of applying the credit to the qualified customers is virtually complete. At present €1.19m has been credited to 593 customers for Q1 2022.
