5.3 Tourism

5.3.1 To receive a Presentation and Update on Boyne Valley Tourism Activities.





Mr. Des Foley and Ms. Michele Whelan, Tourism Development Officer, provided an overview and update on Boyne Valley Tourism activities. Mr. Des Foley advised that in accordance with figures provided by Fáilte Ireland, the value of tourist spend in Co. Meath pre-Covid was €88m. He also provided an update on current tourism projects including the Mornington to Drogheda Greenway, Royal Canal Greenway, Trim Porchfields and the Boyne Blueway in Trim. He further outlined several projects as part of Public Realm and Town Centre First schemes. Ms. Michele Whelan outlined the details of the 'where the adventure begins' campaign as well as details of online platforms and promotional shows.

In general terms the elected members complemented Boyne Valley Tourism on the extensive work that was being done. It was noted that there was potential for improved facilities at Tara Hill.

5.4.1 To enter into an agreement with Cavan County Council pursuant to Section 85 of the Local Government Act, 2001, whereby Meath County Council will exercise the statutory powers, functions and duties of Cavan County Council in relation to a cycle and walking scheme namely the Boyne Valley to Lakelands County Greenway linking Navan through to Kingscourt which is displayed in the Schedule to the Agreement.

This was approved on the proposal of **Councillor Eugene Cassidy** and seconded by **Councillor Paul McCabe**.

"I request Meath County Council to provide an updated Vacant Sites Register, in tabular format by Municipal District, including site valuation."

Response

The Vacant Site Register is available to view on the council's website at https://www.meath.ie/council/council-services/planning-and-building/vacant-or-derelict-sites-and-dangerous-structures/vacant-sites

This register is updated regularly to reflect new sites which are being placed on the register. Column A shows the VS Register Number, Column F contain the Site Valuation and Column I identifies the Municipal District the site is located.

The Council continues to assess sites appropriate for the register.

"Will the Community Call Service be retained by Meath County Council and expanded to help support Ukrainian people fleeing the war?"

Response

A meeting of the Community Response Forum has been arranged for Wednesday 30th March at which the relevant agencies will provide up to date information on what services are in place in Meath to assist the Ukrainian refugees and to address any gaps that maybe identified.

8.3 Submitted by Councillor Alan Tobin

"In light of increasing energy costs, would it be possible to light every 2nd public light where feasible. This could be undertaken on a temporary or pilot basis, while taking account of Health and Safety matters."

Response

Meath County Council operates and maintains circa. 18,900 public lighting lanterns across the county, these include a combination of the older SOX lanterns and the more efficient LED lanterns.





While initiatives to reduce energy are welcomed, changes to the lighting arrangement could result in non-compliance with Irish Standard for public lighting CEN/TR 13201-2:2015 Road Lighting - Part 1: Guidelines on Selection of Lighting Classes which specifies certain lighting classes for traffic, pedestrians, low speed areas and areas of conflicts (where vehicular traffic intersects with pedestrians, cyclists and other road users).

To reduce the lighting to every second lantern would require accessing each affected lantern to remove the photocell or change the timer, additionally while dimming lights may offer some reduction in energy costs these savings, for both options, would be outweighed by the cost to undertake the changes across the network.

Meath are part of the Eastern Public Lighting Energy Efficient Project (PLEEP), which will see the retrofit to LED lanterns, this project when complete will see a reduction in energy costs and increased energy efficiency. In advance of the commencement of the project the public lighting maintenance work will continue to replace expired SOX lanterns with LED lanterns.

"How many men, women and children have been refused emergency accommodation because of no local connection by Meath County Council in the years covering the world's worst pandemic. That is 2019 2020 2021 and so far in 2022?"

Response

The information for 2020 is from the Pathway Accommodation and Support System (PASS) reports only. The information for 2021 and 2022 is extracted both from PASS and Meath County Council Housing Office weekly presentation report.

9.1 Submitted by Councillor Damien O'Reilly

"I call on Meath County Council to write to the Minister for Housing, Local Government and Heritage, requesting the department to provide infrastructural funding for the development of the 50 rural nodes in Meath."

The motion was introduced by Councillor Damien O'Reilly. There were a number of interventions from the following: Councillors Paddy Meade; Alan Tobin; Eugene Cassidy; Noel French; Gerry O'Connor; Paul McCabe; Brian Fitzgerald; Trevor Golden; Michael Gallagher and Elaine McGinty. Councillor Brian Fitzgerald proposed an amendment which was seconded by Councillor Trevor Golden and agreed as follows:

"I call on Meath County Council to write to the Minister for Housing, Local Government and Heritage, requesting the department to assist in the development of the 50 rural nodes in Meath."

The motion as amended, was proposed by **Councillor Damien O'Reilly**, seconded by **Councillor Paddy Meade** and agreed.

9.2 Submitted by Councillor Damien O'Reilly

"I call on Meath County Council to write to the Minister for Housing, Local Government and Heritage, requesting that his department begins the process of updating the National Planning Framework in preparation for the publication of the upcoming census population figures."

The motion was introduced by **Councillor Damien O'Reilly**. There were a number of interventions supporting the motion from the following: **Councillors Maria Murphy; Sharon Tolan; Nick Killian** and **Michael Gallagher.**

9.3 Submitted by Councillor Mike Bray

"That Meath County Council considers modular homes as part of the solution to assist with accommodating the influx of refugees fleeing the war and atrocities in Ukraine over the coming weeks."

Supporting Information subject to the motion being proposed, seconded and considered.

The International Protection Accommodation Service (IPAS) of the Dept. of Children, Equality, Disability, Integration and Youth (DCEDIY) is responsible for providing accommodation to people in the International Protection ('asylum') process, including those fleeing the conflict in Ukraine and is coordinating all efforts in this regard. The local government sector has been asked to provide assistance and support to IPAS.





Senior management of the Council has held a number of meetings in this regard, and we are liaising with the CCMA at national level and various other Departments and Agencies at national, regional and local level. The Council is putting a number of contingency measures in place as part of the national effort and is in communication with IPAS.

This is an evolving situation and the Council will continue to support IPAS in delivering a national response.

The motion was introduced by **Councillor Mike Bray** with interventions from **Councillors Trevor Golden** and **Elaine McGinty.** The motion was proposed by **Councillor Mike Bray**, seconded by **Councillor Trevor Golden** and agreed.

9.4 Submitted by Councillor Ronan Moore

"That Meath County Council seeks to increase the participation of children and young people in the development of local services and policies in the county by including stakeholders from this cohort at Strategic Policy Committee Meetings."

Supporting Information subject to the motion being proposed, seconded and considered.

The statutory basis for the establishment of Strategic Policy Committees (SPCs) is set out in Section 48 of the Local Government Act 2001 as amended by Section 41 of the 2014 Act. The role of the SPCs is to assist the Council in the formulation, development and review of policy and to reflect on the major functions or services of a local authority within the broader context.

In accordance with the legislation the procedure for sectoral representation and nomination to SPCs is set out in Meath County Council's Strategic Policy Committee Scheme 2019 – 2024 as adopted by the elected members of the Council in September 2019. Nominations to the SPCs is facilitated by the appropriate national pillar or through the Public Participation Network.

Children and young are included in the development of local services and policies through Comhairle na nÓg which give children and young people the opportunity to be involved in the development of local services and policies. Comhairle na nÓg in Meath are regularly consulted on issues that arise including the preparation of the county development plan and local economy community plan. They are also represented on the Meath Joint Policing Committee. Meath Age Friendly frequently deliver intergenerational projects and seek the involvement and input from young people from Comhairle and also Transitional Year students from schools.

The motion was introduced by **Councillor Ronan Moore** and he noted that although not expressly implied in the motion, the inclusion of young people in SPCs would take long term planning. There were interventions from the following: **Councillors Gerry O'Connor; Paddy Meade and Maria Murphy.** In general terms the contributions were in support of the premise of the motion, although there were some concerns regarding the practicality of the arrangements. The motion was proposed





by Councillor Ronan Moore and seconded by Councillor Gerry O'Connor was adopted. Councillor Paddy Meade dissented from the motion.

10 General Interest Motions

10.1 Submitted by Councillor Mike Bray

"That Meath County Council supports the call by families for further respite services for adults with intellectual disabilities to be provided for in County Meath and we write to the HSE and Minister for Health outlining our support for these vital services."

The motion was introduced by **Councillor Mike Bray**. On a point of clarity, he advised that the motion should call on the Minister of State, Anne Rabbitte and not the Minister of Health.
