
## 6.1 Transportation

6.1.1 To receive a Progress Report on works undertaken/planned for Ashbourne Municipal District.

The report had been circulated in advance and a further update provided at the meeting.

Matters raised by councillors included:

 Queried when the road would be reinstated following works carried out on behalf of Irish Water – the contractor will be back on site this week regarding the planned programme of works.





- Requested an update on progress with the public lighting and ramp at
   Oberstown a number of measures are to be undertaken, including
   speed surveys and footpath installation, with a contractor being sought
   to carry out the works. Updates will be provided when available.
- Referred to the condition of the hoarding at the Castle Street project, which is subject to delays, and requested that it be repaired and painted and also queried the reason for the delays on the project at Castle Street.
- Queried whether footpath works were planned from Tudor to the Millennium Garden – the works will be carried out during the summer holidays, with a ramp near the junction and pedestrian crossing to be provided. Traffic lights are also to be installed. This is a major scheme, requiring a Part 8 process.
- Referred to damage caused to the bridge on the Milltown Road.




## 10 Correspondence
