5.2 Environment

5.2.1 To receive a presentation in respect of a draft Litter Management Plan 2022-2024 and to agree as statutorily required under the Litter Pollution Act 1997 to put same on public display as part of the consultation process – recommended by the Climate Action, Environment & Emergency Services Strategic Policy Committee at its meeting held on Friday May 13th.

Mr. Larry Whelan gave a presentation on the draft Litter Management Plan 2022-2024. He noted that the draft plan was due to go out on public consultation, following which the plan would be further reviewed and brought back before the members for adoption, in accordance with Section 10 of the Litter Pollution Act 1997. He outlined the responsibility of the council in relation to the prevention of the creation of litter and the collection of litter. He further highlighted some of the successful initiatives that had taken place over the past number of years including Spring Clean events, Pride of Place Awards, Green Schools initiatives and Free Drop Off Days.

6.1 Chief Executive's Report

There were comments and clarifications sought by Councillors Alan Tobin; Wayne Harding; Gillian Toole; Trevor Golden; Damien O'Reilly; Sharon Tolan; Joe Bonner; Paul McCabe and An Cathaoirleach on a number of matters in the report. The main issues focused on:

The Chief Executive left the meeting. Mr. Barry Lynch deputised for the Chief Executive in her absence.

6.2 Report from the Corporate Policy Group

The Meetings Administrator informed the meeting that the CPG met on Friday June 10, 2022. The agenda and the practical arrangements for the AGM and the June Council meeting were reviewed. The members of the CPG were advised that as the Solstice Theatre had fully reopened it was not feasible to continue to use the venue for council meetings and that it was proposed that the council meetings would take place in the Training Room in Buvinda House early in quarter 4 this year.

The members of the CPG were updated on the council supports to IPAS in relation to Ukrainian refugees and it was noted that the Community Response Forum was available to answer any queries from elected members, Ukrainian Refugees or the general public.

The members of the CPG were updated on the Judicial Review proceedings to the Meath County Development Plan.

6.3 Report from the Protocol Committee

The Meetings Administrator informed the meeting that the Protocol Committee met on Friday June 10, 2022. A Notice of Question from **Councillor Francis Deane** had been referred to the Protocol Committee and was responded to at the meeting.

"Can I ask when a review of protected structures and buildings will take place in Meath and in order to help inform the public and representatives on such a review, can the preservation team present an update at full council on how to initiate a preservation or section 57?"





Response

Work has commenced on a two-phase review of the Record of Protected Structures. Firstly, an inhouse desktop review of the Record has commenced. This work will be completed in 2022 and is intended to identify those records which require a more detailed examination. 8.3 Submitted by Councillor Emer Tóibín

"To ask Meath County Council what hope (or otherwise) can we offer council tenants that they will be offered a timely transfer in the event of living next door to dangerous and persistent anti-social and criminal behaviour, as current demands on housing stock means there are little or no alternatives available?"

Response

Meath County Council has adopted a policy on anti-social behaviour which aims to investigate all complaints of anti-social behaviour fairly, impartially, and objectively, to provide a professional service for our tenants, who are victims of anti-social behaviour and to work towards the elimination of anti-social behaviour through prevention, enforcement and support. A new Tenant Handbook was launched during 2021 which is provided to each new Tenant at Pre-Tenancy outlining our responsibility to the tenant and what is expected of each tenant. Furthermore, in January 2022 a new Housing Estate Management Strategy was adopted which sets out how Meath County Council's Housing Department will take the lead in ensuring high quality management of its tenancies and estates.

Meath County Council takes reports of anti-social behaviour very seriously and has put robust policies in place to respond to and manage complains received. It is recognised that anti - social behaviour can have an adverse effect on the quality of life of tenants of the Council and can threaten the sustainability of communities and often leads to further disadvantages for vulnerable households. Meath County Council is committed to the prevention and elimination of anti-social behaviour in its estates and ensuring that all our tenants enjoy living in their homes in a peaceful manner without undue interference or difficulties emanating from anti - social behaviour.

Complaints relating to anti-social behaviour and nuisance are referred to a Housing Tenant Liaison Officer (TLO) for investigation and every effort is made to resolve the matter without resorting to legal action. It is recognised that the investigation and resolution of complaints can sometimes be a lengthy process, but it is important that due process is followed, particularly where the issuance of tenancy warnings are required.

Transfer applications on the grounds of anti-social behaviour are not considered, save in very exceptional circumstances and only on a case-by-case basis.

If a tenant of Meath County Council wishes to report an incident, they are advised to complete a 'Housing Investigation Report Form available on the council website and return by email to tenantliaison@meathcoco.ie or post to Meath County Council,





Housing Department, Buvinda House, Dublin Road, Navan, Co. Meath C15 Y291. Forms are also available at local Council Civic Offices.

In circumstances where tenants feel unable to make a complaint themselves, elected representatives may make the complaint on their behalf and with their consent. In all cases, complaints of criminal behaviour should be reported to An Garda Síochána.

"How many Ukrainian refugees have been accommodated in Co Meath to date?"

Response

The International Protection Accommodation Service (IPAS) of the Dept. of Children, Equality, Disability, Integration and Youth (DCEDIY) is responsible for providing accommodation to people in the International Protection ('asylum') process, including those fleeing the conflict in Ukraine and is coordinating all efforts in this regard. Meath County Council does not have access to the requested information.

9.1 Submitted by Councillor Elaine McGinty

"To ask that the Council write to the Minister for the Environment, Climate and Communications seeking clarification on what legislation should be applied or given priority by either the Council or EPA when assessing applications for waste water treatment licences; the Environmental Protection Agency Act 1993 or the EU Water Framework Directive - European Communities (Water Policy) Regulation 2003 (S.I. No 722 of 2003)."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The two pieces of legislation referred to in this Notice of Motion are complimentary of each other in that:

• Schedule 1 of the Environmental Protection Agency Act 1993 facilitates the identification of the relevant public authority for the purpose of assessing and granting of licences.





The relevant public authority will consider the contents of the EU Water Framework
 Directive - European Communities (Water Policy) Regulation 2003 (S.I. No 722 of 2003)
 when assessing a licence application.

Councillor Elaine McGinty proposed the motion and noted the importance of protecting the River Boyne as a primary source of water for thousands of people. **Councillor Gillian Toole** confirmed her support of the motion.

9.2 Submitted by Councillor Mike Bray

"That Meath County Council establishes a programme to assist and advise community groups and residents associations with the creation and maintenance of wildflower meadows."

The Heritage Section, through an action of the County Meath Heritage Plan supported by the Heritage Council and Meath County Council, will be running a Free Biodiversity Workshop on Pollinators and Sustainable Gardening: How you can make a difference. (See flyer below)

The purpose of these workshops is to give attendees the tools to put the All-Ireland Pollinator Plan into practice to effectively improve their area for wildlife, increase pride in their area and reduce pollution.

These workshops will be advertised to the public in the coming week.

Councillor Mike Bray introduced the motion and noted that he had received several queries in relation to how to establish a biodiversity area and the supports that are available. 10 General Interest Motions

10.1 Submitted by Councillor Alan Lawes





"I am calling on Meath County Council to call on the Minister for Housing to introduce an immediate increase in the income thresholds for people to qualify for social housing".

Councillor Alan Lawes introduced the motion and noted that the increased cost of living had placed huge burdens on families and that as a result, applicants were not eligible for social housing under the current income limits, nor did they qualify for a mortgage. Councillor Michael Gallagher and An Cathaoirleach spoke in support of the motion. The motion was proposed by Councillor Alan Lawes, seconded by Councillor Michael Gallagher and agreed.

10.2 Submitted by Councillor Edward Fennessy

"That this Council opposes any attempt by the Government and the HSE to remove A&E and critical care services from Our Lady's Hospital, Navan and that we write to the Minister for Health Stephen Donnelly, An Taoiseach Micheál Martin and An Tánaiste Leo Varadkar to demand of the government; the full retention of A&E and critical care services at Our Lady's Hospital Navan and the removal of any reference to the closure of A&E services at Our Lady's Hospital Navan from the Small Hospital Framework (2013)."

It was agreed that items 10.2 and 10.3 would be considered together.

The Motion was proposed by **Councillor Eddie Fennessy** and seconded by **Councillor Michael Gallagher.**

10.3 Submitted by Councillor Emer Tóibín

"That Meath County completely opposes Government plans to close the A&E in Navan and to reverse their decision and protect and invest in A&E services in Our Lady's Hospital Navan."

The motion was proposed by **Councillor Emer Tóibín** and seconded by **Councillor Gillian Toole.**

There were interventions in support of the motions from Councillors Eddie Fennessy; Emer Tóibín; Paddy Meade; Alan Lawes; Brian Fitzgerald; Michael Gallagher; Aisling Dempsey; Padraig Fitzsimons; Elaine McGinty; Gillian Toole; Yemi Adenuga; Ronan Moore; Joe Bonner; Gerry O'Connor; Suzanne Jamal; Wayne Harding; Paul McCabe; Damien O'Reilly; Alan Tobin; Sarah Reilly and Mike Bray. The members expressed concern regarding the capacity of neighbouring hospitals to deal with an increased demand, including the impact on elective procedures. Concern was raised regarding the lack of transparency in the decision-making process, and it was noted that the decision





pre-dated the current Sláintecare Programme. **An Cathaoirleach** suggested an amendment to the motions as follows:

"To request an urgent meeting, between a delegation of Councillors, with Minister for Health Stephen Donnelly, Dr. Gerry McEntee and other senior HSE Officials, to discuss plans to close the Emergency Dept. at our Lady's Hospital, Navan."

The motions, as amended, were proposed by **Councillor Alan Tobin**, seconded by **Councillor Eddie Fennessy** and agreed.

10.4 Submitted by Councillor Michael Gallagher

"That Meath County Council calls on the Minister of Health and the Minister of Public Expenditure and the Irish Dental association to resolve their financial differences to restore dental services to patients with Medical Cards."

Councillor Michael Gallagher introduced the motion and noted the difficulties that some medical card holders had in accessing dental services. The motion was supported by An Cathaoirleach. The motion was proposed by **Councillor Michael Gallagher**, seconded by **Councillor Eddie Fennessy** and agreed.

10.5 Submitted by Councillor Alan Lawes

"I am calling on Meath County Council to demand the Irish Government not only condemn the killing of Journalist Shireen Abu Akleh but to also impose the severest sanctions possible on the perpetrators, as we cannot allow any state or person threaten the lives of journalists and the freedom of the press."

The motion was introduced by **Councillor Alan Lawes**. The motion was supported by **Councillor Michael Gallagher**. The motion was proposed by **Councillor Alan Lawes**, seconded by **Councillor Eddie Fennessy** and agreed.
