#### **Data Protection Privacy Statement for**

ECD036- Tourism Competitions

#### Who we are and why do we require your information?

Meath County Council seeks to promote the economic, social and cultural development of County Meath and in doing so contribute significantly to improving the quality of life of the people of County Meath. The delivery of high quality services, tailored to meet the needs of all our customers, remains one of Meath County Council's core objectives and is included in our Corporate Plan. This quality service includes not only the level and quality of service given to our customers, but also the quality of our decision-making processes, the efficiency and effectiveness of our corporate operations, standard of our facilities and our ability to adapt in an ever-changing environment. In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities and businesses of County Meath, we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being offered, the information sought may include 'personal data' as defined by the Data Protection Acts and by the General Data Protection Regulation (GDPR) and may relate to current, past and future service users; past; current and prospective employees; suppliers; and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect, process and use certain types of personal data to comply with regulatory or legislative requirements.

### Why do we have a privacy statement?

Meath County Council has created this privacy statement in order to demonstrate our firm commitment to privacy and to assure you that in all your dealings with Meath County Council, we will ensure the security of the data you provide to us. Meath County Council creates, collects and processes a significant amount of personal data in various multiple formats on a daily basis. Meath County Council's commitment is that the personal data you may be required to supply to us is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary for purpose for which it was obtained
- Recorded, stored accurately and securely and where necessary kept up to date
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

### **Data Protection Policy**

Meath County Council has a detailed Data Protection Policy which outlines how we as a public body are committed to ensuring the security of any personal data you provide to us.

What is the activity referred to in this Privacy Statement?

Competitions are carried out via three channels

- i. at promotional shows
- ii. via social media
- iii. via TV, radio and press

i. Promotional Shows: The competition entrant must give their name and contact details and winners are chosen randomly once the show has ended. The individual is given the option of opting in to receive Boyne Valley Tourism E-zines. If they chose to opt in and they have given email address details, they are added to the direct marketing database. If they choose not to do this or if they have not provided an email address their entry sheet is securely shredded once the competition has been completed.

ii. Social Media- A question or request for user generated content is posted on the Discover Boyne Valley Facebook page and entrants are invited to post their answer in the comments box or to use Facebook messenger to submit their answers. Once the competition has closed a winner is selected from the entrants and that person is sent a DM to email info@discoverboynevalley.ie to claim their prize. Details of how to claim the prize are emailed to the successful entrant. In the situation where the prize is goods-based a postal address may be required for posting of the prize.

iii. Press, TV and Radio- A competition question is published in a press, TV or radio advert with a prize provided by Boyne Valley Tourism. The PR company engaged by Boyne Valley Tourism deal directly with the publication/ broadcaster who then run the competition and receive answers and contact details from entrants. Details of the winning entrant are sent via the PR company to Royne Valley Tourism who will then arrange for posting/emailing

## What is the basis for making the processing of personal data in this activity lawful?

- 1. Competitions at promotional shows: name, email address and/ or telephone number
- 2. Social Media competitions: only the name and email address of the winning entrant is collected unless a postal address is required in the case of a goods-related prize e.g. hamper or voucher
- 3. Press, TV and radio competitions- winners name, email address and postal address (in the event that the prize must be posted rather than emailed)

## We require your contact details

In order to communicate with you, you will be asked for contact details. You do not have to provide all contact details but providing more, such as email, phone, address, makes it easier to communicate. Please note that to help protect your privacy, we take steps to verify your identity before granting access to personal data. These contact details may also be used to verify your identity.

# What items of personal data do we need to undertake this activity?

- 1. Competitions at promotional shows: name, email address and/ or telephone number
- 2. Social Media competitions: only the name and email address of the winning entrant is collected unless a postal address is required in the case of a goods-related prize e.g. hamper or voucher
- 3. Press, TV and radio competitions- winners name, email address and postal address (in the event that the prize must be posted rather than emailed)

### This personal data will be used for the following purpose(s):

Contact information is required to advise the winning entrant of their success and to facilitate award of their prize. If a competition entrant (at a promotional show) has opted-in to receiving periodic marketing Ezines their email address is required to send this to them.

# Is the personal data submitted as part of this activity shared with other organisations?

Meath County Council may, to fulfil statutory or regulatory obligations or in the public interest, from time to time, have to share personal data with other organisations or entities (in Ireland or abroad). Where this is required Meath County Council shall have regard to the security and integrity of the data and will minimise the data shared.

In this activity, the data will be shared with the following recipients:

Data will be shared with our website developer, marketing consultant and Email Marketing Provider for the purpose of sending periodic Ezines (only where the competition entrant has opted in at a promotional show). In the event that a prize has to be sent by post or courier, name and address details will be used to distribute the prize

In this activity, if the personal data is to be transferred to a different country, it will be transferred to the following countries (if there are no countries listed, it is not intended to transfer the personal data abroad).:

### How long is this personal data held by Meath County Council?

Meath County Council has a detailed record retention policy which goes in to more detail of the time period for which your personal data will be retained by Meath County Council and what will happen to it after the required retention period has expired.

### The data processed as part of this activity will be retained for the following period(s):

Promotional shows: If the competition entrant has opted in to receiving direct marketing material, the sign up sheet collected at promotional shows is retained for 1 years and is then shredded. Email addresses are retained on our email marketing database until the data subject unsubscribes.

If the inidividual has not opted in to receive marketing material their data is securely shredded once the competition has concluded.

Social Media: Contact information is not retained once award of the prize has been completed.

Press, TV and Radio: Contact information is not retained once award of the prize has been completed What will happen if the requested personal data is not provided?

If contact information is not provided the competition winner will not be able to received their prize. Ezines will not be sent to the data subjects if they do not provide an email address (only relates to those who have entered at promotional shows)

# **Your Rights**

You have the right to request access to personal data held about you, obtain confirmation as to whether data concerning you exists, be informed of the content and source of data and check its accuracy. In addition, if the data held by us is found to be inaccurate you have the right to change, remove, block, or object to the use of, personal data held by Meath County Council. You also have the right to data portability. In certain circumstances blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you.
