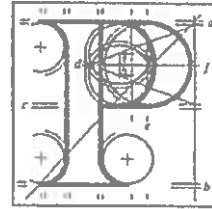

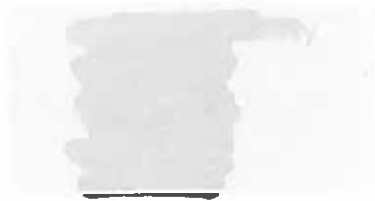

Dear Sirs/Madam,

This is an addendum to my original submission. Predication by Meath County Council of a minimum of 900-100 people per day would cause issues locally and personally. If the Greenway goes ahead, my home would be approximately 13 feet from the Greenway users which is an invasion of my privacy.

**Safety-** The number of people will cause concerns for me in relation to my personal safety.

**Security -** My home is very close to the Road and a lot of passers-by will invade by privacy and anxiety on security.

**My home-** The road I live on along the proposed route is presently extremely busy, buses passing every 10 minutes and heavy traffic from 8am – 6pm daily. The noise at the moment is very loud and it surely will be worse if the Greenway goes ahead.


**Litter-** As expected because of increase of users to the proposed Greenway, there will be inevitably be litter all along the road and possibly be thrown in to my garden.

**Parking-** Meath County Council have stated they will not be providing parking at the Tower Cross area, this will impinge on private parking area and block the road as happened during the pandemic.

**Public convenience** - There are no toilet facilities in the Tower Cross area. During the pandemic, because of increased traffic and people in our local area the Crook Road and Tower Road were very busy and consequently the Sand Dunes and other areas were used by the public to relieve themselves! How much worse will this be if the Greenway goes ahead!

In conclusion, I hope An Bord Pleanála will consider my concerns about the proposed Greenway. I have lived here for 30 years and the Greenway would present great difficulty for my peace of mind and wellbeing.
