#### **AILG Conference**

An Cathaoirleach Cllr. Nick Killian welcomed hundreds of Elected Representatives and delegates from across Ireland to Trim during September to attend the Association of Irish Local Government (AILG) Seminar.

The Knightsbrook Hotel Spa & Golf Resort was the setting for the Seminar, entitled "Celebrating Local Government", which took place on Wednesday 14 and Thursday 15, September.

The event was officially opened by Minister Peter Burke TD, Minister of State at the Department of Housing, Local Government and Heritage and closed by Minister Thomas Byrne TD, Minister for European Affairs.

#### **Bettystown Library Sod Turing**

building with stunning views out over the sea and a major community meeting space overlooking a new plaza in the centre of the village. This state-of-the-art facility is designed with a variety of users in mind and features dedicated areas for children, teens and adults.

#### **Reused Material on display on Greenway**



As part of the construction of the Navan to Kingscourt Greenway, rather than dispose of old rail sleepers the Council has utilised them to provide screen fencing to adjacent properties.

This construction method effectively reused a material which otherwise would have been categorised as waste.

This screen wall was constructed in July on the Navan to Wilkinstown section of the greenway.

#### Meath County Council – Energy Expo Event

The Meath Energy Expo is taking place in The Ardboyne Hotel on October 22<sup>nd</sup> from 10.00am to 4.00pm. The event is being run by Meath County Council and will showcase the information and advice for the public to make their homes and businesses more energy efficient. Present on the day will be experts in several types of renewable technologies, showcasing products from local business within Meath and the North-East.

#### Meath County Council Climate Action Plan

Meath County Council is updating the Climate Action Plan. The following reports will be included as part of the document update:

- Climate Change Risk Assessment for County Meath
- Climate Mitigation Assessment County Wide
- Climate Mitigation Assessment Decarbonisation
- Carry out Strategic Environmental Assessment and Appropriate Assessment for Meath County Councils Climate Action plan.

#### **Energy Audits**

Audits have been undertaken on the energy use of five council buildings that are significant energy users. Surveys have been completed and reports prepared which recommend energy saving changes to the fabric and operations of the buildings. A series of projects will be developed from the outcome of the audits.

#### **Trim Air Quality Project**

Four air quality sensors will be installed on Market Street and Patrick Street on 26<sup>th</sup> September, 2022.

#### School SDG engagement workshop:

A series of workshops will be delivered in 28 Primary Schools throughout Co. Meath which aims to educate  $4^{th} - 6^{th}$  class children on Sustainable Development Goals. The workshops will be delivered between September to December 2022.

#### SDG Children's Art Competition:

- A number of media drops are being undertaken promoting SDGs.
- The Climate Action Section is running a children's art competition to run in conjunction with SDG Week 22-26<sup>th</sup> September. Children aged 12 and under are invited to draw/paint a picture showing what the Sustainable Development Goals mean to them.

#### Swift Boxes:

Swift populations are reported to have significantly declined in the last decade. Swift boxes provide Swifts with a place to nest. Several swift boxes have been installed on the roof of Buvinda House, with the assistance of Bird Watch Ireland (Meath) and Wild About Navan group. It is proposed to expand this project and Navan Library and Town Hall are being considered as further sites for the installation of swift boxes.

#### Air Pollution Act 1987 (Solid Fuels) Regulations 2022

The new solid fuel regulations will come into force on the 31<sup>st</sup> October 2022.

Responsibility for enforcement of the Regulations will continue to rest with the Local Authorities and the Department of Environment, Climate & Communications are arranging for the development of guidance manuals, training and grant funding in respect of same. The main changes being introduced under these regulations relate to technical requirements for fuels including smoke emission rates arising from coal products and manufactured solid fuels, and moisture contents of such fuels. While the Regulations do not make any changes relating to turf cutting rights, they do include prohibitions on the sale of turf via the internet or other media or from premises selling food, fuel or other goods.

Ahead of the introduction of new regulations on solid fuels for domestic heating, the Department have developed an online survey for householders, which may be used to gauge patterns and levels of solid fuel use in different areas.

#### Fast Fashion Workshop for ReLove Fashion Schools



Ten Fast Fashion Workshops are being rolled out across the county in support of the ReLove Fashion Competition.

The workshops will cover all aspects of Fast Fashion – Environmental Impacts of the Textile Industry – Sustainability – What can we do as consumers? – Circular Economy – Reuse and Repair

These events will help students with their entries to the ReLove Fashion Competition and to gain a deeper insight into the true cost of fast fashion.

#### **Burial Grounds**

#### <u>Dunboyne</u>

Works are now complete on the provision of an extension to the Rooske Road Burial Grounds. The extended area set over circa 3 acres has a capacity for single plot burials together with a Columbarium Wall containing 20 niches – there is also scope for the construction of a garden of remembrance for urns, remembrance stones, and additional columbarium walls.

The development includes ancillary works such as internal access roads and footpaths, pedestrian and vehicle linkage to Rooske Old Cemetery, a carpark for 32 no vehicles with public lighting and drainage works. It is proposed to construct a caretaker's office/ canteen and toilet facilities as well as an enhanced entrance area in early 2023.

#### <u>Trim</u>

The provision of a replacement burial ground at Loganstown Trim is currently the subject of a Part 8 Planning process and with Wed 19<sup>th</sup> Oct being the closing date for submissions or observations.

## Call for Expressions of Interest for Purchase of Lands and/or Turnkey Houses – Social & Affordable Housing

A call for Expressions of Interest was advertised on the 19<sup>th</sup> of August 2022 for un-commenced residential developments & land for social and affordable housing. Proposals will be evaluated as they are received. Both calls for Expressions of Interest are open for a period of 6 weeks and will be readvertised on an ongoing basis. Proposals received will be evaluated, and if deemed suitable, will then form the basis of an application for funding under the Affordable Housing Fund to achieve affordability. #### **Refurbishment Projects**

- <u>St Francis Park:</u> Appointment of Contractor ongoing.
- <u>Alverno Court Refurbishment:</u> Refurbishment works commenced on site on 3<sup>rd</sup> August 2021 and will be completed across five phases. Phase 2 & 3 of the works are ongoing and it is expected Stage 4 of the scheme will commence in November 2022.

#### Local Authority Adaptive Work Scheme

The Department have provided  $\leq 629,301.09$  funding for 2022. There are 74 applications in total that have received approval in 2022 – 2nr. extensions and 72nr. adaptations. 51 applications have been allocated out to contractors to undertake works, most of which have been completed to date. The remaining 21 applications are being issued out to contractors to complete over the coming weeks and months. One of the extensions commenced in July and a second extension is due to start in the coming weeks.

#### Housing Adaptation Grant Schemes for Older People and People with a Disability

A total of 92 applications for Grant funding to the value of €681,791 were approved at the end of 2021. These approvals were carried forward into this year's budget as works will not be completed until 2022. A further 351 applications to the value of €2,331,953 have been approved to date in 2022. The total value for the 443 applications that have been approved to date equates to €3,013,744.

#### Local Authority Vacant Units Currently Unavailable for Allocation

#### Joint Policing Committee

A meeting of the Joint Policing Committee took place on Monday 19<sup>th</sup> September. The date of the Public Meeting for 2022 has been set for 7.30 p.m. on Thursday 13<sup>th</sup> October in Ratoath Municipal District.

#### **Broadband Connection Points**

The BCP site managers and people from their communities were invited to a network meeting on the 7<sup>th</sup> September in Kilskyre Community Activity Centre. The network discussed issues that were affecting them, the activities that they were delivering including co-working facilities and opportunities for new opportunities. Kinia presented their Train the Trainer programme to deliver digital skills programmes to 5 to 18-year olds by community leaders within the BCPs.

#### **Public Participation Network**

The nomination process for Secretariat is underway with elections to follow. An independent monitor will oversee same. A Facilitator is in place to hold inductions for new Secretariat members. 2 meetings with Environment and Social Inclusion pillar groups were held in September.

#### Healthy Ireland / Healthy Meath

Four initiatives to date have been approved for funding from the Healthy Ireland Round 4 2022 allocation including the Outcomers LGBT Flags Initiative, the Special Hands Summer Camp, St Ciarans Community School Breakfast Club and the Libraries Books for Dyslexia Project.

#### Joint Migrant Integration Forum

Next meeting is scheduled for 29<sup>th</sup> September which will be hosted by Louth County Council.

#### Town & Village Streetscape Enhancement Initiative

Minister for Rural and Community Development, Heather Humphreys TD, announced the 26 towns and villages that will benefit from a €2.6 million fund to support the enhancement of streetscapes and shopfronts with **Trim nominated in Meath**.

Under the Streetscape Enhancement Initiative, retailers and property owners will be provided with grants that they can use to improve the facades of their buildings, carry out artwork or install features such as street furniture or canopies.

Applications for funding must be submitted to the Department by October 7<sup>th</sup>.

#### CLÁR

Successful applications under Tranche 2 of Measure 1 of the 2022 CLÁR programme were announced on the 13th of September, by Minister Humphreys with the following allocations:

#### **Community Response Forum Ukrainian refugees**

The response forum, which is coordinated by the Community Section, continues to meet on a regular basis to ensure there is a co-ordinated response to assist with the needs of Ukrainian families entering the county. The most recent meeting was held on 12<sup>th</sup> September.

# Libraries Services

#### **Customer Satisfaction Survey**

The Data Working Group under the CCMA Corporate Committee has identified customer satisfaction as an area which they are prioritising this year. The Data Working Group has asked the library services to participate as one of the first local authority service areas in the rollout of a customer satisfaction survey, which will also be applied across other local authority services in due course.

This will involve a high-level user survey which can be taken by library users either online or in printed form being undertaken in one large, busy library in each of the 30 library authorities. The survey will be run in Navan library over 5 days in late September (**26**<sup>th</sup>-**30**<sup>th</sup> **September**).

The customer satisfaction survey includes nine questions relating to the following items:

- library membership
- age group
- gender
- level of satisfaction with ease of use of the library
- engagement with library staff
- satisfaction with the facilities, layout, and atmosphere of the library
- service/s used during the library visit (on day of survey)
- areas for which changes/improvements are desired
- likelihood of repeat use of the library service

#### **Decade of Centenaries**

#### Decade of Centenaries Conference, 22 October 2022

As the Decade of Centenaries draw to a close, the Meath History Workshop will host a conference in Buvinda House, Navan on Saturday, 22 October, presenting new research on the Revolution and its aftermath in County Meath and reflecting on how we have commemorated the seminal events of the period.

The opening paper by Dr Leeann Lane (Dublin City University) will explore the experience of women during the Revolution and in the new state. Local historians Michael, Nolan, Tracey Holsgrove and Jim Gilligan give papers, respectively, on war and lawlessness in 1922-23, violence against women and the role of sport during the revolutionary period.

In the afternoon session, Tom French, local studies librarian, and poet, will offer his perspective on commemoration. Dr Ciarán Wallace (TCD) will introduce the exciting Beyond 2022 project, which seeks to create a virtual reconstruction of the Public Record Office of Ireland, destroyed on June 30th, 1922. Finally, Frank Cogan will reflect on how commemoration was conducted in Meath in the decades after 1922. The conference will conclude with a panel discussion, inviting attendees to contribute their own reflections on the Decade of Centenaries.

The conference is being hosted by the Meath History Workshop, a group of local historians who have been active for the past decade and more in researching the history of the county. The event is funded by the Meath County Council Decade of Centenaries 2012-2023 Programme and supported by the Library Service.

#### **Murray Photograph Collection**

Cllr. Nick Killian, An Cathaoirleach of Meath County Council officiated at the launch of The Murray Photograph Collection in Dunshaughlin Library on Tuesday evening, 13 September. The photographs which are being exhibited form part of an extensive collection of images taken by Peadar Murray, founder of the Gaelic League in Dunshaughlin, businessman and husband of Margaret Murray, the first woman to serve on Meath County Council.

On behalf of Meath County Council, An Cathaoirleach thanked the Murray family, who were gathered in great number, for their public-spirited gesture in consigning Peadar Murray's glass-plate negatives to the care of Meath County Archive. He remarked that photographs are a crucial and neglected part of the heritage of County Meath. He congratulated the local studies department of the library service for their initiative in digitizing the images and welcomed the support the initiative received from the Decade of Centenaries Programme 2012-23. He concluded his remarks by making a presentation of a framed print, dated 1904 of a Gaelic League class in Dunshaughlin, to Ita Murray, daughter of Peadar Murray, who is hale and hearty at 94 years old.

#### Little Library Book Bags – Impact

As the gifting programme draws to a close very positive membership and issues figures have emerged detailing the impact of the initiative. Since the start of the programme there are 710 new library members aged 4-5 who signed up between the 1<sup>st</sup> April - 8<sup>th</sup> September. (This count only includes new members, not those who renewed their membership cards.) There were 12,792 issues on the cards of those new 4-5-year-old members in the same timeframe.

#### **Children's Book Festival**

CBF 2022 is due to commence on Wednesday 5th October. The festival returns with in-person events for the first time since 2019 along with a mix of the very popular zoom and pre-recorded events.

Festival highlights include *Greetings Heroes*, an interactive storytelling show from **Dave Rudden and Graham Tugwell** in the Solstice Arts Centre; **illustration**  workshops from Alan Nolan who'll show 1st and 2nd class how to draw some cool animals, Cllr. Ronan Moore will entertain 4th to 6th classes with exploration of Irish myths, magic and monsters. And thirty-five years after her first visit to Navan library Marita Conlon-Mckenna - the author of the ever-popular Children of the Famine series will be Zooming in to some lucky classrooms.

#### **Residential Zoned Land Tax**

#### <u>A presentation on the Residential Zoned Land Tax will be made at the November Council meeting.</u> In the interim, a summary of the initiative is contained below.

#### Aim

The principal purpose of the residential zoned development land tax is to encourage the timely activation of zoned and serviced residential development land for housing.

#### Legislative Framework

The Residential Zoned Land Tax ("RZLT") was introduced by section 80 of Finance Act 2021 and is contained in Part 22A of the Taxes Consolidation Act 1997 (TCA 1997). It is an annual tax which is calculated at 3% of the market value of land within its scope. Generally, the tax applies to land that, on or after 1 January 2022, is zoned as being suitable for residential development and is serviced. Each local authority will prepare and publish a map identifying land within the scope of the tax. These maps will be updated annually for any changes in the zoning and servicing status of the land.

#### Intro

The first step in this process is to identify lands which fall within scope of the tax. Lands in scope will be zoned for residential development or a mixture of uses including residential; be serviced or have access to servicing by water, waste-water, road, footpath and public lighting; and not be affected by contamination or significant archaeological remains which would preclude development taking place.

The tax measure can be divided into two parts, the first of which is the development of mapping identifying the lands to be subject of the tax. The second part involves implementing and managing the tax, which will be undertaken by the Revenue Commissioners.

#### Guidance

Housing Policy Objective 15.2 of Housing For All – A New Housing Plan for Ireland proposed a new tax to activate vacant land for residential purposes as a part of the Pathway to Increasing New Housing Supply. The Residential Zoned Land Tax (RZLT) was introduced by the Finance Act 2021 and will come into effect from 2024, managed by the Revenue Commissioners.

The tax and the associated guidelines are part of a suite of integrated measures and policy direction within Housing for All to:

- Engage lands in cities and towns;
- Create compact and integrated communities;
- Aid brownfield regeneration;

- Activate greenfield landbanks for housing; and
- Support place making and growth of sustainable communities.

#### Criteria for the inclusion of lands within the scope of the tax

- Land must be zoned residential use or for mixed uses which permit residential use including residential within the CDP/ LAP and Strategic Development Zone
- Land must be connected to, or have access to public infrastructure and facilities necessary for a dwelling to be developed and with sufficient service capacity available.
- All residential and mixed use zonings within each LPA, whether in cities, suburbs, towns and villages or other settlements should be considered for the purpose of the tax.
- Land which is zoned as residential and contains existing residential development such as estates or individual houses are also considered to be 'in scope' and must be included within the map but owners of existing properties will not be liable.

#### Serviced land definition

For the purpose of inclusion on the draft or supplemental, and final map, the land must have access to or be connected to relevant services. This includes lands which already have made connections to services, or where provision has been made in existing infrastructure for connection to the land. Information from stakeholders such as Irish Water will play a key role in identifying these lands and providing confirmation of existing capacity in wastewater treatment plants and water treatment plants along with data informing the date of connection or ability to connect to services, where this date was after 1 January 2022. A need for network upgrades is not considered to exclude lands, where sufficient treatment capacity is confirmed to exist. Further details are provided in Section 4 Implementation.

#### **Exclusions from the map**

- **Contamination:** Lands which are unable to be developed due to the need for significant remediation are to be excluded. These are sites with a degree of contamination which would preclude residential development and area on a verifiable register such as EPA site. Where lands are not identified as an EPA licensed sites, any submission requesting exclusion should submit evidence to enable the LPA to assess whether the land in questions should benefit from exclusion.
- **Significant archaeology**: where zoned serviced greenfield sites area known to contain archaeological remains, identified within the Record of Monuments and places (RMP) within CDP or LAPs, then the area comprising either the know extent of the archaeological remains of the zone of notification should be excluded for the purposes of mapping for the tax measure. Brownfield sites with a notification should be scoped in.
- **Zoning:** where residential is not 'permitted in principle', on a land use zoning matric, such zonings should not be included.

- **Derelict sites register**: Lands which are on the derelict sites register and a levy payable, the land is within scope and should not be placed on the map.
- Land required for infrastructure and community services: Land required for the provision of community services and infrastructure which will sustain existing and future residential communities. Where the land is zoned for residential development and specific objectives apply to provide such facilities but the extent of land required for such a use is not identified, the land will fall into scope until such time as it is developed and the relevant land will then fall out of scope. These uses include:
  - social, community or governmental infrastructure and facilities, including infrastructure and facilities used for the purposes of public administration or the provision of education or healthcare,
  - o II. transport facilities and infrastructure,
  - o III. energy infrastructure and facilities,
  - o IV. telecommunications infrastructure and facilities,
  - V. water and wastewater infrastructure and facilities,
  - VI. waste management and disposal infrastructure, or
  - VII. recreational infrastructure, including sports facilities and playgrounds

#### Exclusions for existing operating uses on land:

zoned serviced lands identified as part of the mapping process may have existing uses which are specifically excluded under the legislation.

With regard to residential zoned land, and mixed use zoned land, sections 653B(c)(i) and (c)(ii) respectively identify where certain uses may be excluded from the tax measure:

#### Operating uses on residential zoned land

With reference to land that is included in a development plan or local area plan and is zoned solely or primarily for residential use such as 'Residential' or 'New Residential', existing uses to be excluded from the scope of mapping for the tax measure must <u>provide a service to the existing or future residential community, must be an authorised use, must be considered a premises in use by a trade or profession and must be liable to commercial rates. Local Authorities should seek input from their Rates Offices in this regard.</u>

For clarity, existing uses such as shops, cafes and similar commercial uses which would be utilised by a residential community on a day-to-day basis and support the sustainable development of the community are considered to be exempted from scope. Use of land for agricultural or horticultural purposes are not considered to be exempted from scope as they are not subject to rates.

#### **Operating uses on Mixed use zoned lands**

With reference to land that is included in a development plan or local area plan and is zoned for a mixture of uses, including residential such as TC-Town Centre, DC-District Centre, RERegeneration,

LC-Local Centre and RV-Rural Village, <u>all land should be excluded from the map unless is it</u> <u>considered 'vacant or idle'.</u>

Vacant or idle land' means land which, having regard only to development (within the meaning of the Act of 2000) which is not unauthorised development (within the meaning of the Act of 2000), is not required for, or integral to, the operation of a trade or profession being carried out on, or adjacent to, the land.

#### **Temporary uses**

Temporary uses of land should not result in land being excluded from the tax measure. Lands which are subject to a temporary planning permission which has been commenced should be considered for exclusion for the period of that permission and revisited during the annual map review process to ensure that the land is activated at a later stage.

#### Annual map review

- The process should focus firstly on removing 'vacant or idle' mixed use zoned land which has been developed through fully completing permitted residential or commercial development or residential zoned land which has been developed for non-residential uses, such as education for example.
- New lands which have been serviced or have come into scope since the previous year's final map should be identified and included in the map for each subsequent review thereafter.
- The revised final map must be published by 31 January of each year, with the draft map for the following year's final map to be published on 1 February and shall identify new lands which are considered to have come into scope, existing lands from previous final maps which remain in scope and lands from previous final maps which are now proposed for removal due to development having been fully completed within the relevant planning permission period.
- The publication of a newspaper notice in relation to the publication of the draft map shall be undertaken by the 1st February each year, commencing in 2024.
- Submissions may be made by landowners and other members of the public. Submissions must be received by the local authority by 1 April in each year.

#### Amendments to zonings

Landowners can make a request to rezone land. These requests can only be made by/on behalf of the owners of land affected and can only be made during the submission period for for the very first draft and supplemental mapping process.

The ability to request a change in zoning is not provided for in later annual reviews of the maps as the taxation measure will at that stage have become established and the owner of any land subsequently falling into scope would be aware of such liability in advance.

Any requests for changes to zoning through a variation process should be considered by the local authority under Section 13 of the Planning and Development Act 2000 (as amended) utilising the same criteria applied to zoning requests during the making of a development plan or Section 20 of the 2000 Act facilitating amendment of local area plans.
