4.1 Corporate Affairs & Governance

4.1.1 To discuss the 2023 Arts, Festivals, Festive Lighting & MD Renewal budget.

Audrey Norris, Senior Staff Officer, Corporate Services advised the members that the allocation for 2023 is €7,500. The members agreed to allocate €1000 to Kentstown and Stamullen towards Christmas lights and €1000 to Ashbourne Tidy Towns for the St Patricks Day Festival. Mel Cronin was requested to prepare proposals for the balance of €4,500 for Christmas lighting in Ashbourne town centre.

4.1.2 To note Municipal District Allocations submitted by Councillors on behalf of Ashbourne Municipal District.

4.2 Transportation

4.2.1 To receive a Progress Report on works undertaken/planned for Ashbourne Municipal District.
