#### 5 Notice of Question

#### 5.1 Submitted by Councillor Stephen McKee

"To ask Meath County Council when work will be carried out to ensure that there is safe and clear pedestrian access between Avourwen, Legavooren Manor and Rosevale estates, Drogheda, County Meath given the Council's commitment to promoting active travel and permeability in urban areas and the fact that Legavooren Manor is soon to be taken in charge."

#### **Response:**





These estates are at different stages with regard to the taking in charge process, Rosevale is taken in charge, Avourwen is still under construction, Lagavooren Manor is not taken in charge as of yet. The Planning Department are liaising with a third-party regarding undertaking compliance works in Lagavooren Manor on foot of the taking in charge to bring the estate up to standard before handing over to the Municipal District. Until such a time as the taking in charge processes are complete for all the estates the Council is currently not in a position to carry out any works.

#### 6 Notice of Motion

#### 6.1 Submitted by Councillor Stephen McKee

"That Meath County Council put in place traffic calming measures on the R152 road between Drogheda and Kilmoon to help reduce the speed of traffic and improve road safety; that the Council continue to liaise with Gardai on speed enforcement on the road and furthermore, in line with its Active Travel commitments, immediately set about the putting in place of a pedestrian crossing on the R152 at Duleek Soccer Club to facilitate safe access to and from the grounds for children and families."

## <u>Supporting information subject to the motion being proposed, seconded and considered:</u>

There is currently no funding ring fenced for traffic calming works at on the R152. Meath County Council will consider any traffic calming measures that could improve the R152 from a pedestrian/vehicle interaction perspective, when funding becomes available.

On the proposal by **Clir Stephen McKee** and seconded **Clir Paddy Meade** the motion was noted.

Cllr McKee advised that traffic calming measures and signage are required along this road to reduce speeding and that there is no safe crossing area at the Duleek Soccer Club.

#### 6.2 Submitted by Councillor Wayne Harding





"To call on Central Transportation and the TII to investigate the erection of bollards on the western side of Slane bridge along the outside rim of the pedestrian lane of the bridge ensuring a short term safety measure for pedestrian users of the bridge."

# Supporting information subject to the motion being proposed, seconded and considered:

The existing Slane Bridge is currently included in the public realm proposals being progressed in conjunction with the N2 Slane Bypass scheme. The existing layout on the existing N2 Slane Bridge will be reviewed subject to the various TII and the National Monument Service's requirements, procedures etc.

On the proposal by **Cllr Wayne Harding** and seconded by **Cllr Paddy Meade** the motion was agreed.

Cllr Harding advised that the Slane Tidy Towns had suggested putting bollards on one side of the bridge to allow pedestrians to walk safely across the bridge.

It was agreed to pass on the telephone numbers of the councillors to Adetola to make contact directly with them.

#### 9 Any Other Business

The following issues were raised with responses:

- Update on the taking in charge of Lagavooren Manor advised Council cannot carry out any works until the estate is taken in charge. An assessment will be carried out with a list of works to be completed along with the costings.
- Seeking a pedestrian crossing between the carpark and Laytown train station as footfall has increased advised there was a scheme to signalise the traffic underneath the bridge, will need to confirm this.
- Referred to the 3D/4D mast erected under a S254 licence application, lack of consultation

   advised applicant granted a S254 licence with several conditions. Applicant appealed
   the condition to consult with residents to An Bord Pleanála and this condition was
   overturned.
- Group seeking assistance with Hungary Hall Community Park in becoming a Green Flag site- advised will provide assistance.
- Referred to works outside the playground and can the banks/verges be removed as wellwill carry out works if resources allow.
- Referred to the potholes that need repair advised a crew on fulltime filling potholes.
- Potholes on lane beside Fr Ryans Park need repair advised currently working on main roads in housing estates.
- Referred to a footpath blocked outside a development in Donacarney this is a matter for the developer as not taken in charge.
- Concern with the bottle banks re-located beside the playground in Duleek advised best area and will be reviewed daily by the outdoor crew.
- Members congratulated the Cathaoirleach for his assistance over the last year.

This concluded the business of the meeting.
