On the proposal of **Councillor Edward Fennessy** and seconded by **Councillor Gerry O'Connor** the revised dates for the General Municipal Allocation Meetings and Preliminary and Statutory Budget meetings were agreed.

5.1.2 To receive an update from the Chair of Meath Women's Caucus.

Councillor Maria Murphy, Chair of Meath Women's Caucus gave a verbal update on the activities of the Caucus to date.

It was noted that the Meath Women's Caucus AGM was held on Monday 3rd July in Buvinda House and a workplan for the year had been agreed including plans to host an event which will encourage women with an interest in politics to consider getting involved. A funding application has been made to fund the event and other activities of the Caucus. In addition, the following officers were elected: Chairperson Councillor Maria Murphy, Vice Chairperson Councillor Aisling Dempsey, Secretary Councillor Sarah Reilly, PRO Councillor Yemi Adenuga.

The Caucus welcomed Ms. Jenny Rispin, Interim Manager of the Meath Ladies Football Team to Buvinda on Monday July 10, where she shared her experience and future plans to develop women's participation in sport in Meath and beyond.

5.2 Finance

5.2.1 To consider the report of the Chief Executive prepared in accordance with the provisions of the Local Property Tax (Local Adjustment Factor) Regulations 2022





For the purpose of resolving as follows:

- a) Vary the basic rate and set a local adjustment factor that will apply for a period as specified by the resolution, or
- b) Not vary the basic rate

Ms. Sheila Harkin, Acting Head of Finance provided details of the four reports that were to be considered in accordance with the Local Property Tax (Local Adjustment Factor) Regulations 2022. It was noted that the public consultation period took place from July 5, 2023 to August 7, 2023 and 23 submissions were received. It was further noted that every 1% of variation would impact the budget in the sum of €186,512 and that there was a preliminary gap of €2,157,421 in the estimate of income and expenditure for next year.

There were interventions not to vary the basic rate from Councillors Gerry O'Connor; Brian Fitzgerald; Damien O'Reilly; Ronan Moore; Mike Bray; Gillian Toole; Elaine McGinty; David Gilroy; Padraig Fitzsimons and Alan Tobin. There were interventions to decrease the basic rate from Councillors Michael Gallagher; Alan Lawes and Emer Tóibín. Councillor Paddy Meade indicated that he would support an increase in the basic rate if the additional funds were ringfenced for the winter gritting programme.

An Cathaoirleach, Councillor Tommy Reilly attended at 2.30pm and presided over the meeting.

The following proposals were put forward:

Councillor Michael Gallagher proposed to decrease the basic rate by 10%, this was seconded by **Councillor Alan Lawes**.

Councillor Damien O'Reilly proposed not to vary the basic rate, this was seconded by **Councillor Gerry O'Connor**.

Councillor Paddy Meade proposed to increase the rate by 5%.

Councillor Emer Tóibín proposed to decrease the basic rate by 5%.

6.2 Report from the Corporate Policy Group

"How much is owed to Meath County Council in rent arrears for its residential properties in tabular format per year, for the last three years?"

Response

The table below details the rent arrears as per the Annual Financial Statements for the years 2022, 2021 and 2020.

Although the value of arrears for 2022 has increased Meath's percentage collection rate of 86% is in line with the national average. A programme of work has been implemented to address the housing rent arrears including:

- Face to face engagement with tenants with the highest level of arrears to agree an affordable payment plan;
- Development and roll out of payment app and automatic enrolment of new tenants onto the app;
- Enhanced early interventions mechanisms with tenants who fall into arrears;
- Progress cases through the legal process;
- Ongoing debt management development of systems, training and reporting.

8.2 Submitted by Councillor Wayne Harding

"Can I ask for an up to date progress report on the Boyne Greenway?"

Response

Detailed work has been ongoing for a considerable time on finalising the preferred option for the Boyne Greenway and Navigation Scheme. The announcement of a preferred option has been delayed and further work and consultations with stakeholders are being undertaken to inform the decision-making process. This further work is principally concerned with more accurately defining the significance of flooding risk. This work is now largely completed, however, there are a number of other tasks remaining before the preferred option will be announced, which I anticipate will be in Q4 2023. Following this announcement there will be engagement with the public and then the preliminary design





and environmental studies/reports for the preferred option will be developed with a view to bringing an application forward for statutory planning approval.

8.3 Submitted by Councillor Alan Tobin

"In respect of the provisions of the Councils Parks Bye Laws 2014 relating to restricted breeds of dog and no dogs allowed, how many inspections have taken place in parks and playgrounds under the Councils control and how many enforcement proceedings have been initiated in 2023 under these bye-laws?"

Response

The Councils Parks Bye Laws 2014 regulating the use and enjoyment of Parks, Playgrounds, Playing Pitches and Multi Use Games Areas under its control provides:

"A person shall not cause or allow any dangerous dog, as defined in the Control of Dogs (Restriction of certain dogs) Regulations, 1991 and 1998 or any subsequent amending Regulations or Act, in their charge to enter or remain in the park unless such dog is kept on a strong lead (only up to 2 metres long) by a person over 16 years of age who is capable of controlling them. The dog/s must be securely muzzled and no person shall, in any portion of the park where a notice prohibiting the admission of dogs, (other than guide dogs or dogs used by members of An Garda Síochána in the course of their duties) is exhibited, cause or allow any dog in their charge to enter or remain there."

The Council currently has one full time Dog Warden and three further Wardens, two of whom combine dog control and litter/waste management duties, and while their dog control related duties are primarily taken up with responding to complaints from members of the public including complaints about incidents in the parks and playgrounds, they also as time permits, carry out patrols and spots checks in these locations and generally in areas which are subject to the greatest footfall.

The Council has not initiated any enforcement proceedings to date in 2023 on foot of such patrols, but Wardens generally advise dog owners of their responsibilities and point to the provisions of the Bye Laws and find in the majority of cases that this approach works.

As previously advised in response to recent dog control notice of motions/questions, the Minister for Agriculture and the Minister for Rural and Community Development established a working group to examine relative legislative and enforcement issues and specifically look at dangerous breeds, fines, the provision of dog wardens, microchipping,





promoting responsible dog ownership and licences and the Council await the outcomes from this process.

Councillor Alan Tobin expressed his disappointment with the response.

8.4 Submitted by Councillor Alan Lawes

"How long does it take the Council to assess and then to accommodate homeless people after they first make contact?"

Response

The time taken to assess and then accommodate a person experiencing homelessness depends on the complexity of the individual case and the availability of suitable accommodation.

In the more complex cases the Council's Homeless Settlement team is required to engage with other state agencies such as TUSLA, the HSE, the Probation Service or the Prison Service which will impact on the time required to achieve a placement. The availability of accommodation for the more complex cases is also a factor as not all providers will have the capability to handle such cases.

In conclusion the length of time from initial contact to placement in accommodation varies considerably depending on the individual circumstances of each case.

8.5 Submitted by Councillor Trevor Golden

"Can we have an update on the HVO trial please?"

Response

In April 2024, Meath County Council commenced a trial with 10 vehicles of various sizes, ranging from a small van up to a large truck. During this trial there were no issues reported with any of the vehicles and the feedback from the drivers shows no difference to driving performance or fuel usage. By the start of August, 5,827 litres of HVO had been used, resulting in a reduction of CO2 of 16,222kg which is the equivalent to an 88% reduction in CO2 emissions.





Odometer readings are being used for each vehicle on the trial to generate the MPG for each vehicle to assess the efficiency of each vehicle and compare against other similar vehicles.

As part of the trial, 9,000 litres of HVO was ordered and this is expected to be fully utilised by mid to late September. Following the completion of the trial, the costs and performance will be assessed.

Further clarification was sought by **Councillor Alan Lawes**, and response provided by Mr. Dara McGowan.

The response was noted by the Elected Members

9 Notice of Motion

An Cathaoirleach noted that Councillor Damien O'Reilly had requested that Item 10.2 of the Agenda be dealt with first. In accordance with Item 11.3 of the Standing Orders this was agreed unanimously by the Elected Members present and voting.

Councillor Damien O'Reilly introduced the motion noting that the self-build scheme was a good scheme and should be extended to those who opt to self-build. The motion proposed by **Councillor Damien O'Reilly** and seconded by **Councillor Tommy Reilly** was agreed.

9.1 Submitted by Councillor Edward Fennessy

"To call on Meath County Council to install the Tier Nextbike rental scheme on the Boyne to Lakelands Greenway without delay."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The recently launched Bike Rental Scheme for Navan is a 12-month pilot project which seeks to promote and encourage the uptake in active travel in and around the town of Navan. The scheme has been met with great enthusiasm to date, and uptake and usage levels have to date exceeded the operators' expectations for the initial period of its introduction.

The pilot scheme limits the extents of the bike hire operation to the town boundaries, as the logistics involved in the delivery and operation of a viable bike rental scheme extended further, to include a greenway, would require a significantly greater level of resources to efficiently operate and maintain. The current boundaries do not unfortunately encompass the new Boyne to Lakelands Greenway.





Meath County Council intends to undertake a review of the operation and viability of the current scheme prior to the expiry of the 12-month pilot.

Councillor Edward Fennessy introduced the motion and noted the success of the Tierbike Scheme in Navan to date. There were interventions from Councillors Paddy Meade; Alan Tobin; Padraig Fitzsimons and Yemi Adenuga. There were calls for a county-wide scheme and some concern was expressed that this could lead to calls for the scheme to be extended to other areas including parks. Responses to queries raised were provided by Mr. Martin Murray.

The motion proposed by **Councillor Edward Fennessy** and seconded by **Councillor Paddy Meade** was agreed.

9.2 Submitted by Councillor Michael Gallagher

"That Meath County Council, in conjunction with the Office of Public Works and any other relevant agencies, investigate and find solutions to areas that are at high risk to flooding within the County and that priority is given to areas where residents are at risk of flooding".

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The Office of Public Works (OPW) is the national authority for the implementation of the EU Floods Directive and are the lead agency for flood risk management in Ireland.

In 2018 the OPW completed the largest study of flood risk ever undertaken by the State to establish those communities that are at risk from significant flood events -this provided the roadmap for the delivery of Government investment in flood relief schemes and €1.3 billion has been committed over the lifetime of the National Development Plan to 2030 to protect approximately 23,000 properties in threatened communities from river and coastal flood risk.

This study known as the Catchment Flood Risk Management Programme (CFRAM) resulted in the production of indicative flood maps and catchment-based Flood Risk Management Plans (FRMPs) and involved extensive public consultation and engagement with local authorities, the Environmental Protection Agency and other relevant departments and bodies in accordance with national flood policy and the EU Floods Directive.

Meath County Council work closely with the OPW when they are designing and delivering major flood relief schemes and examples being such schemes in Ashbourne and Northlands, Bettystown. In addition, the OPW also provide funding to Local Authorities under Minor Flood Mitigation Works and Coastal Protection Schemes and Meath County





Council has identified a number of projects and have ongoing discussions with the OPW about future projects that can be delivered from this funding stream.

Councillor Michael Gallagher introduced the motion noting the risks of flooding in some parts of the county.

Councillor Sharon Tolan proposed an amendment which was seconded by **Councillor Tom Behan** as follows:

"That Meath County Council, in conjunction with the Office of Public Works and any other relevant agencies, investigate and find solutions to areas that are at high risk to flooding within the County and that priority is given to Bettystown where residents continue to be at risk"

There were interventions on the proposed amendment from Councillors Paddy Meade; Alan Tobin; Wayne Harding; Brian Fitzgerald; Tom Behan and Gillian Toole. There were concerns raised that the motion should not become parochial and that any flood mitigation works should be undertaken on a county-wide risk basis.

The amended motion fell on a show of hands vote with 6 votes in favour and 15 against.

The motion proposed by **Councillor Michael Gallagher** and seconded by **Councillor Edward Fennessy** was agreed.

9.3 Submitted by Councillor Alan Lawes

"I am calling on Meath County Council to assess and accommodate homeless people within 48 hours of them first making contact."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The time taken to assess and then accommodate a person experiencing homelessness depends on the complexity of the individual case and the availability of suitable accommodation.

In the more complex cases the Council's Homeless Settlement team is required to engage with other state agencies such as TUSLA, the HSE, the Probation Service or the Prison Service which will impact on the time required to achieve a placement. The availability of accommodation for the more complex cases is also a factor as not all providers will have the capability to handle such cases.

While the Settlement Team works to provide accommodation solutions as quickly as possible for those households in need of assistance, it is not practicable, given the complexities involved, to impose an arbitrary 48-hour deadline on this process.





Councillor Alan Lawes introduced the motion noting that a minimum standard for assessing and accommodating homeless people should be set at 48 hours. There were interventions from **Councillors Sarah Reilly; Alan Tobin** and **Emer Tóibín**. Concerns were raised on the feasibility of implementing the motion including the complexities of homeless cases and the difficulties in sourcing emergency accommodation.

Councillor Brian Fitzgerald proposed an amendment which was seconded by **Councillor Tommy Reilly** as follows:

"To call on Meath County Council to make every effort to assess and accommodate homeless people within 48 hours of them first making contact"

Councillors Gillian Toole and **Alan Lawes** supported the amended motion.

On the proposal of **Councillor Alan Lawes** and seconded by **Councillor Edward Fennessy** the motion, as amended, was agreed.

10 General Interest Motions

10.1 Submitted by Councillor Emer Tóibín and Councillor Gillian Toole (Deferred from June and July Council Meetings)

"That Meath County Council calls on the government to create a fair, just and humane asylum application process that helps those in need and identifies those who falsely apply for asylum."

The motion was introduced by **Councillor Gillian Toole. Councillor Emer Tóibín** supported the motion.

Councillor Yemi Adenuga proposed an amendment which was seconded by **Councillor Maria Murphy** as follows:

"The Meath County Council calls on the Government to review, with a view to improving, the current asylum application process in order to better deal with asylum applicants in Ireland."

There were interventions on the amended motion from Councillors Aisling Dempsey; Noel French; Alan Lawes; Alan Tobin; Emer Tóibín and Gillian Toole.

On the proposal of **Councillor Gillian Toole** and seconded by **Councillor Emer Tóibín**, the motion, as amended, was agreed.

10.2 Submitted by Councillor Damien O'Reilly





"I call on Meath County Council to write to Darragh O'Brien TD - Minister for Housing, Local Government and Heritage to request his department to extend the First Home Scheme for self-build one off rural homes."

10.3 Submitted by Councillor Tom Behan

"That Meath County Council support the reintroduction of the 9% Vat rate for food related businesses and that they write to the Minister for Finance calling on him to extend the 9% vat rate to the end of 2024."

It was agreed that Motions 10.3 and 10.4 would be considered together.

An Cathaoirleach Councillor Tommy Reilly left the meeting at 5.08pm and the Leas-Chathaoirleach, Councillor Paul McCabe presided in his absence.

Councillor Tom Behan introduced the motion. He outlined the average duration of a tourist visit and noted that the majority of spending was on accommodation and dining expenses. He noted that any savings in VAT would be passed onto the consumer.

There were interventions from Councillors Noel French; Alan Tobin; Wayne Harding; Gerry O'Connor; Nick Killian; Alan Lawes; Padraig Fitzsimons and Maria Murphy. The current difficulties for the hospitality sector were noted.

The motion proposed by **Councillor Tom Behan** and seconded by **Councillor Wayne Harding** was agreed on a show of hands vote with 19 in favour and one against.

10.4 Submitted by Councillor Noel French

"That Meath County Council call on the Minister for Finance to reintroduce the 9% vat rate for food related hospitality businesses."

The motion proposed by **Councillor Noel French** and seconded by **Councillor Alan Tobin** was agreed in accordance with Item 10.3 above.

10.5 Submitted by Councillor Helen Meyer

"That Meath County Council write to Darragh O'Brien TD, Minister for Housing, Local Government and Heritage to request that he increase the maximum grant payable for homes older than 12 months, under the Housing Adaptation Grant for people with





disabilities from €30,000 to €40,000 and to increase the central funding of €83 million for Housing Adaptation Grants for people with a disability to €150 million in 2024."

An Cathaoirleach, Councillor Tommy Reilly returned at 5.18pm and presided over the meeting.

Councillor Helen Meyer introduced the motion and noted that due to increased construction costs the current maximum grant was insufficient. There were interventions from **Councillors Sarah Reilly** and **Nick Killian.** The benefits of the scheme and its administration locally were commended.

The motion proposed by **Councillor Helen Meyer** and seconded by **Councillor Edward Fennessy** was agreed.

10.6 Submitted by Councillor Sharon Tolan

"To call on the Minister for Higher and Further Education, Research, Innovation and Science, Simon Harris TD to reform the method by which SOLAS currently allocate college placements to apprentices, and to introduce a system that will ensure greater flexibility for apprentices when offered a placement that may not suit their needs."

Councillor Sharon Tolan introduced the motion and noted the increased numbers availing of apprenticeship schemes across a myriad of trades. She further noted that the scheme should take cognisance of personal costs, as well as accommodation costs when allocating college placements. **Councillor Alan Tobin** acknowledged the success of the apprenticeship model.

The motion proposed by **Councillor Sharon Tolan** and seconded by **Councillor Gerry O'Connor** was agreed.

10.7 Submitted by Councillor Maria Murphy

"That Meath County Council calls on the Minister for Housing, Local Government and Heritage Darragh O'Brien to resolve the issue caused whereby some financial institutions are refusing to approve mortgages to applicants for properties where there is a 2nd charge on the property.

Councillor Maria Murphy introduced the motion and noted that some financial institutions were refusing mortgage applicants on the basis that there was a second charge on the property. There were interventions from **Councillors Gerry O'Connor; Mike Bray** and **Gillian Toole.** Clarifications were provided by Mr. Barry Lynch.





Councillor Maria Murphy proposed an amendment which was seconded by **Councillor Gerry O'Connor** as follows:

"We call on Meath County Council to resolve the issue caused whereby some financial institutions are refusing to approve mortgages to applicants for properties where there is a 2nd charge on the property."

The motion proposed by **Councillor Maria Murphy**, seconded by **Councillor Gerry O'Connor**, as amended, was agreed.
