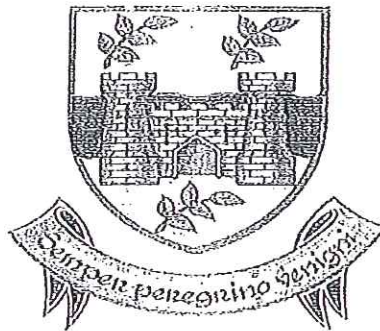


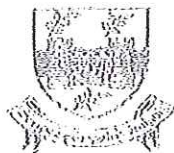

## CAR PARKING BYE-LAWS, 2007

### Part 1: PRELIMINARY

- Long Title:** Trim Town Council (hereinafter referred to as "the Council") in exercise of the powers conferred on them by the Road Traffic Acts 1961 – 1968 as amended by the Road Traffic Act, 1994 (No. 7 of 1994), Local Government Act, 1994 and the Local Government Act, 1994 (Bye-laws) Regulations, 1995 hereby make the following Bye-Laws as to the use of car parks provided by them adjoining the public roads as set out in the definition of "car park" in Bye-Law 5 of these Bye-Laws.
- Citation:** 1. These bye-laws may be cited as the Trim Town Council Car Parking Bye-Laws, 2004-2007.
- Commencement:** 2. These bye-laws shall come into operation on the \_\_\_ Day Of \_\_\_ 2007. (to be confirmed)
- Area of Application:** 3. These bye-laws apply to the car parks defined in the schedule attached hereto.
- Revocation/Repeals:** 4. Trim Urban District Council Car Parking Bye-Laws, 1987 are hereby revoked.
- Interpretation:** 5. In these Bye-Laws:
- "car park" means a place, not being part of the public road, which is maintained by the Council, for the parking of mechanically propelled vehicles;
- "casual trading" has the meaning assigned to it by Section 2 of the Casual Trading Act, 1995;
- "Council" means Trim Town Council;

“disabled persons permit” means a permit issued under Article 43 of the Regulations of 1997;

“information plate” means an information plate which indicates the period during which a valid Pay & Display Parking Ticket must be displayed, the maximum parking period, and the fee for a Pay & Display Parking Ticket;

“Local Authority” means the Trim Town Council.

“parking bay” means a space in a car park intended for the parking of one vehicle or where space is intended for the parking of motorcycles of more than one vehicle and so indicated by surface or other signs or marking;

“the Act of 1994” means the Road Traffic Act, 1994 (No. 7 of 1994);

“the Regulations of 1997” means the Road Traffic (Traffic and Parking) Regulations 1997 (S.I. No. 182 of 1997);

“the Signs Regulations of 1997” means the Road Traffic (Signs)(Amendment) Regulations 1997 (S.I. No. 181 of 1997).

## Part 2:

### GENERAL

6. A person shall not use a car park for any purpose other than for the parking of a mechanically propelled vehicle.
7. A vehicle shall not be parked in a car park for any period exceeding eighteen hours in any period of twenty four hours.
8. A person shall not park or cause to be parked in a car park a vehicle in such condition or in such circumstances that it would cause or be likely to cause danger to other persons using the car park or to obstruct the entrance to or exit from the car park or to obstruct the free flow of traffic within the car park.
9. A person shall not park or cause to be parked in a car park a vehicle in such a position that it or any portion of it extends from one parking bay to another.

10. A person shall not overhaul or carry out repairs to a vehicle while it is parked in a car park save where it is necessary to do so in order to enable the vehicle to be removed from the car park.
11. (a) A vehicle while parked in a car park shall not be used for advertising purposes or the sale of goods, tickets, or any service in or from the vehicle or as an office, nor shall any such vehicle be offered or displayed for sale or for hire or as a prize.  
  
(b) This bye-law shall not operate so as to prohibit casual trading in accordance with the Casual Trading Act, 1995.
12. A person shall not make any unnecessary noise by means of or in relation to a vehicle while it is parked in a car park or by means of any equipment, fitting or instruments fitted to or carried on the vehicle or any loudspeaker or radio in or on or in any way connected with the vehicle.
13. A person shall not throw, place or leave any bottle or any broken glass, nail, litter or other substance in a car park, and no person shall at any time play ball or any game in the car park.
14. Every person using a car park shall comply with any lawful direction given by an agent, officer or employee of the Council, or a member of the Garda Siochana, in relation to the parking of a vehicle in, or its removal from the car park or in relation to any of these bye-laws.
15. A person shall not in any car park willfully obstruct, disturb, interrupt or annoy an agent, officer or employee of the Council, or a member of the Garda Siochana in the execution of his or her duty, including the execution of any work in connection with the laying out or maintenance of any part of a car park by Council staff or agents.
16. A person shall give on demand to an agent, officer or employee of the Council or a member of the Garda Siochana his or her name and address and a person shall not in any car park resist, obstruct or aid or incite any person to resist or obstruct any agent, officer or employee of the Council or a member of the Garda Siochana in the execution of his or her duty or lawful exercise of his or her authority.

17. Where a person is requested by an agent, officer or employee of the Council or a member of the Garda Siochana to leave a car park the person shall comply with such request.
18. An agent, officer or employee of the Council shall produce, if requested to do so, evidence of his or her identity and employment by the Council to any person alleged by him or her to be in breach of these bye-laws or who has been requested to leave a car park under these bye-laws.

19. A vehicle shall not be parked in a car park
  - (a) on that side of a section of roadway in a car park, along the edge of which traffic sign number RRM008 (double yellow lines) has been provided;
  - (b) on a footway, grass margin, clearway, or a median strip within the car park;
  - (c) on a part of the car park which is a casual trading area, during hours of trading, unless the vehicle is, for the time being, in use for the purposes of casual trading. Casual trading in Trim is on Fridays on Market Street. A map showing the casual trading area is attached to these bye-laws.

#### Conditions for parking in Pay & Display Ticket Parking Car Parks

20. A vehicle which is parked in a car park in accordance with these bye-laws shall, where parking bays are provided at that car park, be parked within the area comprising the parking bay.

#### Disabled persons parking bays

21.
  - (1) Subject to paragraph (2) of this bye-law, where traffic sign number RRM015 (Disabled Persons Parking Bay) is provided, a vehicle shall not be stopped or parked.
  - (2) Paragraph (1) of this bye-law shall not apply to a vehicle in which is *displayed* a valid disabled person's parking permit and which is parked for the convenience of the person to whom the permit was granted.

### Long Term Car parking

22. (1) To cater for those requiring park and ride facilities  
(2) To cater for those people who are working in the town and require parking on a long term basis (i.e. all day).  
(3) Long Term permits will be available for those car parks listed on the schedule attached and maybe available on Monthly, Bi-monthly, Quarterly and Annually.

### Long Term Car Parking within Short Stay Car parks

23. A Number of spaces maybe designated within Haggard Street/Emmet Street Car Parks for long term parking issued at the discretion of the Town Clerk upon application. These spaces will require a permit similar to Bye-law 22. Once these spaces are occupied permit holders will be permitted to use the long term parks as designated.

## Part 3: PAY AND DISPLAY TICKET PARKING

### Parking System Definition:

24. "Pay & Display Ticket Parking Car Park" means a car park where the parking of vehicles is subject to the exhibition of A valid Pay & Display Parking Ticket in accordance with these bye-laws and which is indicated by an information plate.

"Pay & Display Parking Ticket" means a parking ticket issued by the Council by means of a pay and display parking ticket machine which contains the following particulars.

- (a) the words "Trim Town Council"
- (b) the fee paid in respect of the ticket
- (c) the date and time of issue of the ticket
- (d) the time of expiry of the ticket
- (e) the street or place where the ticket is issued

"Pay and Display Parking Ticket Machine" means a machine provided by the Council which is capable of automatically delivering a pay and display parking ticket when the appropriate parking fee as indicated on the information plate is inserted into the machine.

"Valid Pay and Display Parking Ticket" means a pay and display parking ticket, which has not expired.

“valid parking permits” means a parking permit which has been issued by the Council, which indicates the day on which it was issued, the parking period it covers, the Pay & Display Ticket parking car park it relates to, the registration number of the vehicle to which it relates to and any other information that the Council may decide as relevant.

#### Free Parking Place

25. This bye-law applies to a vehicle which is parked in a free parking place.
- (a) A free parking space shall be indicated by signs or other markings which shall contain the words “Free Parking Space”.
  - (b) Bye-law 24 shall not apply to a vehicle which is parked in a free parking space.
  - (c) Free parking space will in the main be for residents who reside within the areas of these bye-laws. A special permit may be issued in such cases.

#### Bus Parking

26. This Bye Law applies to the area know as Finnegan’s Way Bus Parking area
- (a) Free Parking is available in this area for Coaches, Buses and Mini Buses only
  - (b) No other vehicles of any description are permitted to park in this area at any time of the day.
  - (c) State Vehicles while carrying out essential works maybe permitted to park in this area once prior notification is given to Trim Town Council

#### Obligations to display valid pay & display parking ticket in pay & display ticket parking car park

27. Where a vehicle other than a motorcycle is parked in a Pay & Display Ticket parking car park,
- (a) there shall be exhibited in the interior of the vehicle so long as the vehicle is parked, a valid pay & display parking ticket.
  - (b) the valid pay & display parking ticket *shall be* so exhibited in a prominent position within the interior of the vehicle that a person outside the vehicle can read the ticket.

#### Period of parking in pay & display ticket parking car park

28. (1) A vehicle parked in a pay & display ticket parking car park shall not be so parked for longer than the period indicated as the maximum parking period for that car park, or part thereof, by an information plate erected by the Council at or in such car park.

(2) The maximum period for parking in the short stay car parks between the hours of 9.00 and 18.00 hours is two hours.

#### **Interference with Pay & Display Parking Ticket Machine and a Pay & Display Parking Ticket**

29.

- (1) Where a vehicle is parked in a Pay & Display Ticket parking car park in compliance with these bye-laws a person shall not interfere with a Pay & Display Parking Ticket exhibited in the vehicle;
- (2) A person shall not damage a Pay & Display Parking Ticket Machine;
- (3) A person who is not an agent of the Local Authority, a member of the Garda Síochána in uniform, an authorised person or a traffic warden, shall not interfere with a Pay & Display Parking Ticket Machine;
- (4) A person shall not insert into a Pay & Display Parking Ticket machine any coin or object other than a coin or coins required to pay the fee.

#### **Removal of vehicle from Pay & Display Ticket Parking Car Park**

30. A vehicle parked in a Pay & Display Ticket parking car park at a time other than the time or times indicated in accordance with the information plate, shall be removed from the Pay & Display Ticket parking car park when the period of Pay & Display Ticket parking indicated as aforesaid commences, unless at such commencement and during the remainder of the period of parking, a valid Pay & Display Parking Ticket is exhibited in the interior of the vehicle.

#### **Issue of Pay & Display Parking Tickets**

31. Pay & Display Parking Tickets shall be made available by the Council through the provision of Pay & Display Parking Ticket Machines which are provided at designated locations as authorised by the Council within each car park. This does not preclude the display of a ticket from a machine from an adjacent street or another car park in the event of a machine being inoperable for a period.

#### **Parking Fees**

32. The fee for a Pay & Display Parking Ticket for parking in a Pay & Display Ticket parking car park shall be that as stated on the authorised information plate or such other fee as may be determined by the Council.



**Disabled persons permits**

33. Where a disabled person holds a "disabled persons permit" issued under Article 43 of the Regulations of 1997, bye-law 24 and bye-law 27 of these bye-laws shall not apply to a specified vehicle parked for the convenience of the person to whom that permit was granted once this permit is clearly displayed within that vehicle.

**Pay & Display Ticket parking car park permits**

34. The Council may issue parking permits for parking within designated areas in Pay & Display ticket parking car parks. The display of this permit shall exempt the owner of the vehicle described on the permit, from bye-law 24 and bye-law 27 of these bye-laws once this permit is displayed

**Display of valid parking permits**

35. A valid parking permit shall be so displayed in a prominent position within the interior of the vehicle in respect of which it was issued, that it can be read from outside the vehicle.

**Schedules**

36. The attached schedule outlines the various periods of parking allowed within the area of these bye-laws.

### AMENDED PARKING PLACES BYE-LAWS, 2007

#### Part 1: PRELIMINARY

**Long Title:** Trim Town Council (hereinafter referred to as "the Council") in exercise of the powers vested in them by Section 36 of the Road Traffic Act, 1994 (No. 7 of 1994) and having consulted with the Commissioner of the Garda Síochána, hereby makes the following Bye-Laws:-

- Citation:** 1. These bye-laws may be cited as the Trim Town Council Parking Places Bye-Laws, 2007.
- Commencement:** 2. These bye-laws shall come into operation on the Day of 2007.( to be confirmed)
- Area of Application:** 3. These bye-laws apply to the on street parking places as defined in the first schedule attached hereto.
- Revocation/Repeals:** 4. Trim Urban District Council Parking Places Bye-laws 1987 are hereby revoked.
- Interpretation:** 5. In these Bye-Laws:
- "the Act of 1994" means the Road Traffic Act, 1994 (No. 7 of 1994);
- "disabled persons permit" means a permit issued under article 43 of the Regulations of 1997;
- "goods vehicles" has the meaning assigned to it in article 3 of the Regulations of 1997;
- "parking bays" has the meaning assigned to it in Article 18 of the Signs Regulations of 1997;
- "public road" has the meaning assigned to it by Section 2 (1) of the Roads Act 1993 (No. 14 of 1993);

“public road” has the meaning assigned to it by Section 2 (1) of the Roads Act 1993 (No. 14 of 1993);

“Council” means Trim Town Council;

“disabled persons permit” means a permit issued under Article 43 of the Regulations of 1997;

“street” means a public road;

“local authority” means the Trim Town Council;

“the Regulations of 1997” means the Road Traffic (Traffic and Parking) Regulations 1997 (S.I. No. 182 of 1997);

“the Signs Regulations of 1997” means the Road Traffic(Signs) (Amendment) Regulations 1997 (S.I. No. 181 of 1997);

“information plate” means an information plate accompanying traffic sign RUS018, which indicates the period during which a valid Pay & Display Parking Ticket must be displayed, the maximum parking period, and the fee for a Pay & Display Parking Ticket.

## Part 2: GENERAL

6. Every person using a on street parking shall comply with any lawful direction given by an agent, officer or employee of the Council, or a member of the Garda Siochana, in relation to the parking of a vehicle in, or its removal from the car park or in relation to any of these bye-laws.
7. A person shall not willfully obstruct, disturb, interrupt or annoy an agent, officer or employee of the Council, or a member of the Garda Siochana in the execution of his or her duty, including the execution of any work in connection with the laying out or maintenance of any part of a car park by Council staff or agents.
8. A person shall give on demand to an agent, officer or employee of the Council or a member of the Garda Siochana his or her name and address and a person shall not in any car park resist, obstruct or aid or incite any person to resist or obstruct any

agent, officer or employee of the Council or a member of the Garda Síochána in the execution of his or her duty or lawful exercise of his or her authority.

9. Where a person is requested by an agent, officer or employee of the Council or a member of the Garda Síochána to leave an area the person shall comply with such request.
10. An agent, officer or employee of the Council shall produce, if requested to do so, evidence of his or her identity and employment by the Council to any person alleged by him or her to be in breach of these bye-laws or who has been requested to leave a car park under these bye-laws.

11. A vehicle shall not be parked on a street/road
  - (a) on that side of a section of roadway in a car park, along the edge of which traffic sign number RRM008 (double yellow lines) has been provided;
  - (b) on a footway, grass margin, clearway, or a median strip.

### **Part 3: PAY AND DISPLAY TICKET PARKING**

#### **Parking System: (Pay and Display Ticket Parking)**

“Pay and Display Parking Ticket” means a parking ticket issued by the Local Authority by means of a pay and display parking ticket machine which contains the following particulars.

- (a) the words “Trim Town Council”
- (b) the fee paid in respect of the ticket
- (c) the date and time of issue of the ticket
- (d) the time of expiry of the ticket
- (e) the street or place where the ticket is issued

“Valid Pay and Display Parking Ticket” means a pay and display parking ticket issued by the Local Authority, which has not expired.

“Pay and Display Parking Ticket Machine” means a machine provided by the Local Authority capable of automatically delivering a pay and display parking ticket when the appropriate parking fee prescribed by these Bye-Laws is inserted into the machine.

“Pay & Display Ticket parking place” means a place on a public road where parking of vehicles is subject to the exhibition of a valid Pay & Display Parking Ticket in accordance with these bye-laws and which is indicated by traffic sign no. RUS018 authorised by the

Signs Regulations of 1997, accompanied by an information plate and traffic sign no. RRM016 as per Article 20 of the Signs Regulations of 1997.

**Obligation to display valid Pay & Display Parking Ticket in a Pay & Display Ticket Parking Place**

- 12.(1) (a) A valid pay and display parking ticket shall be displayed as specified in this bye-law on the interior of a vehicle lawfully parked in a pay and display ticket parking place during operational hours.
- (b) the valid pay and display parking ticket *shall* be so exhibited in a prominent position within the interior of the vehicle that a person outside the vehicle can ascertain when the parking ticket ceases to be valid and,

- (c) the pay and display parking ticket shall be exhibited in accordance with paragraph (2) of this bye-law for so long as the vehicle is parked in that Pay & Display ticket parking place.
- (2) Where a vehicle being parked in a Pay & Display Ticket parking place is a goods vehicle being so parked solely for the loading or unloading of goods, paragraph (1) of this bye-law shall not apply until the expiration of 30 minutes after the commencement of the parking.
- (3) Where a vehicle which had been parking in a Pay & Display Ticket parking place for a period less than the maximum parking period indicated in accordance with bye-law 8 of these bye-laws for that Pay & Display Ticket parking place, is subsequently lawfully parked in another Pay & Display Ticket parking place on that same day, it shall not be necessary subject to compliance with paragraph (1) (b) and (1) (c) of this bye-law to comply with paragraph (1) (a) of this bye-law.

**Period of parking in Pay & Display Ticket Parking Place**

- 13 (1) A vehicle parked in a Pay & Display Ticket parking place shall be so parked in accordance with the provision relating to parking times specified in this bye-law for that Pay & Display Ticket parking place and indicated by means of an authorised information plate accompanying traffic sign number RUS018 authorised by the Signs Regulations of 1997.
- (2) The provisions relating to parking times for a Pay & Display Ticket parking place referred to in paragraph (1) of this bye-law and to be indicated by means of an authorised information plate are the hours of the day during which Pay & Display Ticket parking shall operate and the maximum period for which a vehicle may park in a Pay & Display Ticket parking place.

- (3) The maximum period of parking in a Pay & Display ticket parking place between the hours of 9.00 and 18.00 hours is two hours, except on Sections of Emmet Street and Summerhill Road where the maximum stay shall be 1 hour.
- (4) Where a vehicle which has been lawfully parked in a Pay & Display Ticket parking place is subsequently parked in another Pay & Display Ticket parking place the period to which the subsequent parking is restricted by paragraph (1) of this bye-law shall be reduced by a period equal to the period from the time indicated on the Pay & Display Parking Ticket to the time when the subsequent parking commenced.

#### **Interference with a Pay & Display parking ticket machine and a Pay and Display Parking Ticket**

14. (1) Where a vehicle is parked in a Pay & Display Ticket parking place in compliance with these bye-laws a person shall not interfere with a Pay & Display Parking Ticket exhibited in the vehicle;
- (2) A person shall not damage a Pay & Display Parking Ticket Machine;
- (3) A person who is not an agent of the Local Authority, a member of the Garda Síochána in uniform, an authorised person or a traffic warden, shall not interfere with a Pay & Display Parking Ticket Machine;
- (4) A person shall not insert into a Pay & Display Parking Ticket Machine any coin or object other than a coin or coins required to pay the fee prescribed by bye-law (13) of these bye-laws.

#### **Removal of vehicle from Pay & Display Ticket Parking Place**

15. A vehicle parked in a Pay & Display Ticket parking place at a time other than the time or times indicated in accordance with bye-law 8 of these bye-laws shall be removed from the Pay & Display Ticket parking place when a period of Pay & Display Ticket parking indicated as aforesaid commences, unless at such commencement and during the remainder of the period of parking, a valid Pay & Display Parking Ticket is exhibited in the interior of the vehicle in accordance with bye-law 7 (1)(b) of these bye-laws, and bye-law 7(1)(c) of these bye-laws shall apply from such commencement in respect of such parking.

#### **Prohibition on certain parking inside an hour of leaving a Pay & Display Ticket Parking Place**

16. A vehicle which had been parked in a Pay & Display Ticket parking place shall not be parked again in a Pay & Display Ticket parking place on the public road in which that Pay & Display Ticket parking place is situated until at least one hour after the vehicle last vacated that Pay & Display Ticket parking place.

#### **Issue of Pay & Display Parking Tickets**

17. Pay & Display Parking Tickets shall be made available by the Council through the provision of Pay & Display Parking Ticket Machines which are provided at designated locations as authorised by the Council on each street. This does not preclude the display of a ticket from a machine from an adjacent street or car park in the event of a machine being inoperable for a period.

#### Parking Fees

18. The fee for a Pay & Display Parking Ticket for parking in a Pay & Display Ticket Parking place shall be that as stated on the authorised information plate or such other fee as may be determined by Trim Town Council.

#### Method of payment of parking fees

19. Where a Pay & Display Parking Ticket is obtained from a Pay & Display Parking Ticket machine, the fee shall be paid by the insertion of the appropriate amount in the machine as required by bye-law 13 of these bye-laws.

#### Conditions for parking in Pay & Display Ticket Parking Place

20. A vehicle which is parked in a Pay & Display Ticket parking place in accordance with these bye-laws shall, where parking bays are provided at that Pay & Display Ticket parking place, be parked within the area comprising the parking bay.

#### Disabled persons permits

##### Disabled persons parking bays

21. (A) (1) Subject to paragraph (2) of this bye-law, where traffic sign number RRM015 (Disabled Persons Parking Bay) is provided, a vehicle shall not be stopped or parked.
  - (2) Paragraph (1) of this bye-law shall not apply to a vehicle in which is *displayed* a valid disabled person's parking permit and which is parked for the convenience of the person to whom the permit was granted.
21. (B) Where a disabled person holds a "disabled persons permit" issued under Article 43 of the Regulations of 1997, bye-law 7 and bye-law 10 of these bye-laws shall not apply to a specified vehicle parked for the convenience of the person to whom the permit was granted, once the said permit is clearly displayed in a prominent position within



the interior of the vehicle so that a person outside the vehicle can ascertain the validity of the permit. Such permits should be produced on demand to a member of an Garda Síochána or an official of the Local authority.

#### Residents permits: Definitions

22. "owner" means a resident by whom a vehicle or vehicles are habitually kept and used;

"resident" means a person whose normal residence is at premises situated in a street containing a Pay & Display Ticket parking place;

"resident's parking permit" means a document issued by a local authority for the purposes of bye-laws 18 to 24 and containing the particulars specified in bye-law 19;

"valid resident's parking permit" means a resident's parking permit which relates to a particular street or streets and to a period which has not expired and which is issued by the local authority in whose functional area the vehicle in which the permit is displayed is parked;

"vehicle" means a private motor car, a station wagon or a passenger vehicle having accommodation for not more than seven passengers excluding the driver.

#### Non-Application of bye-laws

23. These bye-laws (except bye-law 15) shall not apply to the parking of a vehicle in a Pay & Display Ticket parking place if there is displayed, in accordance with bye-law 20 of these bye-laws, in the vehicle when it is parked, a valid resident's parking permit which relates to the street in which that Pay & Display Ticket parking place is situated.

Particulars of  
resident's parking  
permit

24. A resident's parking permit shall contain the following particulars:-

- (a) the name of the local authority by whom it is issued;
- (b) the registration number of the vehicle or vehicles in respect of which it is issued;
- (c) the date of issue;

- (d) the period to which it relates, including the date of expiry;
- (e) the street or streets to which it relates;
- (f) a copy of the signature of the officer of the local authority issuing it.

Permission to park  
vehicle displaying

25. The display, in accordance with bye-law 21 of these bye-laws of a valid residents parking permit in the vehicle in respect

residents parking permit of which the permit was issued, shall permit the owner of the vehicle (or any person using it with his/her consent) to park it without limitation as to time in a Pay & Display Ticket parking place in a street to which the permit relates.

**Display of valid resident's parking permit** 26. A valid resident's parking permit shall be so displayed in the interior of the vehicle in respect of which it is issued, that it can be read from outside the vehicle.

**Interference with resident's parking permit** 27. Where a vehicle displaying a resident's parking permit is parked in a Pay and Display Ticket parking place a person shall not interfere with the permit

**Issue of resident's parking permit** 28. (1) A resident's parking permit shall be issued by a local authority in respect of the parking of a vehicle in a Pay & Display Ticket parking place in the functional area of such local authority, to a maximum of two per household.

(2) A resident's parking permit shall be issued by a local authority in respect of the vehicle or vehicles of which the resident is the owner and shall be valid for a period of one year from the date of issue, in respect of that vehicle or those vehicles and for the street and streets to which the permit relates. This paragraph shall not be construed as enabling a resident who owns more than one vehicle to be issued with more than one resident's parking permit.

**Return and transfer of resident's parking permit** 29. (1) Where, during the period to which a resident's parking permit relates, the resident to whom it is issued ceases to reside at the address specified on the permit or ceases to be an owner by disposing of the vehicle or vehicles to which the permit relates, he shall return it to the local authority by whom the permit was issued and where the resident has not disposed of all the vehicles

to which the permit relates, the local authority, shall delete the make and registration number of the vehicle or vehicles which the resident has disposed of and return the permit to the resident.

(2) Where during the period to which a resident's parking permit relates, the resident to whom it is issued disposes of

the vehicle or vehicles to which the permit relates and substitutes another vehicle or vehicles for the vehicle or vehicles disposed of, he shall return the permit to the local authority by whom the permit was issued which, shall either insert the make and registration number of the substituted vehicle or vehicles on the permit and return the permit to the resident or issue to the resident a new permit in respect of the vehicle or vehicles which the resident now owns and such new permit shall be valid for the period specified.

**Other Exemptions** 30. These bye-laws shall not apply to:

- (a) a vehicle being used in connection with the removal of an obstruction to traffic, the maintenance improvement or reconstruction of a public road, the provision, alteration or repair of a main drain, pipe or apparatus for the supply of gas, oil, water, electricity or telephone line or the provision of a traffic sign.
- (b) a fire brigade vehicle, an ambulance or a vehicle being used by a member of the Garda Siochana in the performance of his/her duties as such member, or holders of an authorised permit issued by Trim Town Council to carry out official business.

**Residential Areas.** 31. These Bye-laws shall designate areas/streets as residential only .

- (a) Sarsfield Avenue shall be designated as a Residential Area with the parking of all other vehicles prohibited. Appropriate signage will be displayed to indicate same and residents will be issued with residents permits in accordance with Bye-laws 19-25
