RESPONSE

The Council considered the purchase of this land a number of years ago, but the purchase did not proceed for a number of reasons. The Council currently has no plans to recommence this process.

Councillor Reilly stated that refuse trucks and fire engines cannot get down the lane to residents since the installation of an external gas service to a premises which has narrowed the lane.

Dara McGowan advised that the council has no remit with this but can follow up with the energy supplier.

A valid Taking in Charge request has been received for this Estate, however the workflow for 2024 has not yet been finalised.

On the proposal of **Councillor Sarah Reilly** and seconded by **Councillor Michael Gallagher** the motion and response were noted.

Councillor Reilly said that the estate was built in two phases and a plebiscite has been submitted for the taking in charge. She asked if the works will be completed in 2024 and an outline of the works for each phase.

The members raised the following:

- Enquired if trees could be planted in Lloyd similar to the initiative where trees are given to groups to plant. advised that planting in Lloyd is part of the plan for this area.

 Initiative Advised that the works are completed and to revert back with any proposals to
 open the tower.
- Enquired if salt boxes could be left at junctions engineer advised that this is happening at junctions and estates for the public to use.
- Referred to potholes reappearing in Meath Hill engineer advised that the crew continue to fill potholes as they arise.





- Referred to the continuous flooding at Kearnstown Drumconrath. The engineer advised that
 an application for funding has been sought to alleviate the flooding at this location.
 However, as the location is a natural flood plain the issue may not be fully resolved.
- Referred to the public attending meetings and raised the issue that no canvassing or disruption to meetings is allowed.
