Meath County Council has initiated a pathway for proactive climate action with the introduction of this Climate Action Plan 2024 – 2029. To achieve success, this plan necessitates a collaborative effort from local communities, businesses, government departments, and individuals. Through commitment, collaboration and the delivery of proactive climate mitigation, adaptation, and biodiversity actions at a local level, the collective aim of a climate resilient and climate neutral County will be achieved.

Vision

Meath aims to be a climate resilient, biodiverse rich, environmentally sustainable and climate neutral economy that supports healthy lifestyles and jobs growth.

Mission

Meath County Council is committed to lead in translating the National Climate Policy into local actions through inclusive engagement, capacity building and leadership for the people of County Meath.

The targets of the Meath County Council Climate Action Plan are as follows:




Figure 1: Meath County Council's Climate Action Plan Targets




Figure 2: Co-benefits of Climate Action



Meath County Council Scope and Role on Climate Action

Meath County Council will adopt a dual focus, encompassing both an inward (organisational) and an outward (community) perspective, on building resilience to the negative impacts of climate change and in tackling the causes of climate change.

Meath County Council takes responsibility for the oversight and reduction of its organisational emissions, aligning with the established 51% reduction target for 2030 and the overarching target of attaining climate neutrality by 2050.

Figure 3: Meath County Council's Climate Role




Figure 4: Meath County Council's sphere of influence with regards to climate action

Building the Evidence Base

Ensuring climate action planning gives proper consideration to the available scientific evidence is crucial, this plan is supported by two key scientific assessments, forming a well-defined pathway for effective climate action. The Climate Change Risk Assessment was developed to understand the impacts that climate change is currently having on Meath County Council's operations and on the County of Meath and is likely to have into the future.




Figure 5: Risk Matrix showing the future changes in risk for the identified hazards within County Meath



Buildings contribute a significant proportion of the County's emissions. Optimising energy efficiency and switching to low carbon heat sources in buildings will need to be prioritised in addition to securing renewable energy infrastructure to contribute to national grid decarbonisation and deliver a low carbon alternative to fossil fuels.

The transport-related actions will support the uptake of active travel and public travel options, enable the development of electric vehicle charging infrastructure across the County and reduce the GHG emissions associated with the business and commuting travel of Meath County Council. Additionally, the promotion of sustainable travel and road safety initiatives can improve the safety of the roads and improve air quality in towns and villages throughout Meath.
