An Bealach go Baile Ghib - Amharclann an Grianstad

Sa bhliain 1937 bhog roinnt teaghlach ó na ceantair Ghaeltachta i nDún na nGall, Corcaigh, Maigh Eo, agus Ciarraí go Baile Ghib; fuair na daoine seo talamh faoin coimisiún na talún agus feiceann an clár faisnéise seo ar na cúiseanna a roghnaigh na teaghlaigh chun bogadh go Contae na Mí. Bhí 113 duine i láthair ag an scáileán ar an Mháirt 7 Márta

In 1937 a number of families from the Gaeltacht districts in Donegal, Cork, Mayo and Kerry moved to Gibbstown/Baile Ghib; these people received land under the land commission and this documentary looks at the reasons the families chose to move to Co. Meath. there were 113 people present for the screening on Tuesday 7 March.

'A Cup Of Focals' - Aine Gallagher - Leabharlann na hUaimhe

In this bilingual workshop, Aine used Irish words in a modern way to create fun and to inspire people to practice their Irish without any pressure.

The Meath County Council Gaeltacht Scholarship Awards Night took place in Buvinda House on Thursday 13th March. Singer Máire Ní Churraoin from Ráth Chairn was invited as special guest and she spoke to the students about the trip to the Gaeltacht and sang some sean-nós. Twenty-four Máire Nic Shiubhlaigh grants of €150.00 each were made available to students attending second level schools in the county. Eight Mother Columba Gibbons grants of €300.00 each were made available to students attending DEIS second-level schools; and a further 6 Máire Ní Raghallaigh grants of €300.00 each were also made available to students attending DEIS second-level schools. The grants are recoupable against fees paid at recognised residential Irish colleges during the summer of 2025.

The Gaeltacht Scholarship Scheme is supported by the Meath County Council, Irish Language and Creative Ireland programmes.

Flying the Flag for Meath







Local Lens Podcast



Affordable Housing

Meath County Council will have a new affordable housing scheme for 8 units in Effernock, Trim, Co Meath opening for applications soon.

Expressions of Interest

The Housing Department continue to collaborate with Developers and Landowners to purchase land and or properties for the provision of social and affordable housing.

Local Authority Adaptive Work Scheme (LAWWS)

- LAAWS grant funding of €614,789.19 including VAT was submitted for approval to DHLGH on 23rd January 2025.
- This includes 50 disabled persons grant units for €412,289.19 and 3 disabled persons grant extension units for €202,500.00.

- This brings the total to 53nr. LAAWS applications scheduled to be completed in 2025.
- 5nr. LAAWS applications are completed so far this year.

Housing Adaptation Grant Schemes for Older People and People with a Disability

237 applications for the value of €1,604,258.94 were approved up to 14.03.2025.

Local Authority Energy Efficiency Retrofit Programme (EERP)

Energy upgrade works are currently ongoing on 20 properties. 48 properties have been approved by the Department for the 2025 EERP Programme.

Standards in Rented Accommodation

1058 Inspections were carried out on rented properties in Meath to 28th February 2025. Of this figure, 332 were first inspections, 13 properties passed after their first inspection. 380 properties were on second inspection and of this figure 100 were compliant after inspection. Subsequent follow up inspections will be carried out to ensure compliance. The number of tenancies to be inspected by Meath County Council in 2025 has been set at 1,973 dwellings (each dwelling can only be counted once per calendar year).







Healthy Meath

The CommUnity Connects mental health resource pack was launched in Deerpark Community Hub in Carlanstown on 28th February. This resource pack was produced by collaboratively between Healthy Meath and Healthy Louth. The launch event was attended by the LCDC members, HSE reps and members of the public. The event connected into the '5 Ways to Wellbeing' by hosting taster a yoga session & mindfulness class and activator pole walking on the track outside the centre. CommUnity Connect Champion training will be rolled out in April, allowing the Champions to be advocates for mental health in their local groups and organisations.











Public Participation Network

- A first meeting between all stakeholders involved in County Meath hosting this year's National PPN Conference took place on February 26th. DRCD will support and help Meath County Council and Meath PPN in hosting the event. Monthly meetings will follow and an internal meeting with the Communications and Events team is being scheduled.
- 758 groups are registered with Meath PPN.
- Staff presented at the annual Gathering of Meath GAA Healthy Club Coordinators on February 24th and March 3rd in Dunganny. Funding, training and collaboration between clubs were highlighted as important, with many clubs seeking further advise from PPN.



Another key milestone was attendance by the team at the National Network yearly event for ISW (Integration Support Workers) and ISC (Integration Support Coordinators) in Dublin.



Age Friendly Ireland Shared Service



Age Friendly Ireland presented at an international webinar for the Association of Former WHO Staff on 'Options and opportunities for engagement of members in the WHO Global Network' on 25th February. The WHO Global Network for Age-friendly Cities and Communities currently includes over 1,700 cities and communities in 55 countries, covering over 330 million people worldwide. The objective of the webinar was to enhance the opportunities for a greater engagement of former WHO staff in local initiatives aimed at creating physical and social environments conducive to healthy ageing in cities and communities.

Training for Chairs and Vice Chairs of Older People's Councils – a programme of regional in-person training days has commenced for Chairs and Vice Chairs of Older People's Councils to support them in the roles in relation to representing the voice of older people in their communities, chairing and managing meetings, and broadening diversity among the membership. Across the country, there are almost 500 older people involved in Older People's Council Executive Committees and almost 7,000 in the wider membership. Older People's Councils are the recognised consultative bodies representing the older people's views in Ireland, particularly relation to local government and public services.

The 2024 annual report for Age Friendly Ireland, which includes data from the 31 local Age Friendly Programmes in each authority, shows that 33 walkability audits were carried out across the country last year, including in a racecourse, nursing homes, libraries, train stations and towns. There are now 499 Age Friendly Car Parking Spaces in Ireland, with many situated at local authority offices, libraries, tourism facilities, shopping centres and town centre locations. Age Friendly Parking is accessible parking for older people and others with a higher level of need. It is provided on a courtesy basis to allow less-mobile individuals to have easier access to local shops and services.

On 7th February, Monaghan Hospital became the second hospital in Ireland to receive Age Friendly recognition, following the example of the demonstrator model St Luke's in Kilkenny. Monaghan Hospital implemented a programme of work that included signage, Age Friendly parking, a new access ramp, improved traffic management, sensory garden, renovated toilet facilities, and Universal Design compliant seating in public areas, and enhanced visual contrast on kerbs for better accessibility.

The GAA have signed a partnership protocol with Age friendly Ireland to develop their sports facilities as Age Friendly. They will start with 5 Stadia in 2025 and assign staff members to adopt the WHO four stage process for age Friendly recognition.

Age Friendly Ambassadors from around the country supported this year's 'Ireland Reads' campaign by encouraging everyone to go to their library and get lost in a good book, they also gave examples of their favourite reads.

Two Meath County Council | Age Friendly Ireland Shared Service projects, Healthy Age Friendly Homes Programme and the National Age Friendly Library Recognition Programme, were shortlisted for the Local Authority Members Association (LAMA) Awards, under the category 'National Impact Award'.

The Age Friendly National Technical Manager delivered Age Friendly Housing and Public Realm training to Architectural Design Teams involved in the delivery of housing for Local Authorities nationally.

A recent 2-day meeting and workshop with the national network of Age Friendly Technical Advisors, saw the launch of the new Universal Design Checklist and Toolkit for compliance of internal spatial requirements for Age Friendly Homes and an updated version of the Age Friendly Ireland publication "Ten Universal Design Features to include in a Lifetime Adaptable & Age Friendly Home". The Department of Housing, Local Government and Heritage and the Centre for Excellence in Universal Design at the NDA attended the launch.

Native Woodland Scheme

Earlier this year, the Department of Agriculture Food and Marines' (DAFM) approved Meath County Council's application to establish new native woodlands on a 7.9 hectares (19.5 acres) site in Liscartan, with Greenbelt appointed as the project's foresters. Greenbelt will oversee the woodland establishment process ensuring best practices in ecological restoration and sustainable forest management.



Oak, beech, hazel, and alder trees are set to be planted in the area which will recreate lost native woodland habitats, rich in biodiversity and cultural significance.

DAFM's Woodland Creation on Public Lands Scheme recognises that native woodlands are an important part of Ireland's natural, historical, and cultural heritage, and are unique in terms of their biodiversity.


They are home to specialised woodland animals, birds, insects, and plants, including red squirrel, pine marten, great spotted woodpecker, narrow-leaved helleborine and wood millet, to name but a few.

As well as on-site biodiversity, they provide many ecosystem services, including carbon capture, the protection and enhancement of water quality, wider habitat linkage, landscape enhancement, and opportunities for outdoor recreation, which itself promotes contact with the natural world, physical and mental well-being, and outdoor learning.

Display Energy Certificates

As per national legislation, Display Energy Certificates (DECs) are required annually for all Meath County Council buildings over 250m² which are frequently visited by the public. This project was completed in February for all relevant buildings and involved analysing the energy use for the previous 12 months against the building floor area. All certificates have been issued to MCC and put on display in the relevant buildings.

Tree Week

National Tree Week 2025 was celebrated from Sunday, 9th March, to Sunday, 15th March, with the inspiring theme, "Planting Trees, Growing Together."

To mark the occasion, Meath County Council distributed an impressive 5,000 native and common saplings to community groups and schools. These saplings will support tree-planting initiatives across local areas, sports grounds, housing estates, and schools, fostering a greener and more sustainable future.

The carefully chosen, pollinator-friendly selection included Alder, Holly, Crab Apple, Rowan, Wild Cherry, Oak, Birch, Hazel, and White Thorn. These native species will not only enhance local biodiversity but also create vibrant habitats for pollinators, contributing to the preservation of our natural environment.

Free Couch Drop Off Event

Meath County Council successfully hosted the first free bulky waste collection event of the year from 10th to 16th March. This initiative took place across four recycling centers: Navan, Trim, Kells, and Thornton's Recycling Centre in Dunboyne, providing residents with a convenient and cost-free opportunity to dispose of large, unwanted items responsibly.

Building on the success of this event, the Council is committed to supporting Meath householders with additional free bulky waste collection events throughout the year, further promoting sustainable waste management and environmental care across the county.



Environment Update Waste Oil Dumping Gormanstown

On 3rd March 2025, approximately fifty 25-litre drums of waste engine oil were illegally discarded on a cul-de-sac in the Gormanstown area, near the River Delvin and approximately 200 meters from the beach.

Many of the drums were unsecured, leading to extensive oil leakage. A specialist contractor, engaged and supervised by Meath County Council, promptly removed the waste oil. By 2:30 PM on 4th March 2025, the road was reopened. The spillage was confined to a small section of an open drainage ditch adjacent to the river. Thanks to the swift response, neither the river nor the beach was adversely impacted.

As a precaution, the bed of the affected drainage ditch was excavated and removed for proper treatment and disposal.

An investigation is currently underway by Meath County Council's Waste Enforcement Department. Meath County Council are encouraging any persons with information to contact us.

Local Studies

The annual launch of *Ríocht na Midhe: Records of Meath Archaeological & Historical Society* took place in The Ardboyne Hotel on Wednesday 26 March 2025. The journal has been published since 1955 and is one of the most highly regarded in the country. The subjects covered by this year's volume include Viking Navan, the Navan-Kells turnpike road 1734-1780, agrarian revolt in Summerhill, the early years of Meath camogie 1904-1934, and The Discovery Programme at Tara. A full house attended and Myles Dungan spoke on the subject of his recent book *Land is all that Matters: The Struggle That Shaped Irish History*.



STEAM kits

As part of Engineer's Week 2025, Meath County Council's Library Service launched the STEAM kits collection, which includes themed activities and books on a variety of subjects for children over eight years. The launch was held at Trim Library on Monday, March 3rd.

Thanks to funding of €15,000 from the Meta Clonee Data Centre as part of Meta's Community Action Grants, the kits are now available at all 15 libraries in Meath. These kits follow on from the successful STEAM backpacks initiative, also supported by Meta.

With nine different kits in total to choose from, each kit includes themed activities and books on topics ranging from astronomy, water, creative and robotic coding, maths, music, circuits and electricity. The kits are a great way for children and adults to make learning a fun experience together, showing how STEAM ideas are part of everyday life. This initiative is all about helping young people think critically, solve problems, and be creative.



Bettystown Library at East Meath Civic Centre

Following the launch of East Meath Civic Centre on Monday, March 24th, Bettystown Library opened its doors to the public on Tuesday, March 25th. The building spans over four floors, with separate libraries for Adult and Children's Books, as well as meeting rooms, study space, public access PCs and the library service's first purpose-built sensory room.

More than 1,300 new members signed up to the library in the first five days, and the weekly STEAM Saturday sessions, hosted in library branches throughout the county, have become a popular event.

At the end of March Bettystown Library hosted a talk entitled 'Can Sand Dunes Survive Climate Change'. Borrowers and visitors can soon look forward to the addition of other regular events such as storytimes, Magic Tummy Time and Book Clubs to the library's calendar.

In the first month of operation, 2,200 people registered as members and c6,500 books/items were borrowed.

Dormant Accounts Funding

The Library Service received over €15,000 to assist, facilitate and reach out to people with disabilities and other marginalised groups. Allocated under the Dormant Accounts Action Plan 2024, the funding injection delivered a range of furniture and equipment, including age-friendly chairs, heightadjustable desks, hand-held magnifiers, a high-spec magnifier for visitors to the Local Studies room, and age-friendly book trolleys. All items will support the elderly and people with mobility needs or physical disabilities. The various products will maintain or improve an individual's functioning and independence, thereby promoting their well-being
