4.0 Statutory Business

4.1 Rural Regeneration

4.1.1 To consider the Chief Executives Report on the Part 8 application (PT/MH193) in relation to the proposed playground on the Green, Longwood

An Cathaoirleach, Cllr Ronan Moore opened the discussion with the proposal which was seconded by Cllr Paul O'Rourke:

"To resolve to vary or modify the Part 8 application PT/MH193"

Proposed amendments to the playground, to include lighting, parking, footpaths and a pedestrian crossing. Dara McGowan, Director, confirmed that the amendments were possible, and the current plans could be amended.

Other interventions from members included:

- To be mindful that there are over 400 signatures in support of the development.
- The opening of a playground should be something of joy. Whatever the decision, some people will be disappointed.
- Such developments should be supported by members.
- Can there be set opening times?
- Can there be a fence and gate to the park?
- Why can't CCTV be used to police possible anti-social behavior?

Dara McGowan stated that there is a fence and gate and explained the rationale why CCTV would not be appropriate at the park. On the above proposal, a roll call vote was taken with the following result:
