## **Air Quality Bulletin March 2025**

The daily limit for  $PM_{10}$  is 50 µg/m<sup>3</sup>. The limit is deemed breached if more than 35 exceedances occur during the year. The hourly limit for NO<sub>2</sub> is 200 µg/m<sup>3</sup>. The limit is deemed breached if more than 18 exceedances occur during the year. The table below shows the number of exceedances in 2025 to 31/03/25. This data is provisional and subject to future revision following any further data validation.
