#### Newsletter 2 - Official Languages Act

In the months ahead the Dept Tourism, Culture, Arts, Gaeltacht, Sport and Media will be sending on information concerning changes that will be coming regarding the obligations of public bodies to the Irish language.

Main points from the Dept in Dublin and from the Office of the Language Commissioners that are effective at present are:

- The Meath County Council Language Scheme is still effective until Language Standards are prescribed. Public bodies will have the opportunity to give their opinions and recommendations regarding this.
- 2. **Consultation Language Standards**: The draft Language Standards will be published as part of the consultation process. Public bodies and the public will be given 3 months to take part in the process and to give their opinions and recommendations.
- 3. Section 9 requires public bodies to reply to posts on social media in the language in which they were received, and communications for providing information must be in Irish or bilingual

## **Affordable Housing**

Meath County Council are offering two new affordable housing schemes.

Effernock, Trim, Co Meath - The online portal to apply for these affordable housing units opened for applications on 17 April 2025 at 12noon.

Beaufort, Boyne Village, Navan, Co Meath - The online portal to apply for these affordable housing units opened for applications on 24 April 2025 at 12noon.

### **Expressions of Interest**

The Housing Department continue to collaborate with Developers and Landowners to purchase land and or properties for the provision of social and affordable housing.

**Local Authority Adaptive Work Scheme (LAAWS)** 

- LAAWS grant funding of €614,789.19 including VAT was submitted for approval to DHLGH on 23<sup>rd</sup> January 2025.
- This includes 50 disabled persons grant units for €412,289.19 and 3 disabled persons grant extension units for €202,500.00.
- This brings the total to 53nr. LAAWS applications scheduled to be completed in 2025.
- 12nr. LAAWS applications are completed so far this year.

#### Housing Adaptation Grant Schemes for Older People and People with a Disability

269 applications for the value of €1,892,081.45 were approved up to 16.04.2025

#### **Local Authority Energy Efficiency Retrofit Programme (EERP)**

Energy upgrade works are currently ongoing on 15 properties. 48 properties have been approved by the Department for the 2025 EERP Programme.

## Reasons for emergency accommodation placement in order of frequency:

The primary reason is family breakdown, relationship breakdown, unable to find a property to rent, Notice to Quite, domestic violence, overcrowding, couch surfing, addiction, mental health, unsuitable accommodation, and rough sleeping.

## At 31st March:

273 bed allocations were availed of by service users with a 97% occupancy rate.

Meath County Council is not the sole user of properties located in Meath that facilitate the Settlement Section. Owners of properties that border other LA's will also engage with these LA's. This includes, Louth, Fingal, Westmeath & Kildare.


#### **Sectoral Insights Programme**

## **Community Development**



#### **Meath Age Friendly**

The Meath Age Friendly Programme presented the three Meath branches of the Citizens Information Service (Navan Trim and Ashbourne) with their Age Friendly Business Recognition charters on 23<sup>rd</sup> April in Buvinda House. The Meath branches of the Citizens Information Service completed Age Friendly Business Recognition training provided by the Meath Age Friendly Programme in October last year and since then have created and completed specific actions to improve their service for older people, such as bringing in age friendly seating, reorganizing the stand of forms to make them easier to find and proving access to magnifying sheets for anybody needing assistance in accessing documents and forms with a smaller font. Meath OPC consulted on the project and attended the sites to confirm that the actions were completed. The Chief Executive presented the charters to the new Meath Age Friendly Champions.



#### **Public Participation Network**

Planning of the National PPN Conference continues.

SPC reps attended training on March 25th in Buvinda House. AILG held an online training for members of SPCs on April 17th and a further community reps training will take place in early summer, hosted by Meath PPN.

The Mental Health book project held an event in Bective on Friday 11<sup>th</sup> April and 132 young people attended (photos below).

#### Comhairle na nÓg

The first steering committee meeting of 2025 took place on 11<sup>th</sup> March, 2025. Three new Comhairle na nÓg members of the Steering Committee were in attendance and spoke about their involvement in a variety of consultations on mental health and suicide, electoral register consultation and department of transport consultation; school stress as the chosen annual topic for CNN, advocacy work for autism classes and free period products, their work on the Healthy Meath Programme and collaboration with Jigsaw on reducing stigma around mental health and video created for International Womens day.

#### **Local Enhancement Programme 2025**

Eligible applications received under the Local Enhancement Programme 2025 were recommended by the LCDC on 28<sup>th</sup> March, 2025. A return has been made to the Department of Rural & Community Development for final approval

#### **Healthy Meath**

Champion training for the CommUnity Connects mental health project will take place in Louth and Meath in May, where community volunteers will be trained up in how to use the resource pack.

The Healthy Meath Microgrant Fund closed on 11<sup>th</sup> April. Grant allocation recommendations will be brought before the LCDC meeting in April for approval.

#### **Carranstown Environmental Projects Grant Scheme**

Meetings of the Indaver Community Liaison Committee were held on 19<sup>th</sup> & 26<sup>th</sup> March & 3<sup>rd</sup> April to assess the 36 applications received under the Carranstown Environment Projects Grant Scheme 2024. Funding recommendations will be presented to the Laytown-Bettystown MD Members for approval at their May meeting and by Full Council at their June meeting.

#### **Knockharley Community Liaison Committee**

A meeting of the Knockharley Community Liaison Committee took place on 9<sup>th</sup> April to discuss funding for 2025.

#### **Pride of Place**

One expression of interest was received for the IPB Pride of Place initiative. This was received from Age Well in Summerhill.

Judging is currently taking place in the 51 schools, pre-schools and Montessori schools that applied for this year's Schools Pride of Place initiative.

#### **Community Safety Partnership**

Minister O'Callaghan commenced the Policing, Security, and Community Safety Act 2024 on April 2nd. We are awaiting the establishment of regulations and guidance to formally commence the Local Community Safety Partnership.


#### **Local Authority Integration Team (LAIT)**

The LAIT continues proactively holding drop-in clinics in all commercial setting centres in Meath. If required, we also conduct impromptu visits to centres and other locations to address issues as they arise.

In April there were **785** Beneficiaries of Temporary Protection (BOTP) across 12 commercial settings in Meath and a further **981** in 9 centres hosting International Protection applicants (IPAs).

The team facilitated a meeting between Gormanston Park Residents and Meath Partnership SICAP/BOTP integration team to set up groups in the centre to create a self-sufficient group for employment/training/childrens groups and English language classes.

The Team met with Schools of Sanctuary who attended our Ashbourne court clinic (pictured).



## **Age Friendly Ireland Shared Service**



A series of 6 regional training events for Older People's Council Chairs and Vice Chairs was delivered in March and April by external facilitator Mary Carleton Reynolds. The training focused on the representative role of Older People's Councils and promoting diversity with these committees to reflect the voice of all older people in the community.

Age Friendly Ireland was represented at the WHO supported Age Friendly Futures Summit in Manchester in March. At this global event, Regional Manager Karen Fennessy contributed to a special session on the forthcoming WHO European Strategy on 'Ageing is Living: Promoting Lifelong Health and Well-being (2026–2030)'.

An innovative pathfinder Community Linkage Project is being set up with funding from the Women's Health Action Plan in the Department of Health. A project co-ordinator will be employed by MCC to bring befriending volunteers and other community-based supports to women in residential care in Counties Roscommon and Leitrim, with the aim of improving health and wellbeing outcomes for older women.

A new partnership between Age Friendly Ireland and the GAA was announced to mark the start of a collaborative process to scale up the demonstrator model of an Age Friendly Stadium. Five GAA stadia across the country will follow the example of Croke Park in developing their facilities in line with World Health Organisation guidance for supporting ageing communities.



A new initiative to focus on the development of Age friendly Workplaces will be piloted in County Meath with local businesses. Employers will be involved in co-design sessions to develop a toolkit and recognition programme for workplaces that wish to be accredited as Age Friendly working environments.

Older People's Councils were involved in consultation sessions with Professor Ronan Collins on the topic of Assisted Dying, and with An Garda Siochana on the topic of road safety. In April, they engaged nationally with the HSE through an Older Person's Reference Group established as a patient and service user panel to support the work of the Office of the HSE National Clinical Advisor & Group Lead.

Age Friendly Ireland hosted a health and wellbeing event for Sligo and Leitrim in Sligo ATU on 28<sup>th</sup> March which attracted over 200 people across the two counties.

The Healthy Age Friendly Homes Programme continues to support older people, over 65 years of age, to live in their home for as long as possible. Referrals to the programme remain strong. A tender process was completed, and Stichting International Foundation for Integrated Care (IFIC) have been awarded the contract to carry out a three-year programme evaluation.

Age Friendly Ireland carried out a walkability audit of Carlow train station, one of the ten stations chosen by larnród Eireann to go through the Age Friendly four stage process.



Age Friendly Housing & Public Realm training was delivered to Architectural Design Teams involved in the delivery of housing for Local Authorities nationally.

Age Friendly Ireland was represented at the House Building Summit and Housing Practitioners conference in Croke Park on 8<sup>th</sup> April. The IHBA's annual summit explored building housing amid infrastructure, cost, labour and planning pressures - offering insights and solutions to advance best practices in housing development.

### **Climate Action and Environment**



#### **Meath Energy Expo**

Meath County Council hosted the Retrofit Expo on April 2, 2025, at Buvinda House in Navan. The event focused on promoting energy efficiency and sustainable building practices. It coincided with the visit of the NZEB (Nearly Zero Energy Building) Truck from the National Construction Training Campus, offering workshops and accredited courses.

Representatives from the Vacant Homes, and Climate Action Sections of Meath County Council, local financial institutions, and representatives from the Sustainable Energy Authority of Ireland (SEAI) and Local Enterprise Office (LEO) provided advice on grants, retrofitting techniques, and loan options. The event featured a live broadcast by The Late Lunch with Gerry Kelly, interviewing key participants.

The Expo was a success, with over 80 people trained on NZEB principles, 200 consultations with experts, and 50 guidance sessions by financial institutions. The radio broadcast reached an estimated audience of over 10,000 in the Louth/Meath area.



#### **Community Climate Action Programme Fund**

Community Climate Action Programme: Strand 1: Action: Building Low Carbon Sustainable Communities €811,000 has been allocated to 25 Projects within Meath under the Community Climate Action Programme. This allocation supports a variety of community organisations in areas such as energy, waste, biodiversity, and active travel. 
#### **Local Studies**

#### **Creative Ireland**

#### "A Voice" - Foroige Music and Visual Art Project with Artists Mark Smith and Alun Smyth

As part of Meath Cruinniú na nÓg 2025, young people from the Fóroige Navan Young People's Development (NYPD) project will create a unique music and visual arts project to amplify their voices within their community. This project idea emerged from a dynamic creative consultation process with the group during which they expressed a desire to make their voices heard through art and music. Collaborating with local artists Mark Smith and Alun Smyth, they will participate in a series of workshops designed to explore identity, expression, and community through creative practice.

The outcome will be a powerful multimedia project combining music and visual art. As part of the visual element, the young people will design six mock vinyl covers, each featuring a single letter from the phrase "A Voice." These letters will be layered over photographs of local graffiti, symbolizing raw, authentic expression from their hometown streets. The imagery will also be woven into a music video, soundtracked by original music they create during the workshops, resulting in a bold artistic statement that reflects their collective voice and vision.

Their original creations will be unveiled in Navan the week of June 7th as part of the Meath Cruinniú na nÓg 2025 programme. Date, time and location to be confirmed. An audio-visual piece will also be shared to the Meath County Library social media pages on June 7<sup>th</sup>. After this date, their work will travel to Kells to be exhibited as part of the Kells TypeTrail launching on June 26th.
