4.	To receive an update on the PPN
	BH gave an update on the PPN for the month of April as follows:
	<ul> <li>Planning for the National Conference continues. Meetings with DRCD/MCC and Events &amp; Communications team have taken place.</li> </ul>
	<ul> <li>SPC reps attended training on March 25<sup>th</sup> in Buvinda House. AILG (Association of Irish Local Government) are holding an online training for members of SPC's on April 17<sup>th</sup> and a further community reps training will take place in early summer, hosted by Meath PPN.</li> </ul>
	132 young people attended the Mental Health book project event on Friday 11 <sup>th</sup> April.
	<ul> <li>The May Plenary meeting will take place in Duleek on Thursday, 29<sup>th</sup> May.</li> </ul>
- 1	763 groups are registered with Meath PPN, broken down as follows:

# 5. To receive an update on the Healthy Meath Programme

**AL** gave an update of the Healthy Meath programme as follows. She noted that this is the final year of the 3-year programme.

## The Healthy Ireland Fund R4 2024 Overview: -

- 26 projects were completed by December 2024.
- Pobal progress and financial reporting for 2024 was submitted in February 2025. Both have been approved.
- Budget Allocation for 2025 is approved and funding to be received by MCC next week.
- Total Allocation of €75,000 for 2025 Split 50:50 between Positive Mental Health & Reduction in NCD initiatives for 2025
- An underspend of €6,353.65 from 2024 will be carried into 2025 budget.

## Outcome area 1 - Positive Mental Health

AL gave an overview in relation to Positive Mental Health and its projects outcomes and outputs.

**AL** gave an overview in relation to Chronic Disease Reduction, its projects outcomes and outputs and Financial Reporting as follows:

### Workplan 2025 - Positive Mental Health & Reduction in NCD Mortality:

 AL provided an overview of the projects and programmes that will be carried out in 2025 under the Positive Mental Health and Reduction in NCD Mortality themes including details of activities, partners, target groups and timelines. She noted that the budget for those themes is €32,500 each.



#### Healthy Meath Micro Fund Scheme 2025:-

AL provided an overview of the Health Meath Micro fund Scheme 2025 applications that had been received. She noted that the funding for that Scheme for 2025 is €16,000 which is to be divided 50:50 between Healthy Lifestyle and Positive Mental Health projects. She noted that the proposed grant allocations were agreed by the Healthy Meath subcommittee at their meeting on 22<sup>nd</sup> April and she asked the LCDC for their approval of same.

The grant proposals under the Healthy Meath Microfund 2025 were agreed on the proposal of SC and seconded by MM.

**SMcG** asked if details of the works carried out by groups in relation to Health Meath Projects/Programmes are shared with the public.

**AL** advised that a Healthy Meath newletter is issued every 2 months and is very detailed and informative in relation to the works carried out under the programme. This newsletter is also shared via the PPN.

**BH** stated that he plans to invite a couple of groups to an LCDC meeting later in the year to give presentations on their projects.

#### 7. A.O.B.

**BH** asked the LCDC to approve the amended SICAP subcontractor list as a number of additional subcontractors had been added to the list for 2025.

The updated SICAP subcontractor list for 2025 was approved on the proposal of MM and seconded by CB.

**BH** advised the LCDC that the SICAP Team have chosen the thematic focus area of "Older People in Isolation" as their Case Study for 2025 and asked for their approval of same. He noted that the chosen theme is consistent with the case study theme guidelines issued by Pobal.

The SICAP Case study theme for 2025 "Older People in Isolation" was approved on the proposal of BL and seconded by SC.

SMcG thanked all for their attendance and noted that the next meeting would take place on 23rd May 2025.
