

Joint Foreword – An Cathaoirleach Cllr. Sharon Tolan & Chief Executive Kieran Kehoe

In a year where we published our five-year Corporate Plan charting an ambitious course for County Meath through to 2029, great strides were made in 2024 towards realising our vision of making Meath even better and accomplishing our objectives.

2024 saw us make great progress in delivering high-quality housing solutions catering to our communities' diverse needs. Meath County Council spent €137,998,597 on capital schemes in 2024 with a number of direct construction projects completed including Yellow Ford in Athboy (an agefriendly development consisting of 28 homes), Gort na Glaise in Farganstown, Navan (consisting of 84 homes), and Millrace in Ashbourne (consisting of 74 homes).

Meath County Council is continuing to strengthen its reputation as a leader in job creation. The council has acquired a building in the Navan IDA Park to establish the Thrive Centre for Business Excellence, which aims to promote a vibrant and sustainable economy for both citizens and businesses. The county is also working to attract relocating or expanding businesses by acquiring additional land in Navan and Trim. In 2024, Meath continued to promote its experiential tourism sector by supporting a range of festivals, including Púca, Samhain, Bealtine, Hinterland, and the Boyne Music Festival, all of which contribute to a dynamic cultural landscape in the county.

The Meath County Council Climate Action Plan outlines our intentions to reduce emissions from our operations by 51%. We continued collaborating with local businesses and communities to facilitate effective climate action across Co. Meath. We achieved certification to ISO 50001:2018, an internationally recognised energy management standard, and continued to integrate Sustainable Development Goals (SDGS) into all aspects of our service by promoting awareness with social media campaigns and events.

Trim was proudly recognised as the international winner at the 30th Communities in Bloom Awards in Canada, a testament to the town's unwavering commitment to community enhancement and active involvement. This remarkable achievement was celebrated with a Civic Reception hosted by Meath County Council, reflecting our shared dedication to a vibrant community spirit.

Key milestones this year included the grand opening of the Boyne Valley to Lakelands Greenway, which promises to enhance connectivity and promote outdoor activities. We also welcomed the Kilmainhamwood Community Centre and the Rooske Road Playing Pitches, both of which are vital additions to our community infrastructure. A standout moment was the flag-raising ceremony for Bettystown Beach's first Blue Flag Award in nearly 30 years, underscoring our commitment to environmental excellence. Additionally, significant roadworks were completed in Ashbourne, paving the way for future development, with ongoing projects focused on fulfilling our vision for Navan 2030. The Council also launched several strategic initiatives, including the Boyne Valley Tourism Strategy for 2024-2030 and the Climate Action Plan for 2024-2029, ensuring a sustainable and prosperous future for our community.

Finally, we'd like to thank the Elected Members, management team, and staff of Meath County Council, as well as the businesses, community groups, and state agencies that support the council's work to drive the economic, social, cultural, and environmental improvement of our county. We commend you for your commitment and dedication as we work together to Make Meath Even Better.

Corporate Affairs and Governance


The Corporate Affairs and Governance Department operates within a framework of democratic principles and ethics, providing essential services to Elected Members and the broader organisation.

In 2024, the Department was key in facilitating various organisational activities, including business planning, risk management, and compliance with certain legislative requirements such as data protection, freedom of information, and ethics. It also promoted and managed a strong health and safety culture throughout the organisation, in accordance with the requirements of the ISO 45001 certification for health and safety management.

Additionally, the Department facilitated the delivery of services to the public through the customer services team, managed communications and media relations, organized corporate events, and maintained relations with several relevant bodies.

Key Achievements

Local Elections 2024



Local elections in Ireland play a crucial role in shaping the governance and community development of the country. Vibrant local governance strengthens democracy and ensures that the voices of ordinary citizens are heard and considered in the political landscape. Meath County Council organised the 2024 local elections in Meath, featuring 92 candidates across 6 municipal districts, with the Count Centre held at Simonstown GFC. Meath County Council revolutionized the local electoral process by live-streaming the elections, a groundbreaking initiative that aimed to provide real-time access to information for over 220,000 citizens. By utilizing a straightforward setup of cameras, microphones, and a robust internet connection, the Council successfully broadcasted the event on its YouTube channel and major social media platforms, fostering a more inclusive environment for community participation.

The live stream not only provided transparency in the democratic process but also served as an educational resource for schools and residents. With 22,837 views and 166 concurrent viewers at its peak, the stream reached a broad audience, significantly enhancing civic engagement. Moreover, the

initiative was cost-effective, utilising existing equipment and infrastructure while minimising the carbon footprint associated with traditional attendance. By offering a platform for the public to engage with local democracy from their homes, Meath County Council demonstrated its commitment to accessibility, community involvement, and sustainability in governance. This innovative approach has set a precedent for future electoral processes, ensuring ongoing engagement and transparency in local government.

Trim Tidy Towns MD Civic Reception

On Saturday, October 19th, 2024, Trim was proudly crowned the international winner at the 30th Communities in Bloom Awards held in the charming city of Charlottetown, Canada. This prestigious recognition serves as a testament to the town's unwavering commitment to enhancement, environmental stewardship, and community involvement. It marks a significant achievement not only for the residents of Trim but also for the local volunteers whose hard work and dedication have transformed their community into a vibrant and welcoming place.

To commemorate this momentous occasion, Meath County Council hosted a Municipal District Civic Reception in honour of the Trim Tidy Towns initiative. This special event provided a perfect platform to pay tribute to the dedicated volunteers whose tireless contributions and spirit of camaraderie have played an essential role in elevating Trim's profile in the Communities in Bloom programme. The gathering was not only a celebration of their efforts but also a heartfelt acknowledgement of the pivotal role community spirit plays in fostering a welcoming atmosphere.



Corporate Plan 2024 – 2029

At the November Council meeting, the Elected Members formally adopted the Council's Corporate Plan for the period 2024 – 2029. This plan serves as both a strategic framework for action and a bold vision that embodies the Council's unwavering commitment to excellence.

Meath County Council engaged in a comprehensive consultation process during the development of this Corporate Plan, highlighting the importance of reflecting on our achievements over the past five years while strategically planning for the future.

A pivotal aspect of our approach involved facilitating consultative sessions with diverse stakeholder groups to gather a wide range of perspectives and insights. Notably, a think tank comprising Elected Members was convened to discuss and establish strategic priorities for the upcoming five years. This session fostered productive dialogue across party lines and districts, underscoring our shared responsibility to drive progress and enhance the quality of life in the county.

Housing

Meath County Council is committed to realising the ambition of Housing for All at County level, for the benefit of those in need of social housing support, and those impacted by the affordability constraints that exist for many in certain areas of the County. 2024 is another record year for delivery in Meath, with significant exceedance of our target. The Housing for All 2022-2026 summary of targets and delivery is outlined below.

Key Achievements

Housing Capital Expenditure

A total of €137,998,597 was spent on capital schemes in 2024 under the following headings: Acquisitions, Buy & Renew, Construction, Traveller Accommodation, Part V, LAAWS, Turnkey, Voids, Turnkey Admin Costs, EERP, NTW – Wages, EERP Project Management Fees. Here are some examples of direct construction projects that were completed in 2024:



Yellow Ford, Athboy

Yellow Ford, Athboy: Meath County Council completed an age-friendly development in August 2024 consisting of 28 homes. The development also caters for persons with a disability or mobility issues.

This site was previously part of the sports grounds for Mercy Convent Secondary School in Athboy. The State received the land through the Sisters of Mercy Redress Scheme and transferred it to Meath County Council.

The age-friendly development is in a well-established part of the town, close to all services and amenities. It is surrounded by the Community Centre, existing housing, playing fields, and mature trees.

Gort na Glaise, Farganstown, Navan: A development of 84 homes was delivered in Gort na Glaise, Farganstown in December 2024 delivered in conjunction with the recently completed LDR6, LIHAF Funded distributer road. This is a mix of houses, duplex and apartments. The site provides a strong urban edge along the eastern boundary facing the proposed access.

Millrace, Ashbourne: The proposed development provided 74 units (48 houses and 26 apartments) on a site at Castle St, Ashbourne. The site was previously owned by the Department of Education and was previously the site of a temporary school. The development incorporates a playground for residents.

Homeless Service

On January 1st, 2024, 219 households were accommodated in Emergency Accommodation (EA). There was a total of 319 placements in EA over 2024, including repeat placements

285 households exited EA over 2024, some of the exits would include people who were in EA on January 1st, 2024. On the 31st of December 2024, we had 253 households in placements in EA.

Local Authority Vacant Units

86 Vacant units required works prior to being re-tenanted in 2024 resulting in expenditure of €2,675,382. A total of €2,271,226 of this was eligible to be claimed from the Department of Housing, Local Government & Heritage under Void Maintenance and Energy Efficiency Retrofit works.

Housing Adaptation Grant Schemes for Older People and People with a Disability

In 2024, 750 Households received Grant aid under the various Grants schemes in 2024 to the value of €3,873,074 including VAT. Grant funding of €3,098,459 (80%) was received from the Department of Housing Local Government & Heritage towards these works

Private Rental Inspections

From January to December 2024, 6,188 inspections were conducted on private rented properties in Meath. The Department of Housing, Local Government, and Heritage had set a target of 1,850 first inspections, which was surpassed with 2,828 first inspections completed.

Estate Management Policy

The Estate Management Policy was implemented to provide an overall framework for promoting and achieving better estate management outcomes within Meath County Council's estates. The Tenant Liaison team encourages all new tenants to participate in existing Resident Associations or set up new Resident Associations for new estates. The Team also outlines what supports are available from the Public Participation Network (PPN). The Team assists and attends resident association meetings throughout the year, encourages estate management initiatives, and explains what funding is available.

Disability Strategy

Meath County Council's 'Strategy for Housing People with a Disability' was reviewed in under the auspices of the Housing Disability Steering Group following the publication of the National Housing Strategy for Disabled People 2022-2027. A National Implementation Plan was published in 2023 from which local actions were identified and are being progressed. The Steering Group convened 4 times in 2024, and the Sub Steering Group convened twice in 2024.

Planning and Development Management

The Planning Department's activities in Meath, which include building control, encompass a wide range of functions critical for sustainable development. This includes managing the consenting process for new developments, ensuring compliance with building regulations, planning enforcement, collecting development contributions, and overseeing heritage, conservation, and biodiversity initiatives. The department's efforts are aimed at delivering essential infrastructure, enhancing both the built and natural environments, and improving residents' quality of life.

In 2024, the Planning Department processed a total of 1,636 planning applications, a slight decrease from the 1,685 applications received in 2023. Additionally, it handled 104 applications for declarations of exempted development and 32 applications for certificates of exemption from the requirements of Part V of the Planning and Development Act. Notably, the number of commencement notices significantly increased, with 935 received compared to 643 in 2023. This rise is attributed to the National Development Contributions Waiver Scheme, leading to an uptake in building control inspections, exceeding 1,000 inspections throughout the year. Development contribution receipts reached €15,564,626, funding infrastructure projects such as roads, public transport, and social amenities as outlined in the Meath County Development Contributions Scheme (2024-2029). During this period, 13 housing developments were also taken in charge.

Key public realm and regeneration projects were advanced, including the Village Core Redevelopment in Old Johnstown Village, the Flower Hill Frontage Improvement in Navan, a Heritage Led Regeneration plan for Duleek, and a Recreation and Amenity Plan for Tower of Lloyd in Kells. Furthermore, the department spearheaded the successful THRIVE funding application, securing €7 million for the Navan Cultural Quarter, which will convert the Old St. Patrick's Classical School into a community hub.

Progress was made on the Maynooth & Environs Local Area Plan with a draft prepared for public consultation. The Meath County Development Plan saw two variations, with a third published to update provisions concerning age-friendly initiatives and sustainable residential development. A settlement capacity audit was initiated to inform future growth planning, with a new County Development Plan set for preparation starting in Q3 2025.

The Planning Department initiated the first annual review of the Residential Zoned Land Tax in early 2024 and submitted 30 responses to public consultations on relevant government plans and guidelines. The Annual Development Plan Monitoring Report indicated approval for nearly 2,700 residential units in 2024 and over 87,000 square meters of commercial/industrial floorspace.

An extensive heritage and biodiversity program was carried out, which included assessing applications for community heritage grants and creating a booklet on medieval towns in Meath. Conservation efforts were also made on several historical sites, with a new Biodiversity Action Plan in progress, set for completion in 2025. Overall, the department's commitment to fostering sustainable development and enhancing community life is evident through its numerous initiatives and projects.

The Planning Department underwent a review in 2023, which was completed in 2024, conducted by the Office of the Planning Regulator. This review found the department's systems and procedures to be "effective and robust." It also highlighted innovative practices, including the development of a customized software solution that ensures planning compliance submissions are processed within the legally required eight-week timeframe.

Key Achievements

Community Monument Fund

Under the Community Monument Fund 2024, Meath County Council successfully received €266,000 in funding for four projects:

- Ardmulchan Church and Graveyard
- St. Erc's, Slane Castle
- St. Patrick's Cathedral, Trim
- Belfry Tower, St. Columba's Church of Ireland, Kells

The project for Ardmulchan Church and Graveyard represents the culmination of several years of work. In 2022, Meath County Council engaged a conservation team, including a conservation engineer, bat ecologist, and archaeologist, to conduct a series of surveys at the site. This work was funded through the Community Monuments Fund and aimed to inform a suitable conservation strategy and methodology for the church's preservation and the stabilization of the boundary wall, in consultation with the National Monument Services.







In 2024, Phase I of the conservation project was initiated, focusing specifically on the 15th-century belfry tower. The work was supervised by a bat ecologist and monitored by a project archaeologist, following Ministerial Consent.

The conservation efforts included erecting scaffolding to create a safe working platform for accessing the tower. This involved carefully removing ivy, raking out joints, and then pinning and pointing with lime mortar. Additionally, the top of the tower was flaunching to secure the wall capping. A laser scan and a detailed desktop study on the history and archaeology of Ardmulchan Church, its graveyard, and the surrounding area were also conducted.

This project aims to safeguard the future of the church while increasing public awareness of this prominent feature along the Boyne River.

Taking in Charge

In 2024, Meath County Council took charge of 13 housing estates following requests from both residents and developers. The time it takes to bring a development under the Council's responsibility depends on several factors, including the necessary work to meet the required standards and the completion of the statutory process for taking in charge.

One notable request from residents was regarding Kilcloon Lawns in Kilcloon, a small development of six houses built in the mid-1970s, which did not have a bond or cash deposit. The developer of the estate had passed away. The building control unit conducted several inspections to identify the works needed to bring the development up to standard and then prepared a cost estimate for completing the necessary repairs. Once the approximate cost was determined, funding was allocated from the Council's Taking in Charge budget.

Kilcloon Lawns was subsequently included in a batch of seven estates requiring remedial works. A request for tenders was published through the Supply Government Framework for small civil works with PSCS. The development was officially taken in charge in May 2024, allowing the Council to access the site for the works. A contractor was appointed in August 2024, and the works were completed in October 2024.

The improvements included drainage works, the replacement of kerbs and footpaths, a complete overlay of the entire road surface, road marking, and associated signage. These enhancements have significantly improved the quality of the footpaths and roadways serving the development.



The Arches in Dunshaughlin is a small residential development consisting of 14 units that received planning permission in 2019. It exemplifies the benefits of a coordinated approach that the Planning Department now uses for new residential developments under construction. This approach enables Meath County Council staff to identify and address any potential issues during building control inspections.

In April 2023, the developer of The Arches submitted a request to take the development in charge. Following an inspection, the Council identified outstanding items that needed to be addressed by the developer. By December 2023, the roads and services within the area were deemed compliant with the Council's requirements.

The statutory process to take in charge the roads and services within The Arches began in March 2024. Meath County Council publicly advertised its intention to declare the roads in The Arches as public roads. The maps and related notices were displayed at all Meath County Council Municipal District Offices and the Planning Department from Wednesday, March 6, 2024, to Thursday, April 4, 2024. The deadline for submissions or objections was April 18, 2024, and no submissions or objections were received during this period. As a result, The Arches was officially taken in charge by Meath County Council in July 2024.

Duleek Heritage Led Regeneration Plan

Duleek is situated on one of the oldest town sites in Ireland, with its historic core dating back to the early Christian period. The town centre features significant medieval remains and traditional street patterns, as well as a variety of attractive eighteenth and nineteenth-century architecture, a village green, and a charming streetscape. Despite the town's rich heritage, many of these important heritage assets have become overlooked, underutilised, and underappreciated in recent years.

To address this, Meath County Council has received funding support from the Heritage Council and the Department of Housing, Local Government, and Heritage through the Historic Towns Initiative 2023 grant scheme. This funding was used to develop a Heritage-Led Regeneration Plan for Duleek town. After extensive public consultation, a draft Plan was published in 2024.

The Plan recognises the unique opportunities presented by Duleek's natural and built heritage. It lays out a strategy for heritage-led regeneration aimed at enhancing the quality of life for both residents and visitors to the town now and in the future. This strategy is based on five themes: celebrating our heritage, defining our historic town centre, sustainably using our built heritage, creating community spaces for all, and governance. Each theme includes specific actions.

The Plan outlines measures to boost Duleek as a visitor destination, improve the public realm and building facades, increase heritage awareness, repurpose and adapt historic buildings, and facilitate easy access to public spaces. Additionally, it is accompanied by a detailed implementation action plan to support the successful execution of its strategy.

Road Transportation and Safety

Meath County Council's Transportation & Assets Department continued to deliver a wide range of high-quality services throughout 2024.

The Transportation and Assets Department deal with a wide range of services including roads. Although the Roadworks Programme is a huge undertaking each year, the Department deals with road opening licenses, events, registration and management of the Council's assets other than housing stock. The maintenance and upkeep of bridges, the management of Community and Local Infrastructure Schemes, serving notices in relation to trees and dangerous structures. The outdoor staff are called on to assist when there are major weather events or road traffic accidents as examples. Outdoor staff also carry out street cleansing work, they maintain the parks, playgrounds, and public spaces and work with the local Tidy Towns Groups and community groups such as Men's Sheds.

The Department regularly monitors and surveys areas of high traffic volumes and ensures compliance with guidelines set down by the RSA. In addition to this Meath County Council is currently carrying out an Area Based Transport Assessment (ABTA) for Navan and Dunboyne.

Consultants were appointed to conduct this study, which includes an assessment of transport demand and its associated impacts along with identification of requirements, primarily in relation to movement and accessibility, as well as safety.

A total revenue budget of just over €67m was spent on the improvement and maintenance of almost 4,000kms of National, Regional and Local Roads, as well as the provision of engineered road safety solutions and educational programmers for the promotion of road safety among all road users with particular emphasis on young people with the co-operation and assistance of the NTA, TII, and DoT.

Key Achievements

Traffic Management Initiatives

During the year, a number of Traffic Management initiatives were rolled out, particularly in Navan, which will help facilitate the delivery of the Navan 2030 vision for the town. The Department continued to progress a number of climate-friendly initiatives through Active Travel Schemes, the continuation of the greenways through the County, and the Public Lighting Energy Efficiency Programme (PLEEP).

Innovative reuse and recycling of road materials were also trialled during the 2024 roadworks programme and proved very successful. This project on the Former National Road, R147 south of Kells, was supported by both the DoT and TII, and the lessons were shared across the industry.

High Profile Projects

In addition to the department's daily work, some high-profile projects were delivered, such as the completion of Navan 2030 Contract 3 and Phase 1 of the Athlumney—Trim Road Cycle scheme.

Construction of the Navan 2030 Contract 5 also commenced in 2024. This scheme to improve pedestrian facilities and the public realm around the Fairgreen, Fairgreen carpark, Church Hill, and Laneways (Cornmarket, Bakery Lane, and Preston Place) was delivered during the year. The new LDR4 Abeylands, Navan, was commenced in February 2024. This new road connects Kells Road to the Ratholdren Road and improves traffic circulation in the Town.

The Boyne Valley to Lakelands Greenway was officially opened by Minister for Rural and Community Development, Heather Humphreys, and Minister of State at the Department of Transport, Jack Chambers, in Kilmainhamwood. The greenway is a very valuable asset to the County both from a health and wellbeing point of view, making Meath more accessible for active tourism, encouraging biodiversity and fostering a love for nature and the outdoors in the local community.

The 30km greenway was developed along the disused railway line between Kingscourt and Navan and funded by the Department of Rural and Community Development, the Department of Transport and Meath County Council to the tune of €6m.

An application for planning permission was made to An Bord Pleanála for the Millenium Bridge in the Porchfields in Trim. €7 million in THRIVE Funding, the Town Centre First Heritage Revival Scheme 2024, under Strand 2 for Navan Cultural Quarter: Community Hub & County Archive, formerly known as St Patrick's Classical School, was secured during 2024.

Other notable projects, such as the Slane Bypass, the new Meath County Council Chamber, and the MCC Noise Action Plan for 2024-2028, were progressed.

Transportation SPC

Only one meeting of the Transportation SPC was held in March 2024, as the Local Elections took place in May and a new SPC was formed.

The Work of the SPC in 2024 included updates on the Navan Rail line, discussion around a Footpath Amenity Scheme for sporting facilities, discussion around the introduction of a subsidy scheme for the provision of salt bins to community and residential groups, and the setting up of a Winter Gritting Sub Committee with an elected Representative from each MD sitting on the Committee.

Overall, 2024 was a very productive year, and the Department looks forward to delivering an even more comprehensive work plan for 2025.

Environment and Climate Action

County Meath remains steadfast in its commitment to protecting and enhancing its natural and built environment, ensuring a thriving, high-quality space for residents and visitors alike. Clean air and water, unspoiled landscapes, and sustainable waste management remain at the core of Meath's vision for a greener future.

Meath continues to pursue a climate-resilient, biodiversity-rich, and environmentally sustainable economy. One that fosters healthier lifestyles and drives job growth. Climate change presents both challenges and opportunities, and Meath County Council is leading the way in adaptation and mitigation measures, shaping Ireland's approach to energy, waste management, air quality, biodiversity, surface water management, planning, building control, and transport choices.

The Council remains proactive in identifying risks and vulnerabilities, ensuring Meath stays ahead in the fight against climate change.

In 2024, new initiatives were launched, many of them driven by EU, National, and regional policies and regulations. All aimed at helping Ireland achieve its legally binding climate goals: net-zero greenhouse gas emissions by 2050 and a 51% reduction by 2030.

Through continuous action and leadership, Meath County Council remains at the forefront of environment and climate resilience, paving the way for a more sustainable, vibrant future.

Key Achievements

Environmental Awareness

In 2024, several notable achievements and projects were completed in County Meath, with a strong emphasis on environmental education and awareness activities. An Taisce awarded 26 new Green Flags to schools in Meath, reflecting their commitment to sustainability. The Picker Pals initiative saw participation from 65 primary schools, while 38 secondary schools engaged in a variety of activities such as the Rubbish Film Festival, the Composting and Recycling for Schools Programme, and ReLove Fashion. Additionally, two schools implemented water fountains and banned single-use plastic bottles, contributing to a more sustainable environment.

Litter Management and Waste Prevention

Community litter management services remained active, with 208 clean-up events supported by Meath County Council, which provided essential materials like pickers, bags, gloves, and waste collection services. The introduction of brown bin collections at recycling centres also aimed to tackle food waste and facilitate proper waste management.

Waste prevention and recycling events were another highlight of 2024, with 124 free bulky waste collection days organised across four sites. These initiatives collected a wide assortment of bulky household items, from mattresses and couches to garden equipment and Christmas trees. In tandem with this, five anti-dumping initiatives were implemented, totalling €75,000, which included paint collection and clean-ups at known dumping blackspots.

In terms of waste and litter management, Meath County Council continued to excel, building on an impressive track record. Although the 2024 results from the EPA haven't been released yet, in previous years, the Council achieved an excellent overall score of 95%. In 2024, the Council executed 1,506 litter patrols and conducted 206 litter pollution surveys, further solidifying its commitment to maintaining clean and safe environments in the county. Additionally, the council invested approximately €90,000 annually into street maintenance and illegal waste disposal management.

Water Quality and Coastal Management

The Environment Water Team focused on improving water quality in County Meath through a series of inspections and compliance actions aimed at ensuring adherence to water pollution legislation and good agricultural practices. In total, 1,973 water and wastewater inspections were carried out, alongside 1,564 planning and compliance inspections, to monitor agricultural impacts and ensure local water quality standards were met.

RPS Ireland Ltd continued its work on the Meath Coastal Flood and Erosion Risk Management (CFERM) study, aimed at establishing effective management policies for areas susceptible to flooding and erosion. By the end of 2024, all technical surveys and coastal process modelling were completed, leading to the submission of Draft Interim Report 1 to Meath County Council. This comprehensive study undertook to clarify the risks posed by coastal erosion to the local community and environment.

The retention of Blue Flag and Green Coast Awards for Bettystown and Mornington was also a significant accomplishment, with Meath securing two Clean Coast Awards and one Blue Flag.



Climate Action

Meath County Council is committed to climate action and sustainable development, as demonstrated by its adoption of the Climate Action Plan 2024 – 2029 on January 29, 2024, intending to reduce emissions from its operations by 51%. The Council is actively collaborating with local businesses and communities to facilitate effective climate action across County Meath.

Notably, Meath County Council achieved certification to ISO 50001:2018, an internationally recognized energy management standard, enhancing its efficiency and minimising environmental impact.

The Council is also engaged in the Sustainable Development Goals (SDGs), promoting awareness during SDG Week from September 20th to 27th, 2024, with activities such as quizzes, social media campaigns, and events in partnership with the library service.

Furthermore, Meath County has 33 Sustainable Energy Communities (SECs) and has played a pivotal role in supporting them through grant applications for energy master plans, with Athboy, Laytown, Kilbride, and Ashbourne completing energy master plans in 2024.

Meath County Council is also involved in the URBACT InGreen project, focusing on sustainable urban development in Navan, with an Integrated Action Plan being developed collaboratively with local stakeholders.



Fire and Emergency Services

Meath County Council Fire and Rescue Service

The mission of Meath County Fire and Rescue Service is to take all necessary measures to ensure the protection of life, property, and the environment through the efficient and effective prevention and control of fires, road fatalities, and similar emergencies. The functions of the service are divided into Operations, which manage the day-to-day needs of the seven fire brigades and fire stations; Fire Safety, which focuses on fire safety in the built environment and the safety of individuals occupying specific types of buildings; and Emergency Planning.

Key Achievements

65th Chief Fire Officers Association Annual Conference

In May 2024, Meath County Council hosted the 65th Annual Conference of the Chief Fire Officers Association. The conference was inaugurated by the Minister for Housing, Local Government and Heritage, Mr. Darragh O'Brien, along with Cathaoirleach Councillor Tommy Reilly and the Chief Executive of Meath County Council, Kieran Kehoe.

The Chief Fire Officers Association serves as the professional representative body for Chief Fire Officers across the country. This two-day conference is one of the most prestigious events of its kind in Ireland, attracting over 400 delegates and trade representatives.

The event included a large trade exhibition, both indoors and outdoors, showcasing a variety of products and services relevant to the fire services, including new fire appliances and fleet options.

The theme of the 2024 conference was "Igniting the Future: Cultivating Sustainable Transformation in the Fire Services." It brought together influential speakers from within the fire service community and beyond, all of whom shared their expert insights. Notable speakers included entrepreneur and "Dragon's Den" star Gavin Duffy, who presented on "Communicating Effectively for Progressive Emergency Services." Additionally, former Meath manager and herbalist Sean Boylan imparted his thoughts on "Leadership that Inspires."



Fleet

In 2024, the fire service expanded its fleet by purchasing seven new vehicles. This includes two Volvo 8000L water tankers, which are stationed at Ashbourne and Navan Fire Stations. Additionally, a second-hand 2009 Scania fire appliance was acquired for Ashbourne Fire Station to replace an older 2002 model. Nobber Fire Station also received a 2013 Volvo fire appliance to complement the existing 2008 unit at the site. Finally, two Ford Ranger Jeeps equipped with roof-mounted scene safety signage were added to enhance operational safety.

Recruitment

Recruitment and retention remain significant challenges for the fire service. In 2024, spending on the Fire Service was notably affected by the implementation of the 2023 WRC Agreement concerning Retained Fire Fighters. The Council recruited additional crew members at each of the seven stations, adding at least two members to each station. Furthermore, extra sub-station officers were appointed to support the new roster system, which operates on a week-on/flexible-week format.

Additional costs included increases in the retainer payable to Firefighters and other provisions outlined in the WRC Agreement. The Council is committed to implementing various aspects of the Agreement to enhance the fire service's operational capabilities.

Community Fire Safety

In 2024, Meath County Council Fire and Rescue Service successfully achieved its main objective of aligning all Community Fire Safety activities and initiatives with the Public Service ICT strategy. This alignment enhanced the customer service experience, making it well-documented, actionable, and measurable.

Key initiatives included the "Community Smoke Alarm Scheme," which provided 1,100 smoke alarms to residents of County Meath. The service also conducted fire safety awareness talks for vulnerable groups and collaborated with Meath Age Friendly and the Meath Public Participation Network to promote fire safety.

Additionally, the council relaunched its Christmas Fire Safety Campaign, "12 Days of Christmas," in partnership with the Housing Department. As part of this campaign, over 4,000 brochures were distributed to Meath County Council tenants. Furthermore, a Road Safety Seminar was developed in collaboration with the Meath County Council Transportation Department, aimed at promoting safer driving practices among transition-year students.



Civil Defence

Civil Defence is a voluntary section of the emergency services within Meath County Council. The role of Meath Civil Defence is to assist the principal response agencies as well as community groups and sporting organisations in line with the requirements for the Civil Defence Towards 2030 document. Service provided by Civil Defence can categorised under the following headings.

- Emergency Response
- Search and Rescue
- Medical Response
- Community Assistance
- Radiation Monitoring Services

Nationally Civil Defence operate under the Civil Defence Act and the associated Code of Practice.

Key Achievements

Training

Currently, there are 177 volunteers registered as members of Meath Civil Defence. These volunteers meet weekly to train in various practical skills that enhance the services provided. Training occurs twice a month in eight centres across the county, and they also attend our training facilities in Moat View House for centralised training, also twice a month.



Volunteers have completed training in the following areas:

- Cardiac First Response
- First Aid Response
- Manual Handling
- People Moving and Handling
- Fire Safety
- Food Safety and Welfare
- Flood Water Pumping
- Health and Safety
- Water Safety Awareness
- Rescue Skills
- Kayaking
- Severe Weather and Off-Road Driving

Recruitment and Operational Activity

In 2024, we organised three recruitment evenings at Moat View House, successfully recruiting 17 new probationary volunteers. These individuals will join the active cohort after completing their minimum training. Additionally, Meath Civil Defence volunteers provided invaluable assistance at 164 community events and supported families during 18 days of missing person searches, both on land and at sea.

Fleet and Equipment

In 2024, Meath Civil Defence upgraded its fleet by replacing the Catering Truck with a new purpose-built catering trailer. This new unit will allow Civil Defence volunteers to be self-sufficient while assisting at large events and during extended emergency callouts.

Additionally, a new Zodiac boat was acquired with funding from the Civil Defence Branch. This purchase enabled the replacement of our older Zodiac, which had reached the end of its lifespan.

Community

The Community Department actively engaged in a wide spectrum of activities to support and empower communities across Meath, demonstrating a commitment to fostering a vibrant, inclusive, and resilient county. This included strengthening the voice of the community through the Public Participation Network (PPN), which witnessed significant membership growth.

The department championed the needs of older adults through the Meath Age Friendly Programme. It fostered youth engagement and civic participation through Comhairle na nÓg, providing a platform for young people to address issues vital to them. The Pride of Place Initiative continued to celebrate the dedication and hard work of local communities in enhancing their environments, with a notable increase in participation, with 245 applications representing an increase of 10% in 2023. Additionally, 45 schools submitted applications for the Schools Pride of Place Gardening Scheme in 2024, and the Municipal District and County Pride of Place awards had over 1,100 attendees.

In October 2024, Trim Tidy Towns was crowned the international winner at the 30th Communities in Bloom Awards in Charlottetown, Canada. This achievement highlighted how Meath County Council, residents, and businesses in Trim have worked towards a shared vision of a vibrant and sustainable community.

The development of Meath's first County Outdoor Recreation Plan also commenced in 2024, promising to enhance the county's natural assets for both residents and visitors. Underpinning all these efforts was the allocation of Community Grants, which directly empowered grassroots initiatives, along with the ongoing work of the Local Community Development Committee (LCDC) in implementing key national and local programmes aimed at sustainable community and economic development.

Key Achievements

Meath Age Friendly

The Meath Age Friendly Programme continued its work throughout 2024, demonstrating a strong commitment to creating a county that values and supports its older residents.

The community department supported the Meath Older Persons Council, and a notable achievement was the first-place win at the Meath Garda Youth Awards for the "Meath Age Friendly Alliance Intergenerational IT Initiative." This project, a collaborative effort between students of Colaiste na hInse, Laytown, and local older people, not only fostered valuable intergenerational connections but also enhanced digital literacy among the senior population.

The programme's dedication to addressing the needs of older adults was further highlighted by the shortlisting of Meath Age Friendly Alliance member Third Age for their initiative "Senior Line" for the national Age Friendly Recognition and Achievement Awards, acknowledging its crucial role as a confidential listening and support service.

Beyond this the programme also actively progressed a dance/movement pilot to promote physical well-being, hosted the annual Meath Cares About Older People event in Ashbourne, facilitated a valuable knowledge-sharing visit between Meath and Louth Older People's Councils to discuss strategies for tackling ageism, completed three walkability audits to identify areas for improvement in accessibility, and hosted a visit from the Mobile Virtual Dementia Training Tour Bus to Buvinda House, providing valuable insights into the experience of living with dementia.

The Meath Age Friendly Alliance also convened on a quarterly basis throughout 2024, ensuring ongoing strategic direction and collaboration.

Grant Funding



The Community Department actively supported local initiatives through the allocation of substantial grant funding in 2024, demonstrating its commitment to empowering grassroots projects and fostering vibrant communities. This included:

- Community Grants: 563 applications granted a total of €246,048, enabling vital community activities and enhancements to local infrastructure.
- Regional Festivals: Five applications were granted a total of €10,000, contributing to the county's vibrancy and economic activity.
- Carranstown Grant Scheme: 32 applications granted a total of €298,069, facilitating specific local development projects and addressing the unique needs of this community.
- Kentstown Village Project: €90,000 was allocated to the Kentstown Village Project, a key infrastructural undertaking aimed at improving residents' quality of life.
- The Community Amenity Project Scheme: 27 groups were grant-aided under the Scheme, totalling €600,000.
- Under the Community Recognition Fund 2024/2025, Meath County Council was allocated €1,188,066, and €311,567 was approved by year-end under the First application window.

A significant development in 2024 was the successful recruitment and establishment of the Local Authority Integration Team. This dedicated team was crucial in supporting individuals seeking protection and Ukrainian Beneficiaries of Temporary Protection (BOTPs) as they integrated into Meath communities. The LAIT provided essential information, direct guidance, and advice through a range of measures, including drop-in and appointed clinics, as well as open days, responding to 898 cases throughout the year. Recognizing the importance of collaboration, a key action of the LAIT was the establishment of the Community Integration Forum, a vital network comprising key local service providers that met seven times during the year to collaboratively define and agree on the nature of support that could be effectively provided. Furthermore, the team actively organised integration

events during Work Refugee Week and International Human Rights and Migrants Day, fostering understanding and connection within the wider community.

The Meath PPN continued to thrive as a vital link between the local authority and community and voluntary groups across the county. In 2024, the network experienced a significant 17% increase in membership, welcoming 105 new groups and bringing the total to 717 registered organisations. Recognizing the importance of mental well-being, the PPN launched the "Louie and Frankie" mental health resource, directly engaging with young people and providing valuable tools for emotional management. PPN also recommended nominees to the various Strategic Policy Committees and LCDC in 2024.

Local Community Development Committee (LCDC)

In 2024, the LCDC played a pivotal role in the strategic development and coordination of community and economic initiatives across Meath. The committee officially launched the new six-year Statutory Local Economic & Community Plan (LECP) 2023-2029, a crucial document that outlines the long-term vision, objectives, and strategic actions for the sustainable economic and community development of the county. The LCDC oversaw the implementation of several key programmes:

- The contract for the new SICAP Programme 2024 -2028 commenced in 2024 with a budget of €688,365.00. Meath Partnership continues to deliver the programme on behalf of the LCDC and Annual KPI targets for 2024 were exceeded.
- The Healthy Meath initiative progressed various projects, including the Community Connects Mental Health Resource Pack, commenced a significant Healthy Lifestyle Research Project in conjunction with Technological University Shannon (TUS), continued the Chronic Disease Risk Management Programme, and distributed €10,000 through a Micro Fund supporting 26 community-led events benefiting 740 individuals. The Meath Chronic Disease Risk Management Programme was extended for 2024 with 7 new pharmacies participating. The total Healthy Ireland Fund spend in 2024 was €101,458.55.
- The LCDC acted as the Local Action Group for the LEADER programme and oversaw the closeout of the previous programme and the progression of the new LEADER (RDP) 2023-2027, receiving 29 Expressions of Interest, progressing 6 to full application, and approving projects for a total funding of €288,773.93 with Meath Partnership as the programme implementor.
- Local Enhancement Programme (LEP) allocated €163,632.52 in Capital Funding to 115 groups and €30,897.50 in Women's Group Funding to 11 groups.

Age Friendly Ireland – National Shared Service Office

2024 was an exceptionally successful year for the Age Friendly Shared Service, with an increase in staff numbers to 85 people directly employed by MCC and a further 66 assigned to work on local programmes nationally, giving a cumulative total of 155 staff working directly into the shared service in MCC across all 31 local authorities. In 2024, the Age Friendly Shared Service completed staff onboarding in the national recruitment campaign for the Healthy Age Friendly Homes Programme. There is a very strong line of referrals coming into the programme across the country. Work on the Commission on Care continued during the year. Chief Officer Catherine McGuigan chaired the Reference Group, which was comprised of older people and civil society groups. A new National Technical Manager commenced with the shared service office in January 2024, leading a technical work programme with engineers, architects and planners in all local authorities. Multiple national events were hosted to support key messages and campaigns around ageing, and new resources were published to support the scaling up of good practice. Ireland was represented internationally at the National Age Friendly Australia conference, where we had the opportunity to showcase the significant achievements of the local government-led national programme to an international audience.



Key Achievements

Core Programme

An innovative approach to addressing health and well-being for older people on offshore islands was led by four local authority areas with funding from Healthy Ireland. The Age Friendly Islands initiative was delivered on 11 islands across counties Donegal, Galway, Mayo and Cork. Actions ranged from yoga and singing for the brain to activator poles, information events and health checks, and minor capital works to improve the accessibility of outdoor community space. Approximately 500 older people benefitted from this new initiative. Many of these actions will lead to sustainable outcomes,

such as purchasing exercise equipment for community centres on the islands, which will be retained for use by the community, and the establishment of walking groups.

All 343 public libraries were recognised as Age Friendly at a national event in May 2024. All local authority libraries have appointed an Age Friendly Champion, undertaken training and delivered actions to make their libraries more Age Friendly, such as Age Friendly Car Parking, seating, and tailored events and activities for older people.

The first National Age Friendly Sports Day, held at the Sport Ireland Campus in Blanchardstown in September, attracted 100 older people from 13 counties and is likely to become an annual event.

Communications and Operations

A significant component of the work of the national office relates to raising awareness and communicating about the contribution of older people to society and the benefits of an ageing population. In May, the National Convention of Older People's Councils was held in Kilkenny, while the annual National Age Friendly Recognition Awards were hosted by Fingal County Council, showcasing the best innovative practices for supporting older communities. 2024 was also a significant year for the shared service regarding our national communications plan. Copper fastened a contract with a new PR company, and we achieved a record volume of media coverage across Ireland in print, radio, and social media. Age Friendly Ireland hosted several events with several key Ministers, including events for Kildare Racecourse and Castlefen Housing Estate to recognise their Age Friendly status. Through consultation with Older People's Councils, several private sector organisations launched free phone helplines for older people as part of their commitments to being Age Friendly, including Gas Networks Ireland, the GAA Ticketline and Age Friendly Care from Eir.

A national Age Friendly Ambassadors Day was launched, harnessing the media reach of high-profile national and international personalities and business professionals for a campaign to raise awareness about ageism.

National Technical Programme

The National Technical Programme aims to accelerate the delivery of Age Friendly Housing and Public Realm projects and develop the built environment to enable older people to continue to participate in their communities as they age. An important focus during the year was reviewing County and City Development Plans nationally to assess their alignment with national policy and Age Friendly guidance for housing delivery. The National Technical Manager promotes Age Friendly technical resources to each local authority area and has commenced work on a data collection system to track the delivery of Age Friendly housing nationally.

One of the major success stories with the technical workload in 2024 was a partnership agreement with Irish Rail to scale up the demonstration model for an Age Friendly Train Station (MacDonagh Station, Kilkenny). Irish Rail/Iarnród Éireann are working with ten train stations nationwide to bring them through the World Health Organisation's Four Stage Process for Age-Friendly recognition. At the end of this process, the stations will be fully accessible to older people and people with disabilities. A core element of this work involves older people in a co-design process at each station, which includes a walkability audit. Irish Rail funds the capital works required to bring the stations up to Age Friendly standards.

Healthy Age Friendly Homes Programme

The Healthy Age Friendly Homes Programme (HAFH) held its official nationwide launch on 10th July 2024. Following a two-year pilot across nine sites, the programme expanded to all 31 Local Authorities, with 44 Locals employed. Over ten thousand older people will be directly supported each year to remain living at home. This support coordination service delivers actions such as assistance with housing adaption grant applications and energy grants, advice on home modifications, safety measures such as fall detectors and personal alarms, and access to health and community services. The evaluation of the pilot phase conducted by Maynooth University was also released in July. This evaluation, based on data from a subset of over 2,130 participants during the pilot phase, documented improvements in self-reported health status, quality of life, social support, and functional ability, underscoring the programme's success in enhancing the well-being of older adults and supporting them to remain living at home.



Library Services

Meath County Council Library Service is a vital community hub in Meath, focused on educational, cultural, and community development. Committed to relevance, the library serves as an accessible public space. The national strategy, "The Library is the Place," aims to transform libraries into multipurpose social and educational areas.

In 2024, notable developments included the launch of the My Open Library service in Enfield and Trim Libraries, the reopening of Leabharlann Ráth Chairn after refurbishment, and the official opening of Ballivor Library. Progress was also made on a new County Archive building.

The library successfully executed the 2023 Creative Ireland plan, securing funding for the cataloguing of the Clayton Woollen Mills archive and organizing the annual Cruinniú na nÓg events in collaboration with various stakeholders. Additional funding facilitated three significant commemorative programs and a €15,000 grant from Meta for a STEAM kits project for children.

Collaborating with Trim Family Resource Centre, the library established digital hubs at multiple locations, providing digital skills classes for all ages. The library also actively engaged with national programs like Right to Read and Healthy Ireland, hosting the 'Children's Book Festival' and achieving notable participation in the Summer Stars National Reading Programme.

Further contributions included programming for Seachtain na Gaeilge, establishing a Down Syndrome Book Club, and hosting events for Europe Day. Library staff participated in the Bloomsday Garden Party at Áras an Uachtaráin and facilitated a popular lecture series on Irish Painting.

Key Achievements

My Open Library


My Open Library extends library access beyond staffed hours from 8 am to 10 pm every day. It aims to improve access, use and visibility of the library as a community hub. Members of this enhanced service may access Enfield and Trim Libraries on a self-service basis from 8am-10pm 7 days a week. The service launched in Enfield Library in February 2024 and in Trim Library in September 2024. Over 300 members registered to use this service during the year. During My Open Library hours, members can:

- Borrow and return items
- Print by sending documents from home or from a mobile device
- Photocopy
- Use the library computers/internet
- Access free Wi-Fi
- Use study space
- Book a meeting room

Ballivor Library

Ballivor Library opened in the former St. Kinneth's Church on July 23rd. The library is open 22 hours weekly, including one late night and a half-day on Saturday. The library offers study spaces, free Public PCs, a reasonably priced printing and photocopying facility, and WiFi. underwent a major

refurbishment project. The refurbishment project included the construction of a new accessible toilet, office and tea station within the church, and installing a new insulated floor slab and restoration works to the stained-glass windows, roofs, ceilings, stairs and woodwork.



Archives

Meath County Archives hosted an afternoon seminar in Solstice Arts Centre on Saturday 18th September. The Commemorative Initiatives Programme from the *Department* of Tourism, Culture, *Arts*, Gaeltacht, Sport and Media funded the event, and it was focused on the early years of the new Irish state. The theme was on craft and design in Meath, with a particular focus on the first decade of the new state.

Presentations included one from Vawn Corrigan on the disappearing world of Irish textiles. Project archivist Clare Ryan focused on Clayton Woolen Mills and the ambitious archival project, weaving together stories of wartime contributions, community impact, and the intricate threads of international commerce in the early years of the state. Author Ken Davis spoke about the contribution of Navan Carpets. As one of the key industries in Navan which helped power the local economy throughout the 20th century. Over 100 people attended the seminar, and many were former employees and workers. One former employee of Claytons brought the Clayton Bell, which was used each to call staff in from lunch, and the bell rang to signal the end to the afternoon.

Arts Office

The Meath County Council Arts mission statement as per the County Arts Development Plan 2019 – 2027 is:

- To work closely with artists, individuals and communities to increase access to, awareness of
 and participation in the arts across all disciplines and sectors of society. To act as a facilitator
 for arts organisations and play a major role in the development of good practice for the
 county. To provide opportunities across disciplines intended to support the Local Authority
 policy of supporting quality artistic endeavour, provision of employment opportunities for
 artists and long-term sustainability and durability for the arts in the county.
- In implementing key aims and objectives as per the County Arts Development Plan, the Arts Office continues to adopt a proactive approach in devising the annual Arts programme and engages with creative partners, artists, groups, organisations and the greater creative community. The Arts Office also engages with and is supported by the Dept Tourism Culture Arts Gaeltacht Sports and Media, the Arts Council and Creative Ireland, specifically in implementing actions under the Arts Council Meath Framework for Agreement 2019-2026 and the Creative Ireland Meath Culture & Creativity Strategy 2023-2027.

Key Achievements

In 2024, we worked to deliver a wide range of actions as per the four strategic priorities of the County Arts Development Plan: SP1 Nurture and support artists and creators; SP2 Enhance our local cultural and creative infrastructure; SP3 Provide children and young people access to high-quality participatory arts experiences; SP4 Promote inclusivity and diversity through the arts. We also delivered actions as per Meath County Council/Arts Council Partnership Framework Agreement 2019 – 2026 and the Creative Ireland Meath Culture & Creativity Strategy 2023-2027.

Nurture and support artists and creators – Arts Office Arts Grants Awards & Bursaries Schemes (SP1)

Funding artists, arts activities and development is a key strategic objective of the County Arts Development Plan. In 2024, to maximise the potential for arts provision in the county, a range of annual bursary and award schemes were implemented, and a new 'Gathering Bursary', in partnership with Performing Arts Ireland, was introduced. Funded by Meath County Council, the Arts Council & Creative Ireland, these schemes provide valuable support to creative organisations, arts practitioners and arts groups in the development of artistic practice and the delivery of a diverse range of arts activities and events throughout the county.

In 2024, 85 Awards were made under the following 10 schemes:

- Annual Arts Grants
- Community Arts Award
- Professional Artist Development Fund
- Festival Grant Scheme
- Drama League of Ireland Residency Award

- Irish Writers Centre National Mentorship Award in partnership with Words Ireland & IWC
- Centre Culturel Irlandais Residency Award in partnership with CCI Paris
- Gathering Bursary in partnership with Performing Arts Ireland
- Tyrone Guthrie Centre Residency Award in partnership with Age & Opportunity
- Culture Night Event Awards

Enhance our local cultural and creative infrastructure – Kells Creative Placemaking – Courthouse Tourism & Cultural Hub (SP2)

The Toradh Gallery 2 and Venue *Upstairs* @ the Courthouse are programmed and managed by the Arts Office with funding and support from Meath County Council, the Arts Council, the Heritage Council and Creative Ireland. *Upstairs* @ the Courthouse serves as a performance venue and as a working hub for artists – rehearsals, readings, programme development and hot desk spaces for the Meath Arts Office Associate Artists. It is also a space for meetings, training events, seminars, workshops, etc. The range and diversity of events in the spaces increased in 2024.

In 2024, the Courthouse hosted 33 festivals and public events, welcoming approximately. 3,000 attendees.

The Toradh Gallery 2 hosted five visual arts exhibitions in 2024, facilitating 20 local, national and international artists to exhibit and display their work. Some of the exhibitions were accompanied by artists' readings and talks. The gallery was delighted to host the premiere of musician and visual artist Steve Wickham's (The Waterboys) exhibition 'Tempest – 50 nights in a Dublin Hotel', which was selected as an Irish Times 'top pick' in The Ticket magazine.

In March we were pleased to welcome the Heritage Council and Heritage Officers Network, and the County Heritage Forum in December. Food for the Soul show development and rehearsals which premiered at Samhain Festival.

Promote inclusivity and diversity through the arts - Tea Chats and Tunes (SP4)

Tea, Chats & Tunes (TCT0) is a collaborative project between the MCC Arts Office and Music & Health Ireland, backed by Meath County Council, Creative Ireland, the Arts Council, and Age Friendly Meath. It aims to enhance mental health and well-being for individuals in residential healthcare settings by improving cultural access and quality of life.

Originating from a 'Music in Healthcare' training program established in 2013, TCT evolved into a pilot project during the COVID-19 pandemic, focusing on live music engagement for isolated individuals in nursing homes.

The 2024 program tailored musical interactions to residents' preferences, fostering person-centred experiences. Led by accomplished musicians, the initiative aimed to forge meaningful connections among residents and their families, addressing health issues like dementia and sensory loss.

Key delivery methods included:

- Engaging all stakeholders through pre-project meetings.
- Six music residencies in Meath nursing homes, featuring live music programs and virtual visits connecting residents with families via Zoom.
- Monthly virtual concerts for multiple nursing homes.
- A 'Music & Care' workshop for healthcare staff to enhance their creative use of music in care.
- Audio storytelling titled "C'mere till I tell Ya", where musicians worked with residents to explore their stories and preserve cultural heritage.

By the end of 2024, the project reached around 120 residents, each receiving six visits, supported by over 25 healthcare staff.

Festival support (SP1,2,3,4)

Meath has a thriving arts festival scene, which provides valuable employment opportunities for artists and creatives and engagement opportunities for a wide range of audiences, residents, and visitors alike. In 2024, the Arts Office provided a wide range of support to arts festivals in the county. These supports included finance, strategic development, audience development and capacity building, planning, programming, and co-curation.

Festivals Supported in 2024 include Bealtine, Hinterland, Hinterland Hindsight, Typetrail, Boyne Music Festival, Another Love Story, Dunshaughlin Harvest Festival, Loughcrew Fairy Festival, Samhain Festival, World Harp Day, Meath Beo and Cruinniú na nÓg.

LEO, Economic Development and Tourism Development

The Economic Development, Enterprise and Tourism teams have been focused on developing Meath as an economically vibrant, sustainable and welcoming County to visit and do business in. In 2024 work continued on building on this vision and producing roadmaps for the short to medium term, aimed at fostering that sustainable growth, attracting investment and visitors, and enhancing the quality of life for all residents of the County.

To this end, work was completed on the following strategies and action plans, all of which were launched in 2024:

- Meath Economic Development Strategic Action Plan launched May 2024 contains 6 overarching priorities to support the county's development in addition to specific objectives under five key focus areas:
 - Food & Agriculture
 - o Indigenous and Micro
 - o Education & Skills
 - Foreign Direct Investment
 - o Hospitality, Tourism & Retail
- Boyne Valley Tourism Strategy 2024 2030 launched October 2024 with the ambitious target of the Boyne Valley becoming one of the leading Experiential Destinations in the world, attracting high-value visitors who leave the region feeling inspired.
 - The strategy outlines various recommendations and strategic objectives aimed at achieving this. It also identifies six new projects capable of contributing to the transformation of tourism in the region. Projects include the Boyne Valley National Park, Boyne Valley Food Development, Coastal Tourism Development, Accommodation Growth, Development of Greenways, and Heritage Assets.
- Boyne Valley Food Development Strategy 2024 2028 launched June 2024 ambition for the region to build a thriving and enduring food and drink community by focusing on developing under three pillars:
 - a) Discover Boyne Valley Flavours food and craft drinks network
 - b) Food Tourism
 - c) The Centre of Food Culture, Boyne Valley

Additional resources in the Economic Development team have been provided in 2024, to assist with the delivery of all the ambitions contained in these strategies.

The supports offered by the Local Enterprise Office grew in 2024, including the roll out of Lunch and Learn Roadshows, bringing information on all of the available supports to the local communities, as well as facilitating networking between neighbouring businesses. This has been hugely successful in developing a relationship between the LEO and small businesses that may not otherwise have reached out and engaged with these supports.



Key Achievements

Economic Development

- A building was acquired in Navan IDA Park to house the Meath Centre of Business Excellence, which will open in 2025. This centre will provide support to businesses to facilitate growth and expansion. This building has been designed with both training and networking in mind and will house all support services for businesses that fall under the Local Authority umbrella.
- A Business Relationship Manager was appointed to understand the client's needs, signpost businesses to the various supports available, and act as a connector between all stakeholders, both internal (e.g., the Planning, Transportation, and Environmental departments) and external (e.g., IDA, EI, and education providers).
- Lands suitable for economic development were identified, and the acquisition process commenced in both Navan and Trim to ensure that the Council have a land bank of sites to offer to businesses looking to locate or expand within the county.
- Work on establishing the Centre of Food Culture, Boyne Valley, as the first centre of its kind in Ireland ramped up by holding the first national food networking event at the Samhain Symposium in November 2024. The symposium welcomed those involved in regional food and drink networks across the island of Ireland to explore shared values, goals, and ambitions to establish Ireland as a true food destination, with attendance from 15 networks on the day. Chaired by John McKenna of the McKenna Guides, with two-panel discussions, "From the Ground Up Learning from Ireland's Food and Drink Networks" and "Making Partnerships Work to Support Sustainable Networks".
- The Samhain Food festival has now been established as the flagship event for the centre, and was more successful than ever in 2024, when it collaborated with Sheridan's Irish Food Fair, with approximately 6,000 attendees over the weekend.
- As part of the implementation of the actions identified in the Boyne Valley Food Strategy, Boyne Valley Flavours producers were supported in attending a meet the buyer event, SIAL tradeshow, in Paris. The companies received mentoring in advance of the trip, to ensure that they were as prepared as possible to maximise on the opportunity.

Meath Local Enterprise Office

Meath Local Enterprise Office had a very successful year when it came to job creation, with 74 new posts being created through their client companies during 2024.

Other statistics for the year include:

- 1285 Training course places This includes Start your own business courses (SYOB), general training and management development programmes (MDP's)
- 133 Grants awarded This includes Measure 1 (Priming, Expansion & Feasibility), Agile, TOV's and Energy Efficiency Grants

Tourism

The Tourism section supported the promotion of the Irish Language and Culture by leading out on a new festival located in the Gaeltacht area of Bhaile Ghib, Siamsa Glás. Over twenty events across the two days for all age groups and interests, ranging from Treasure Hunts, Pottery Workshops, Nature Walks and an Immersive Theatre Experience to a Céilí Mór, Teddy Bear's Picnic and a Cultural Concert. The events were promoted extensively through the Discover Boyne Valley channels and the festival generated great interest, with visitor numbers exceeding 1500 across the two days.



Finance

During 2024 the focus of the Finance section was on budgetary controls as we strive to effectively manage the County's resources and achieve efficiencies and value for money while delivering a wide range of services. Emphasis for 2024 was on maintaining collection rates for all sources of income. Rates collections at 97% are the highest in the country and Rents at 89% and Housing Loans at 92% are also above the national average. During 2024 Finance carried out a review of the systems and processes within the Accounts Payable function with the aim of identifying areas that could be further automated or enhanced by new Business Solutions. This has resulted in faster processing of supplier payments and increased efficiencies in bank reconciliation. Also during 2024 the Finance section prepared Meath County Councils Three Year Capital Programme of €1.4bn, the Annual Revenue Budget for 2025 of €232m and the Annual Financial Statements for 2024 which returned a surplus for the year of €278,326 bringing the Councils cumulative reserves to €554,599.

Accounts Payable

Accounts Payable continued to process supplier payments in a timely and efficient manner with regular monitoring and reporting to ensure compliance with Prompt Payment legislation. System development and enhancements continued throughout 2024 to ensure compliance with all taxation legislation.

Procurement

The Procurement Unit continued to promote, guide, and support all procurement activities in Meath County Council. The unit regularly provides training and guidance to staff and supports strong corporate governance by conducting regular procurement and budgetary compliance checks.

Financial Overview

In the first quarter of 2024, the Finance Department prepared the Annual Financial Statements for 2023. This was followed by the release of the half-year accounts in July. The Local Property Tax reports were presented at the September Council meeting for members' consideration, and the Three-Year Capital Investment Programme was also prepared and submitted to the full council. Additionally, the Annual Budget for 2025 was developed and presented to the members for adoption in November.

Human Resources

The HR Department performs several strategic functions, including Payroll and Pensions, recruitment and Retention of Employees, learning and Development, and Time and Attendance management. It also liaises with the Trade Unions to manage Industrial Relations across the organisation.

The HR Department continued to facilitate the expansion of the Council's workforce during 2024, holding a significant number of recruitment competitions throughout the year. The Department strives to fill vacancies as quickly as possible and improves its onboarding processes to make them more agile. In 2024, the Council also commenced its Strategic Workforce Planning process to identify the skills and human resources required to deliver the priorities agreed in the Corporate Plan 2024-2029.

The HR Department also continues to implement and oversee a number of national agreements within the Council, particularly the National Public Sector Pay Agreement, the WRC Water Services Agreement, and the WRC Retained Fire Services Agreement. The transition of water services to Uisce Eireann and the expansion of the Fire Service continue to be managed by the HR Department.

Recruitment and Selection

In 2024, the HR Department organised a significant number of recruitment competitions – 67 competitions in total. The number of applications received was 1779, with a total of 675 candidates interviewed. These interviews were mainly in-person, with candidates being facilitated with online interviews, where required.

The HR Department continued a series of Rolling Recruitment initiatives, targeting particular skill sets, such as Engineering and Planning technical positions. These were open calls for candidates, where applications were processed, interviews held, and offers issued quickly and agilely. These initiatives were very successful in helping to fill a number of key vacancies across the organisation.

Summer Student Programme

As part of its objective of promoting the Council as an employer of choice and to attract the skillsets required to deliver our services, the HR Department managed a structured summer programme for third-level college students. The programme was targeted at particular skills in engineering, planning, architecture, and environmental management, with 8 students employed for 3 months across various departments.

This programme also helps develop collaborative connections with local colleges such as DKIT, and it is intended to expand in 2025.

Learning and Development

In terms of Learning and Development, the Department continued to build on its training programme, with an expansion in the learning supports and professional development course options for staff.

Work will continue to focus on developing the necessary competencies for each staff member's required role to enable individuals to perform to the best of their ability.

The Department continues to review and assist with training and up-skilling requirements throughout the organisation.



Coaching Programme

Meath County Council was one of seven local authorities that participated in a national pilot Coaching Programme for the local government sector. Twenty employees have now been trained to be coaches and are available to coach and support other staff.

Health and Wellbeing

The implementation of the Council's Wellbeing and Mental Health Policy was led by the HR Department, with the assistance of McNulty and Employee Financial Wellness Ltd, to support staff and build resilience within the workforce. The HR Department also managed the Health Screening Programme for staff, with over 500 employees availing of the programme in 2024.

To further support employees, the Council continues to provide an Employee Assistance Programme, through the services of Spectrum Life.

Information Systems

In 2024, the Information Systems department focused on Networks and Operations, Information Security, Geographical Information Systems, Business Applications, and Broadband & Digital. We engaged in a consultation process to guide our new Digital and ICT Strategy and procured an Online Citizen Services Portal to enhance digital transformation.

Key achievements included improving operational stability and information security while implementing business process enhancements. We partnered with Corporate Communications to make meath ie the most accessible Local Authority website in Ireland. A new system was introduced for the Healthy Age Friendly Homes programme, and we successfully launched various ICT systems for housing management and inspections.

We provided improved spatial analytics for departments like Transportation and Housing and developed online tools for Meath Fire and Rescue, including a Home Fire Safety Checklist. We ensured that all council employees had the necessary tools, regardless of their work location, and focused on modernising equipment and software.

The National Broadband Plan saw 10,587 homes and businesses connected in County Meath by the year's end, covering 52% of the Intervention Area. We also secured €299,000 in funding for a Community STEAM initiative in local schools and supported several educational projects in collaboration with OurKidsCode.

Our ongoing efforts in cyber security include vulnerability management, training, and policy updates. We also implemented measures such as a Privileged Access Management solution to enhance security for third-party access.

Key Achievements

2024 Local Elections

Significant support was provided by the Meath County Council Information Systems Department for the 2024 Local Elections.

This support included eCount management, online map provision, iReg assistance, provision of laptops, Wi-Fi and printers, support planning the event, support at the event, and support post event.

Draft Meath County Council - Digital and ICT Strategy 2030

In 2024 work began on the draft Meath County Council Digital and ICT Strategy, the goal of which is to harness the potential that technology offers to support Meath County Council and the work that we do. It is an ambitious strategy that follows 4 main themes: (1) Digital Services, (2) Digital Workforce, (3) Digital Systems and (4) Digital Communities.

Meath County Council ran a public consultation between Thursday the 14th of March 2024 and Monday the 27th of May 2024 querying where members of the public felt the priorities of digital

should be within the County. The Survey was circulated widely through the Public Participation Network (PPN), public representatives and community organisations and was promoted on social media. 186 responses were received. The strategy has also been developed and informed through consultation with our Chief Executive, Directors of Service, Elected Members, Senior Coordination Group (SCG), and the wider organisation (via several consultation workshops and an open surveys).

Our strategy references terms such as Digital Transformation, Business Process Improvement, Innovation and Continuous Process Improvement, but in essence means a process of re-viewing, rethinking, re-imagining, and re-designing how we deliver our services, digitally, to the public. A strategic objective will be to improve the customer journey when interacting with the Council and improving our backend processes. An interesting statistic is that the government aims, by 2030, to have 90% of applicable public services available and consumed online. This target is both commendable and challenging in equal measures and we will require collaboration, leadership and buy-in across all departments within Meath County Council to achieve same and enable real change.

The draft strategy will be brought to the Management Team in early 2025 for noting and approval.

Community Health, Social and Recreational Web Map Applications developed for Healthy Age Friendly Homes in regional areas

The Healthy Age Friendly Homes (HAFH) Community Mapping Resource was developed to enable the Local Coordinators across the Country to identify accurate and reliable HSE Health, HSE Social Care, Transport, Community and Recreational facilities location data within their respective coordinator areas. There are 6 separate web map applications to cover each of the HAFH regional areas.

To date there are 98 data layers (79,390 individual point locations) available within the Community Web Map Application with data sourced from the HSE, GeoDirectory, National Transport Authority and Sport Ireland.

Housing Response Maintenance Contractor Management back-office processes

A new Housing Response Maintenance module has been developed within our CRM providing full visibility of maintenance works related to our Housing Stock.

The maintenance process can now be monitored and managed from the initial call logged by our customers, through to allocation to the Clerk of Works, assignment to Contractors to remedy the issue, and resolution of same.

An additional Contractor portal has been created which allows them to manage their allocated jobs, update job status information, raise invoices and so forth.

Dashboards have also been created to give Contractors, Clerks of Work and Housing administration staff a full 360 view from job creation to final invoice.

The system will be deployed in 2025.

STATEMENT OF INTERNAL FINANCIAL CONTROL (SIFC)

Introduction

I, Kieran Kehoe, Chief Executive (CE) of Meath County Council, am responsible for the Annual Financial Statement (AFS), prepared by the Director of Finance, in accordance with the accounting code of practice issued by the Minister under section 107 of the Local Government Act, 2001 (as amended).

I certify that the unaudited financial statements of Meath County Council for the year ended 31 December 2024, are in agreement with the books of account and have been prepared in accordance with the accounting requirements of the Minister of Housing, Local Government and Heritage.

The AFS is subject to external audit, by an auditor of the Local Government Audit Service, whose purpose is to form an independent opinion of the accounts and state whether the annual financial statement presents fairly the financial position of the local authority and of its income and expenditure for the period in question, and whether the transactions of the audited body conform with the statutory or other authorisation under which they purport to have been carried out.

The Annual Financial Statement for 2023 has been audited. The figures reported herein for 2024 form part of the unaudited Annual Financial Statement for 2024. When the audit for 2024 is concluded, the audited accounts will be presented to Meath County Council's Audit Committee and the Elected Members of Meath County Council.

The AFS reports on the day-to-day activity of Meath County Council in the form of the Statement of Comprehensive Income & Expenditure, summarised by Division. The Statement of Financial Position outlines Meath County Council's overall financial position as of the 31st of December 2024.

The *Statement of Comprehensive Income* represents expenditure and income on the day-to-day running of the Meath County Council.

The year-on-year increase in income from 2023 to 2024 is €43,627,431.

Income from Grants & Subsidies increased by €28,254,281. The increase primarily related to funding from the Department of Enterprise, Trade, and Employment for Increased Cost of Business (ICOB) Grants and Power-Up Grants (PUG) paid to Meath businesses in 2024, as well as additional funding for the Roads and Housing work programmes.

Income from Goods & Services increased by €11,443,832, reflecting additional income from housing rents, contra income from circular economy, income for age friendly shared service, additional planning fees and fire certificate income and income for Crói Cónaithe.

The surplus €278,326 for the year 2024 arose as a result of robust financial and budgetary controls coupled with strong collection rates across all income headings. Also, where possible Meath County Council endeavours to maximise all available external funding sources.

The Statement of Financial Position (Balance Sheet) represents the closing financial position of the council at year-end together with comparative year figures as appropriate.

The statement includes assets and liabilities as follows:

- Assets both recently constructed/purchased and historical assets
- Work in progress and preliminary schemes- mainly roads and housing
- Long Term Debtors housing loans
- Current Assets- including Stock, Debtors, Cash at bank
- Current and long term liabilities- mortgage and non-mortgage loan borrowings
- Various Reserves/Balances

A *Statement of Funds Flow* was introduced as part of AFS 2011. While the guidance of International Accounting Standard 7 Statement of Cash Flows has been followed, the business of local authorities is substantially different to most private sector organisations and therefore some minor changes to the format have been agreed to ensure the data displayed is meaningful and useful within the local government sector.

System of Internal Financial Controls

As Chief Executive of Meath County Council, I acknowledge my responsibility for ensuring that an effective system of internal financial control is maintained and operated by Meath County Council. This responsibility is exercised in the context of the resources available to Meath County Council. Also, any system of internal financial control can provide only reasonable and not absolute assurance that assets are safeguarded, transactions authorised and properly recorded, and that material errors or irregularities are either prevented or would be detected in a timely manner. Maintaining the system of internal financial controls is a continuous process and the system and its effectiveness are kept under ongoing review.

Financial control environment

As Chief Executive of Meath County Council, I confirm that a financial control environment containing the following elements is in place:

- Financial responsibilities have been assigned at management level with corresponding accountability.
- Reporting arrangements have been established at all levels where responsibility for financial management has been assigned.
- Formal procedures have been established for reporting significant control failures and ensuring appropriate corrective action.
- There is an Audit Committee which as part of its work programme regularly reviews the internal financial control system.
- Procedures for all key business processes have been documented.
- There are systems in place to safeguard the assets.

Administrative Controls and Management Reporting

As Chief Executive of Meath County Council, I confirm that a framework of administrative procedures and regular management reporting is in place, including segregation of duties and a system of delegation and accountability and, in particular, that:

- procedures for key business processes have been documented
- there are systems aimed at ensuring the security of the ICT systems

- there are systems in place to safeguard the assets of the local authority and
- there are appropriate capital investment control guidelines and formal project management disciplines in operation.

Procurement compliance

Meath County Council ensures that there is an appropriate and ongoing focus on good practice in tendering and purchasing and that procedures are in place to ensure compliance with all relevant procurement guidelines.

Internal audit and Audit Committee

As Chief Executive, I can confirm that Meath County Council has an internal audit function with appropriately trained personnel, that operates in accordance with a written charter. Its work is informed by analysis of the financial risks to which Meath County Council is exposed, and its annual internal audit plans are based on this analysis. I am satisfied that there are procedures in place to ensure that the reports of the internal audit function are followed up.

I can confirm that Meath County Council has an effective audit committee which carries out an annual effectiveness review of its activities. I can also confirm that an Audit Committee is in place in accordance with the requirements of Section 122 of the Local Government Act 2001 (as amended).

The statutory functions of audit committees as set out in Sections 59 and 60 of the Local Government Reform Act 2014 are as follows:

- i. to review financial and budgetary reporting practices and procedures within the local authority that has established it;
- ii. to foster the development of best practice in the performance by the local authority of its internal audit function;
- iii. to review any audited financial statement, auditor's report or auditor's special report in relation to the local authority and assess any actions taken within that authority by its chief executive in response to such a statement or report and to report to that authority on its findings;
- iv. to assess and promote efficiency and value for money with respect to the local authority's performance of its functions; and
- v. to review systems that are operated by the local authority for the management of risks.

I recognise that the audit committee plays a crucial role in the governance framework of local authorities, particularly in the context of increased public sector accountability. They have an independent role in advising the Council on financial reporting processes, internal control,

risk management and audit matters as part of the systematic review of the control environment and governance procedures of the local authority.

I acknowledge the Audit Committee's role in the risk management process and in the continuing review of the control environment and governance procedures in Meath County Council.

Risk and control framework

Meath County Council has implemented a risk management system that identifies and reports key risks and the management actions being taken to address and, to the extent possible,

mitigate those risks.

A corporate risk register is in place which identifies the key risks and evaluates and grades them according to their significance. The register is reviewed and updated by the Management Team on a regular basis. There is also a risk register in place for each service

division and these are also reviewed and updated on a regular basis.

The outcome of these assessments is used to plan and allocate resources to ensure risks are managed to an acceptable level. The risk registers which detail the controls and actions needed to mitigate risks and responsibilities for the operation of controls are assigned to

specific staff.

As Chief Executive, I confirm that key risks and related controls have been identified and processes have been put in place to monitor the operation of those key controls and report

any identified deficiencies.

The Statement of Internal Financial Control will be included in the draft Annual Report submitted to Council members and thereafter included in the published Annual Report prepared and adopted by the Council by 30 June each year.

Governance Statement 2024

Purpose

The purpose of this governance statement is to provide relevant information on the governance structures and governance arrangements within the local authority including the Council, committees, senior management and related areas. It demonstrates our commitment to effective governance, recognises key legislative and good governance requirements and affirms the Council's compliance with the Local Government Code of Governance obligations.

Good Governance

Fundamentally, good governance in the local government sector and wider public sector is about delivering priorities, achieving objectives, behaving with integrity and acting in the public interest, in ways that are consistent with legal, regulatory and government policy obligations. Governance refers to the framework of rules, relationships, systems and processes by which the local authority is directed, controlled and held to account and whereby authority within an organisation is exercised and maintained. It encompasses authority, accountability, stewardship and leadership, direction and control.

Good Governance Principles

CORE PRINCIPLE 1 - Good governance means focusing on the purpose of the authority, on outcomes that deliver sustainable economic, community and wider societal benefits and on implementing a vision for the local authority.

CORE PRINCIPLE 2 - Good governance means promoting and demonstrating public service values through upholding high standards of conduct and behaviour.

CORE PRINCIPLE 3 - Good governance means members and officials working together to achieve a common purpose within a framework of clearly defined functions and roles.

CORE PRINCIPLE 4 - Good governance means developing the organisational capacity and the leadership capability and competencies of members and officials to operate effectively and fulfil the purpose of the organization.

CORE PRINCIPLE 5 - Good governance means taking well-informed and transparent decisions and managing risks and performance.

CORE PRINCIPLE 6 - Good governance means engaging openly and comprehensively with local people, citizens and other stakeholders to ensure robust public accountability.

CORE PRINCIPLE 7 - Good governance means actively contributing to the furtherance and achievement of the Sustainable Development Goals by delivering on the priorities and actions within the Climate Action Plan and the provisions of the Climate Act.

Our Commitment to Good Governance

As the Cathaoirleach and Chief Executive of the Council, and on behalf of the elected members, management and staff we confirm that;

- 1. We recognise the governance principles as the fundamental bedrock and philosophy on how we operate as a governing body and as an executive.
- 2. We recognise the Local Government Code of Governance as the centrepiece of the governance framework for local authorities.
- 3. The Statement of Internal Financial Control is submitted by the Chief Executive to the Elected Members and to the Audit Committee. The Audit Committee reviews the SIFC and provides an assurance on an annual basis to the Elected Members. Mechanisms are available to the Audit Committee to notify the Elected Members of any issues that arise outside of the normal annual reporting.
- 4. Compliance with legal and regulatory obligations are acknowledged and adhered to.
- 5. There is clarity of roles and responsibilities based on the reserved and executive functions and based on committee terms of reference.
- 6. Codes of Conduct and ethics declarations for members and employees are in place.
- 7. Procedures are in place for the making of protected disclosures in accordance with section 21(1) of the Protected Disclosures Act 2014 and confirmation that the annual report required under section 22(1) of the Act has been published.
- 8. The Council and Committees review their own performance on a periodic basis.
- 9. We have instituted appropriate governance oversight arrangements in respect of subsidiary, associated and related companies.

10. As part of our commitment to effective oversight and accountability, we have developed and continue to enhance our overall assurance framework utilising external and internal assurance sources to ensure good performance as part of our governance culture.

Appendix 9 – Public Sector Duty – 2024

In 2024, the Corporate Affairs & Governance Section reviewed the progress made to date regarding the Council's compliance with its statutory obligations in relation to the Public Sector Equality and Human Rights Duty. This review was instrumental in identifying the existing policies, plans, and actions in place to ensure that the organisation meets its legal and ethical responsibilities.

As part of this initiative, a detailed work programme for 2025 was developed to further advance the Council's commitment to these principles. Implementing this programme will involve systematically identifying areas where additional information or consultation is necessary to adequately assess and address key equality and human rights issues.


Moreover, the assessment of the actions needed to build the organisation's capacity to effectively implement the Duty will play a crucial role in this effort. This will include training staff, enhancing resources, and fostering an organisational culture that prioritises equality and inclusivity. The section plans to assess its policies, plans, and actions on an ongoing basis, ensuring that they are not only compliant but also proactive in promoting equality and human rights.

To achieve these goals, a phased approach will be adopted, aligning with the lifetime of the Corporate Plan. This approach will allow the organisation to set measurable objectives, monitor progress over time, and make necessary adjustments to strategies based on feedback and changing circumstances. By doing so, the organisation aims to create a more equitable environment that respects and promotes human rights for all individuals.

Appendix 10 – MD Allocations – 2024

In 2024, each Elected Member of Meath County Council was allocated €15,000 to allocate to activities/projects in their MD, at their discretion. As agreed at the General Municipal Allocation Budget Meetings in November 2023, if a member is not returned at the forthcoming Local Elections in 2024 and their MD Allocation fund is not fully allocated, the balance on their fund will return to their Municipal District. It will not roll over to newly elected members in the respective MD.

40 Elected Members had a total of €600,000 available to them in 2024, with €19,913 in funds deferred from 2023 available to 8 of those Members. Across the year, 694 applications were submitted, 689 of which were deemed to have fully complied with the agreed protocols and were processed for a total of €561,373.



672 Applications were processed for allocations to 469 unique groups/projects across the county. 145 groups received two or more allocations, with 20 groups receiving allocations from more than one Municipal District. One group received 12 allocations from all 6 Municipal Districts, totalling €10,150.
