WHEREAS the land described in the Schedule hereto and shown on the map attached hereto which said map has been marked

“Vesting Order Map relating to **Compulsory Purchase (No.1) Order, 2021- Corporate Services - Pathway Between L-3409-58 Ratholdren Road and L-34095-6 (known as Linky Lane) Abbeylands, Navan, Co. Meath**

Vesting Order Serial No. **MH/LND528/01/2025** and sealed with the seal of **MEATH COUNTY COUNCIL** (hereinafter referred to as " the local authority ") is land to which the **Pathway Between L-3409-58 Ratholdren Road and L-34095-6 (known as Linky Lane) Abbeylands, Navan, County Meath** relates, and the said scheme has become operative in so far as it relates to the said land:

AND WHEREAS the local authority have, at least six months prior to the date of this order, entered on and taken possession of the said land in accordance with the powers conferred upon them by section 80 of the Housing Act, 1966, as applied by section 10 of the Local Government (No. 2) Act, 1960 (as substituted by section 86 of the Housing Act, 1966):

AND WHEREAS

(a) the several interests in the said land have not been conveyed or transferred to the local authority,

(b) the local authority consider that it is urgently necessary, in connection with the purposes for which they have been authorised to acquire the land compulsorily, that the acquisition of the land should be completed, and

(c) the local authority has not been in receipt of particulars from any party claiming an interest in the property the subject of the above CPO such that it would be enabled to make a proper offer for such interest.

NOW THEREFORE the local authority in exercise of the powers conferred upon it by Section 81 of the Housing Act, 1966, as applied by section 10 of the Local Government (No. 2) Act, 1960, as substituted as aforesaid, hereby order that the said land shall, on the 27th day of August 2025 VEST in the local authority in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind.
